## APPENDIX to the Administrative Services Agreement Plan Notice Delivery Services

This Appendix to the Administrative Services Agreement between Client and ADP (the “Agreement”) will be effective as of the date specified in the ADP election form completed by Client to elect or change Plan Notice Delivery Services and supersedes any prior Appendix governing Plan Notice Delivery Services. Unless defined herein, capitalized terms shall have the same meaning as in the Agreement.

By electing Plan Notice Delivery Services, Client directs ADP to deliver notices and disclosures within the scope of the Plan Notice Delivery Services that are selected by the Client (collectively, the “Notices”) to Active Participants, Newly-Eligible Employees, and/or Terminated Participants and Beneficiaries, as selected by Client, as provided herein.

Plan Notice Delivery Services are generally designed to meet the timing requirements for Notices imposed by the Internal Revenue Service and Department of Labor. Nonetheless, there may be situations where the Notice delivery timeframe(s) under Plan Notice Delivery Services for a particular Notice or category of Notice recipients does not meet a requirement applicable to a particular plan or given the facts and circumstances of a particular notice recipient. Client acknowledges that it remains responsible for any use it may make of the Plan Notice Delivery Services in complying with laws and governmental regulations governing Plan administration, including but not limited to determining whether the timing of Notices delivered under the Plan Notice Delivery Services is appropriate for administration of its Plan. Client further acknowledges that the Administration Manual contains a detailed explanation of how Plan Notice Delivery Services operate for specific Notice and situations, including but not limited to situations in which Client remains responsible for Notice delivery.

### 1. Groups to Whom Notices May be Delivered

As used in this Appendix, the terms “Active Participants,” “Terminated Participants and Beneficiaries,” and “Newly-Eligible Employees” are defined as follows:

- A. “Active Participants” include the following as indicated on ADP’s recordkeeping system:
- (i) Currently eligible non-participating employees;
  - (ii) Currently-eligible participants
- B. “Terminated Participants and Beneficiaries” include the following as indicated on ADP’s recordkeeping system:

- C. “Newly-Eligible Employees” include the following as indicated on ADP’s recordkeeping system:
- (i) Employees with an initial Plan entry date on or after the date Plan Notice Delivery Services begin as defined in the Administration Manual that has been entered, affirmatively approved, or deemed approved by Employer as required by ADP’s systems and operational framework. If ADP calculates eligibility for a Employer without a requirement for affirmative Employer approval, any Employee listed on the ADP recordkeeping system as a Newly-Eligible Employee at the time ADP initiates Notice delivery for Newly-Eligible Employees will be treated as a Newly-Eligible Employee for purposes of Plan Notice Delivery Services. Notwithstanding the preceding, “Newly-Eligible Employees” will not include any employees for whom ADP will not perform Plan Notice Delivery Services as set forth in Section 4 of this Appendix.
  - (ii) Beneficiaries of deceased participants with an account balance; and
  - (iii) Alternate payees with an account balance under a “Qualified Domestic Relations Order” as provided for under section 414(p) of the Code.

### 2. When Plan Notice Delivery Services Will Begin

ADP will begin initiating delivery of Notices for the Plan as described in the Administration Manual. ADP will not be responsible for delivery of any specific Notice for which delivery as described in the Administration Manual would be scheduled to occur before ADP begins initiating Notices generally. **Client is specifically referred to Section 1 of this Appendix (including but not limited to the definition of “Newly-Eligible Employee”) and the Administration Manual’s explanation of timeframes for delivery of Notices for**



other provisions that may affect the manner in which Delivery Services begin for a given population or type of Notice).

### 3. Timeframes for Delivery of Notices

ADP will initiate delivery of specific Notices in accordance with the timeframes set forth in the Administration Manual. **Client expressly acknowledges that ADP's ability to deliver any Notice as provided below is subject to Client's performance of Notice-specific requirements specified in the Administration Manual.** ADP will not be responsible for timeliness of Notices sent late due to eligibility being approved or entered by Client less than 45 days before a Newly-Eligible Employee's Plan entry date or arising from a delay by Client in confirming whether an employee has satisfied the Plan's eligibility service requirements.

Notwithstanding the foregoing, Client acknowledges that as a convenience to Client, ADP will still initiate delivery of Notices to Newly-Eligible Employees in "immediate" or short term eligibility service situations (i.e., where a Newly-Eligible Employee's Plan entry date is less than 45 days after Client approval or entry). In this case, delivery initiation will occur as soon as administratively practicable, and Client will be responsible for delivering any Notice it determines should be delivered sooner.

### 4. Exclusions from Plan Notice Delivery Services

The following are in addition to any Notice-specific exclusions that may be set forth in the Administration Manual.

- A. Notwithstanding any agreement by ADP to deliver Notices to Newly-Eligible Employees, Client acknowledges that it will remain responsible for delivery of Notices to Newly-Eligible Employees for any "immediate" or short eligibility service situation that may arise under the Plan.
- B. ADP will not deliver Newly-Eligible Employee Notices to Employees who make a rollover contribution into the Plan before meeting the Plan's eligibility service requirements. Delivery of any such Notice will be the responsibility of Client.

### 5. Notice Form and Content

ADP will prepare all Notices in the form of ADP's standard templates for such Notices and based on the information regarding Client's Plan contained in ADP's recordkeeping system. ADP shall have no obligation to customize

ADP's templates for Notices. Notwithstanding ADP's agreement to provide Plan Notice Delivery Services, ADP will continue to provide a copy of all Notices to Client in advance, either by delivering a copy to Client or posting to the Plan Sponsor Website on an ongoing basis in accordance with ADP's standard operational processes so that Client may deliver said Notices to the extent Client remains responsible for such delivery under the terms of this Agreement or to the extent Client believes it necessary or appropriate to do so in a given circumstance in order to administer its Plan in accordance with applicable law. Unless Client notifies ADP in writing of an error in a Notice at least five (5) business days before ADP is scheduled to initiate delivery in accordance with this Appendix or the Administration Manual, Client will be deemed to have approved the content of said Notice.

### 6. Method of Delivery: Bad or Missing Addresses

- A. ADP will deliver Notices delivered in hard copy via first class mail at the address in ADP's records as supplied or verified by Client (or by a Terminated Participant) and using Client's mailing address in ADP's records as the return address for undeliverable mail. If an individual has been flagged in ADP's records as having a missing or bad address, ADP will not attempt to deliver Notices to that individual until a corrected address has been provided to ADP. If an individual has not yet been flagged in ADP's records as having a missing or bad address but is missing a required address element at the time of mailing, ADP will use Client's mailing address in ADP's records at the time ADP initiates delivery in lieu of the individual's address.

To the extent ADP makes electronic delivery available to deliver any Notices in connection with the Plan Notice Delivery Services, Client hereby consents to the electronic delivery of Notices and appoints ADP as its designee to receive from the Client or Participants (which includes terminated employees, beneficiaries and alternate payees), to collect, use and store Participants' electronic addresses (including e-mail addresses, mobile phone numbers capable of receiving written messages, and/or any alternate electronic addresses) received by ADP in connection with any ADP services provided to the Client, and for the purposes of delivering such Notices or such other Plan related documents as directed by the Employer. ADP shall electronically deliver such Notices to such electronic address, or deliver notification of the availability of such

Future Notices to such Participants shall be delivered to such Participants via USPS first class mail for such fee, unless and until the Client or Participant updates the e-mail or other electronic address or ADP is notified that the mailing address is not valid. The Client is responsible for keeping electronic addresses and mailing addresses of Participants current and for locating participants with bad electronic or mailing addresses. ADP shall not be responsible for informing Participants that their e-mail or other electronic addresses are invalid.

- B. Client shall be responsible for delivering any Notice delivered or returned to Client's address; locating participants, beneficiaries, and alternate payees with missing or bad addresses; and providing corrected addresses to ADP. Client will alert its employees who process incoming mail to identify Notices delivered or returned to Client's address so that such mail is forwarded to an appropriate employee of Client for this purpose. Notice Delivery Services in order to reflect the impact of the change.

- C. Except as provided in Section 7(D), Client may terminate Plan Notice Delivery Services on 30 days' notice and may do so without terminating recordkeeping and administrative Services under the Agreement.
