Note 1 - Description of the Plan

The following brief description of Dennen Steel Corp 401K Profit-Sharing Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement or Summary Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan which covers all eligible employees of Dennen Steel Corp (the Company). The Plan contains two main components: a 401(k) deferral component and a matching component. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participation Requirements

Each employee of the Company is eligible to become a participant in the 401(k) component of the Plan on the first day of the following next month upon completion of 90 days of service for the Company, as defined by the Plan, and attaining age 18. Each employee of the Company is also eligible for matching contributions of the Plan on the first day of the following next month upon completion of 90 days of service for the Company, as defined by the Plan, and attaining age 18.

Contributions

The 401(k) component allows eligible participants to defer part of their compensation through voluntary salary or wage reduction, and the Company may make a matching contribution as determined by the Company's management each year. Eligible employees receive a matching contribution of 50% up to 6% of the employee's eligible compensation.

Participants direct the investment of the contributions into various investment options offered by the Plan. Currently, the Plan offers various mutual funds as investment options for participants.

Allocations to Participant Accounts

Each participant's account is credited with the participant's and the Company's contributions as well as an allocation of investment earnings or losses and Plan expenses. Allocations to participants' accounts are proportional based on the value of account balances or equally among all participants, as specified in the Plan Agreement.

Vesting

Participant contributions, including rollover contributions, safe harbor match contributions, and all earnings thereon, are fully vested at all times. Employer discretionary match contributions are vested as follows:

Investment Options

Upon enrollment in the Plan, a participant may direct employee and employer contributions to any investment options offered by the Plan. If the participant fails to elect any investment options, contributions are placed in an investment fund as specified in the plan document.

Payment of Benefits

Participants, or their beneficiaries, may request payment of benefits at any time after their retirement, termination of employment, or death. The Plan allows for total or partial in-service withdrawal prior to retirement if the participant meets certain age or hardship withdrawal requirements. Such withdrawals are subject to approval by the plan administrator.

Notes Receivable from Participants

Participants may borrow from their accounts an amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans will not be made for less than \$1,000. With the exception of notes used to finance the purchase of a principal residence, note terms generally may not exceed five years. A participant may have no more than three loans outstanding at any time. The notes are secured by the vested balance in the participant's account and bear interest at 1% over the Prime Rate as published in the Wall Street Journal. The interest rates range between 4.25% and 9.50% on the notes outstanding as of December 31, 2024 and 2023. Principal and interest are repaid through payroll deductions over the term of the note and are credited to the participant's account.

Administrative Expenses

The Company pays all legal and accounting fees, custody, recordkeeping and fund management fees for the Plan. Administrative expenses also include certain participant-directed fees, such as distribution or loan origination fees, charged directly to participant accounts.

Note 2 - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared in accordance with the accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable - Participant Loans

Participant loans are classified as notes receivable from participants and are measured at the unpaid principal balance plus unpaid accrued interest. Defaulted loans, if any, are reclassified as distributions based upon the terms of the Plan Agreement. Interest income on participant loans is recognized on the Statement of Changes in Net Assets Available for Benefits as it is earned.

Payment of Benefits

Benefits payments are recorded when disbursed.

Income Taxes

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there currently are no audits in progress for any tax periods. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 3 - Fair Value Measurements

In accordance with ASC 820, *Fair Value Measurements and Disclosures*, the Plan utilizes a fair value hierarchy for valuation inputs that gives the highest priority to quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices in active markets for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets and liabilities in inactive markets, and other input that are observable or can be corroborated by observable market data.

Level 3 - Inputs to the valuation methodology are both significant to the fair value measurement and unobservable. Such inputs typically reflect management's estimates of assumptions that market participants would use in pricing the asset or liability, including certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.

The following valuation methodologies were used to measure the fair value of the Plan's investments:

Registered investment companies: Valued at quoted market prices in an exchange and active market, which represent the net asset value of shares held by the Plan.

Common collective trust (CCT): Units held in CCT are valued at net asset value (NAV) as reported by the trustee. The CCTs held by the Plan provide for daily redemptions by the Plan at reported NAV with no advance notice requirement. The Plan is permitted to redeem investment units at NAV on the measurement date. The investment strategy for CCTs, which are categorized as balanced/asset allocation funds, is to seek total return consisting of long-term growth of capital and current income, consistent with investment strategy of an investor who expects to retire in a specified year.

The Plan's valuation methods may result in a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Although Plan management believes the valuation methods are appropriate and consistent with the market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following tables set forth the Plan's investments, by level, within the fair value hierarchy. There have been no significant transfers into or out of Levels 1, 2 or 3.

Note 4 - Investments and Information Certified by the Plan's Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA as of December 31, 2024 and 2023 and for the years then ended. Accordingly, Reliance Trust Company, qualified institution, has certified that the following data for plan years ended December 31, 2024 and 2023, respectively, included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income as shown in the accompanying statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the Schedule of Assets (Held at End of Year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 5 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate or suspend contributions at any time, and to terminate the Plan subject to the provisions of ERISA. In the event of termination, each participant's account will become fully vested.

Note 6 - Income Tax Status

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated August 23, 2023, stating that the Plan is qualified under Section 401(a) of the IRC and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has not been amended since receiving this letter, the plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified.
