As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate to the best of their knowledge and belief.

### **Note 1 - Plan Description:**

The following description of the BSR 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions. All of the Plan assets are held by the Custodian and Trustee.

#### General

The Plan, effective as of January 1, 1997 and most recently amended and restated effective January 1, 2023, is a defined contribution plan that was established by Business for Social Responsibility (BSR or the Organization) to provide benefits to eligible employees, as defined in the Plan document. The Business for Social Responsibility 401(k) Investment Committee is responsible for oversight of the Plan. The Plan Administrator believes that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code and the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

#### Eligibility

All employees who have reached 21 years of age, except those covered by a collective bargaining agreement, nonresident aliens, leased employees and interns, are eligible to participate in the Plan, including receiving safe harbor contributions, at the beginning of the first day of the month after they have met the eligibility requirements.

Employees are eligible to begin receiving employer matching contributions as soon as they are enrolled in the Plan and begin deferring contributions.

#### Contributions

Effective January 1, 2012, eligible employees hired are automatically enrolled to have a salary deferral of 5% unless they affirmatively opt out or elect a different percentage. Participants hired before January 1, 2012 were not automatically enrolled and, upon enrollment, selected their salary deferral contributions of eligible pre-tax compensation. Employee deferrals may not exceed the amount allowable under current income tax regulations. Employees who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions.

Effective February 1, 2025, the Plan adopted an automatic escalation feature for deferral contributions. Under this provision, the initial automatic deferral percentage will increase by 1 percentage point annually, up to a maximum of 10%. These increases will take effect on the first day of the second Plan year following the Plan year in which the eligible employee's automatic deferrals were first implemented.

Participants may elect a different rate at any time and are allowed to make rollover contributions from other tax-qualified employer-sponsored retirement plans.

Effective January 1, 2018, BSR adopted to make safe harbor nonelective contributions to the account of each eligible participant in an amount equal to 3% of each participant's eligible annual compensation.

BSR may also make discretionary matching and profit-sharing contributions. No such contributions were made in 2024.

### Participant Accounts

Each participant's account is credited with the participant's contributions, the participant's qualified rollover contributions, allocation of the Organization's safe harbor contributions, discretionary matching and profit-sharing contributions, if any, and an allocation of Plan earnings or losses thereon. Participant accounts are charged with an allocation of Plan fees that are paid by the Plan. Allocations are based on participant account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Participants are immediately vested in their salary deferrals, rollovers of funds from other qualified retirement plans, safe harbor contributions and earnings thereon.

Effective September 1, 2015, participants are immediately vested in the Organization's discretionary matching contributions. Prior to September 1, 2015, the portion of the participants' accounts attributable to the Organization's discretionary matching contributions became 33% vested upon one period of service (as defined), 66% vested upon two periods of service and 100% vested upon three periods of service.

Effective March 1, 2017, participants are immediately vested in the Organization's discretionary nonelective contributions after the participant has met the eligibility requirement. Prior to March 1, 2017, the portion of the participants' accounts attributable to the Organization's discretionary nonelective contributions after the participant met the eligibility requirement became 20% vested after two years of credited service and 100% vested after three years of credited service as defined in the Plan.

### Participant Investment Options

Upon enrollment in the Plan, a participant must direct employee and employer contributions to any of the investments made available and determined by the Plan Administrator. Participants may change their investment options any time throughout the year via the third-party administrator's telephone system or Internet website.

### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the remaining balance in the participant's account. The Plan allows one loan per participant at any time. The term of the loan shall not exceed five years except in the case of a loan for the purpose of purchasing the principal residence of the participant, in which case the term for repayment may be over a period no longer than ten years. Repayment of loan principal and interest must be made either by check or through payroll deductions. The interest rate is set by the Plan Administrator at 1% over the prime rate and is fixed throughout the duration of loan. The interest rate on loans outstanding at year end is 9.50% per annum and maturity dates are through September 17, 2029.

### Payment of Benefits

A participant with a vested account of more than \$5,000 may, upon termination of employment, retirement, total disability, death, reaching age 59 1/2 or hardship, elect to leave their account balances in the Plan, roll their account balance over into another qualified plan or individual retirement account (IRA), or receive an amount equal to his or her vested account interest in a lump-sum distribution. In accordance with the SECURE 2.0 Act, the Plan increased the force-out threshold to \$7,000 effective January 1, 2024. A participant with a balance of \$7,000 or less may, upon termination, have the vested amount paid out in a lump-sum distribution. Eligible distributions between \$1,000 and \$7,000 are rolled over into a traditional IRA unless otherwise elected by the participant. The Plan allows for hardship withdrawals by employees from their deferral and rollover accounts. There were no participant requests to withdraw from the Plan as of December 31, 2024 or 2023 that had not been paid as of those dates.

### Forfeitures

Forfeitures are the nonvested portion of a participant's account that is lost upon termination of employment. Forfeitures are retained in the Plan, invested in the Vanguard Federal Money Market Fund, and shall be used to reduce future employer discretionary contributions. During the year ended December 31, 2024, there were no forfeitures, and the Company did not apply any forfeitures to reduce employer contributions. As of December 31, 2024 and 2023, the remaining balance of forfeited accounts totaled \$11 and \$10, respectively.

### Plan Trustee and Custodian

Reliance Trust Company is the Custodian and Trustee of the Plan. All of the Plan assets are held by the Custodian and Trustee.

On end of day December 31, 2024, Reliance Trust Company resigned as Trustee and Custodian, and the Plan Sponsor appointed ADP Retirement Trust Services, LLC as the Trustee and Custodian effective January 1, 2025.

### **Note 2 - Summary of Significant Accounting Policies:**

#### Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

#### Use of Estimates

The preparation of financial statements in accordance with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments of the Plan are held by the Trustee and invested based solely upon instructions received from participants.

The Plan's investments are reported at fair value as of the last day of the Plan year. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Business for Social Responsibility 401(k) Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes gains and losses on investments bought and sold as well as those held during the year.

The market volatility of equity-based investments may substantially impact the value of such investments at any given time. It is likely that the value of the Plan's investments, both in total and in individual participant accounts, has fluctuated since December 31, 2024.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation (depreciation) in fair value of investments.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are recorded as distributions based upon the terms of the Plan document.

### Contributions

Contributions from Plan participants, the safe harbor nonelective employer contributions, the discretionary matching and the profit-sharing contributions are recorded in the year in which the employee contributions are withheld from compensation.

### Benefits to Participants

Benefits are recorded when paid.

### Administrative Expenses

Certain expenses of maintaining the Plan, including investment advisory fees, are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Investment advisory fees are included in administrative expenses.

### Subsequent Events

The Plan Administrator evaluated subsequent events from December 31, 2024 through October 6, 2025, the date these financial statements were available to be issued, and has determined that, except as disclosed in Note 1, there were no material subsequent events that required recognition or additional disclosure in these financial statements.

### **Note 3 - Certified Information:**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate to the best of their knowledge and belief by Reliance Trust Company (the Trustee of the Plan).

### Note 4 - Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used as of December 31, 2024 and 2023.

*Mutual funds:* Valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

### **Note 5 - Related-Party Transactions and Party-in-Interest Transactions:**

Plan investments are managed by an investment company registered under the Investment Company Act of 1940, contracted with Reliance Trust. Any purchases and sales of these funds are open market transactions at fair value. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the party-in-interest prohibition.

Certain administrative functions are performed by officers or employees of the Organization. No such officer or employee receives compensation from the Plan.

### **Note 6 - Plan Termination:**

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, all participants immediately become 100% vested in their entire account.

### **Note 7 - Tax Status:**

Effective January 1, 2023, the Plan adopted a non-standardized defined contribution pre-approved plan from ADP, LLC. The ADP, LLC Plan has received a favorable opinion letter dated October 6, 2020 from the Internal Revenue Service as to the form of the plan being acceptable under Section 401 of the Internal Revenue Code. This opinion on the acceptability of the form of the plan is not a ruling or determination as to whether the plan qualified under Code section 401(a). The Plan has been amended since the ADP, LLC plan received the opinion letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax-exempt status and taken no uncertain tax positions that require recognition or disclosure in the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

### **Note 8 - Risks and Uncertainties:**

The Plan provides for various investment options in any combination of mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits.

Calvert Bond Fund Class R6 represented 15% and 16% of net assets available for benefits as of December 31, 2024 and 2023, respectively.

Parnassus Core Equity Instl represented 12% of net assets available for benefits as of December 31, 2024 and 2023.

Vanguard FTSE Social Index Admiral represented 14% of net assets available for benefits as of December 31, 2024 and 2023.
