**NOTE 1 – PLAN DESCRIPTION**

The following description of PMA Financial Network, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document and the Summary Plan Description for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by PMA Financial Network, LLC (the Company and Plan Sponsor) covering all employees who are age 21 or older. The assets of the Plan are managed by Reliance Trust Company (the Trustee) and administered by ADP, LLC (the Recordkeeper). Reliance Trust Company, as the trustee for the Plan, holds the Plan's investment assets and is responsible for the investment of the plan assets. The 401(k) Committee is responsible for the oversight of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions: Each year, participants may contribute up to 90 percent of pre-tax or post tax (Roth) annual compensation up to the maximum deferral limit, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan and into a self-directed brokerage account, if they choose. The Company may make matching contributions equal to a discretionary percentage during the plan year. For 2024, the matching contribution is six percent of participants compensation. The Company may also make a discretionary profit-sharing contribution to participants employed on December 31 and who have completed 1,000 hours of service. The Company did not make any discretionary profit-sharing contribution for 2024. Contributions are subject to certain limitations.

Participant Accounts: Each participant's account is credited with that participant's contributions and allocations of a) the Company's discretionary matching contribution, if any, b) the Company's discretionary profit-sharing contribution, if any, c) plan earnings, and d) charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their contributions, Company discretionary matching contributions, and rollover contributions plus actual earnings thereon. The vested percentage of a participant's account attributable to the Company's discretionary profit sharing contribution is based on years of services and is determined under the following schedule.

A participant also becomes fully vested upon death, if currently employed by the Plan Sponsor, retirement, or disability. To earn a year of service, participants must be credited with at least 1,000 hours of service during the plan year.

**NOTE 1 – PLAN DESCRIPTION** (Continued)

Payments of Benefits and Certain Withdrawals: Upon death, termination of service, disability, attainment of age 59 ½, retirement or due to other reasons, as defined in the Plan, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his/her account, or annual installments over a period of not more than the assumed life expectancy.

In-service hardship withdrawals of participant and Company contributions are allowed with certain restrictions.

**NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting: The financial statements are prepared on the accrual basis of accounting.

Accounting Policies: The financial statements of the Plan have been prepared in conformity with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates: The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Committee determines the Plan's valuation policies utilizing information provided by the investment advisers and the Trustee of the Plan. See Note 4 for a detailed discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation(depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: The Plan pays certain administrative expenses as provided in the plan document. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. Certain other administrative expenses are paid by the Company on behalf of the Plan, without reimbursement.

**NOTE 3 – CERTIFIED INVESTMENTS**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

#### NOTE 4 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB guidance are described as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to their fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured on a recurring basis at fair value.

Registered Investment Companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded.

Collective Trusts: Valued at the Net Asset Value (NAV) of units of the collective trust. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Self-Directed Brokerage Accounts: These accounts include investments primarily in common stocks and mutual funds that are valued at the quoted market prices reported in active markets in which the individual securities are traded.

**NOTE 5 – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Some administrative expenses of the Plan are paid directly by the Company.

**NOTE 6 – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their Company discretionary profit-sharing contributions, if any.

**NOTE 7 – TAX STATUS**

The Internal Revenue Service issued an opinion letter dated October 6, 2020, indicating that the prototype adopted by the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended from the original prototype document, Plan management believes that the Plan is currently being operated in accordance with the Internal Revenue Code.

**NOTE 7 – TAX STATUS** (Continued)

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination. Plan management has analyzed the tax positions taken by the Plan and has concluded that through December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audit for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 8 – RISKS AND UNCERTAINTIES**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit risks as well as risk associated with global events. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
