Note 1: Description of Plan

The following description of Prospect Waterproofing Company 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established by Prospect Waterproofing Company (the Company) and affiliates in January 1967. The Plan, as restated effective May 1, 2021, operates under a Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Ascensus Trust Company (Ascensus). The Plan generally covers all employees who have completed at least 1,000 hours of service and have attained the age of 21. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Plan currently has three entities that have common ownership and participate in the plan: Prospect Waterproofing Company (the Company); Division 7, Inc.; and Prospect Solar, LLC.

Participant Contributions: Each year, participants may contribute up to the limits, on a pre-tax basis, as defined in the Plan agreement and allowed by the Internal Revenue Code. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). Participants direct the investment of their contributions, including employer contributions, into various investment options offered by the Plan. Participants have their deferral contributions invested in a designated balanced fund until changed by the participant.

Employer Contributions: The Company annually determines different contribution allocation levels for different groups of participants if such groupings and allocation levels satisfy the requirements of Internal Revenue Code. The Company may make the following types of contributions: matching, discretionary profit-sharing, and/or prevailing wage contributions as determined by various contracts. Discretionary profit-sharing contributions are allocable to those participants who have completed at least 1,000 hours of service during the Plan year and are either employed on the last day of the Plan year, or have terminated employment during the Plan year as a result of retirement, death, or disability. For the years ended December 31, 2024 and 2023, the Company's profit-sharing contribution was the lesser of limits established by the Internal Revenue Service or 3.0% of compensation to owners and officers and 1.0% to all other eligible employees. In addition, during the Plan years ended December 31, 2024 and 2023, the Company made prevailing wage contributions as determined on a contract-by-contract basis. The Company did not make any matching contributions for the years ended December 31, 2024 and 2023.

Participant Accounts: Each participant's account is credited with the participant's contributions, allocation of the Company contributions, Plan earnings and losses, and charged with an allocation of administrative expenses. Allocations are based on compensation, participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. All Plan assets as of December 31, 2024 and 2023 have been allocated to participants' accounts except for employer contributions receivable and forfeitures, if any.

Vesting: Participants are vested immediately in their contributions, the Company's prevailing wage contributions, and actual earnings thereon. Vesting in the Company's discretionary contribution portion of their accounts is based on years of continuous services. A participant becomes vested in the Company discretionary contributions and earnings based upon the following vesting schedule:

In the event of death, disability, or retirement, a participant's interest is immediately fully vested in the employer contributions and related earnings under terms set forth in the Plan agreement.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Participants can have no more than two loans outstanding from the Plan. The loan terms are five years or less and the interest rate on any loan is the Prime Rate published on the date of the loan application plus 1%. Weekly payroll deductions include ratable payments of principal and interest.

Payment of Benefits: Upon termination of service due to death, disability or retirement, a participant may elect to receive some or all the amount equal to the value of the participant's vested interest in his or her account. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan permits participants to take distributions while remaining employed with the Company. For in-service distributions, a participant may request distributions upon reaching age 65. Minimum distributions from a participant's account are generally required after the participant has reached the age of 73. Distributions in this manner will have the same options as distributions based upon termination of service due to death, disability, or retirement. Participants may also take hardship distributions while remaining employed with the Company, provided they satisfy certain conditions as defined in the Plan document.

Forfeitures: Forfeitures from non-vested participant accounts are used to reduce future employer contributions or pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$-0- and \$4,047, respectively. During the years ended December 31, 2024 and 2023, approximately \$28,000 and \$17,000, respectively, from the forfeitures account was used to pay Plan expenses and reduce the Company's contributions.

Note 2: Summary of Significant Accounting Policies

Following is a description of the significant accounting and reporting policies of the Plan:

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates: The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Investment Valuation and Income Recognition: The Plan trustee is responsible for oversight of the Plan, determining appropriateness of the Plan's investment offerings and monitoring investment performance. Investments are reported at fair value (except for the fully benefit-responsive trust, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Contributions: Contributions from participants are recorded in the period the employer withholds payroll deductions from Plan participants. Employer matching contributions, if any, and discretionary contributions are recorded in the period as determined under the terms of the Plan, and approved by the Company's management and collectability is reasonable assured.

The Plan has not established an allowance for credit losses at December 31, 2024 and 2023. Expected collection losses are determined from a review of historical collection experience, existing economic conditions and reasonable and supportable forecasts of future events affecting the Plan Sponsor. The Plan's fiduciaries believe the employer contributions receivable will be fully collected based on the ability of the Plan Sponsor to pay amounts when due.

Benefits Paid to Participants: Benefits are recorded when paid.

Subsequent Events: In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through October 8 2025, the date the financial statements were available to be issued. During the period from January 1, 2025 to October 8, 2025, the Plan did not have any material recognizable subsequent events.

Note 3: Fair Value Measurements

Generally accepted accounting principles (GAAP), establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). Below describes the three levels of the fair value:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
- Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for Plan assets measured at fair value:

Mutual Funds: The fair value of mutual funds is based on the closing price at year-end as reported by the fund. Mutual funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

There has been no change in the methodology used to value investments at December 31, 2024 and 2023.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4: Information Certified by the Plan Trustee

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the Plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to information certified as complete and accurate by Ascensus Trust Company (Ascensus), the trustee of the Plan except to compare such information to information included in the Plan's financial statements and supplemental schedules.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule including investments in mutual funds, collective investment trust, interest-bearing cash and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was derived from information certified as complete and accurate by Ascensus.

Note 5: Collective Investment Trust

The Morley Stable Value Fund (the "Stable Value Fund"), a collective investment trust, meets all the standards currently required to be considered fully benefit-responsive and therefore is reported at contract value. The Stable Value Fund is available only to participants in a qualified retirement savings plan and is designed to protect a participant's capital investment. Fund investments include various investment contracts with insurance companies or other institutions, with underlying investments in bonds, guaranteed investment contracts ("GICs"), and other investment products (synthetic GICs and collective investment trusts) with similar characteristics. The Stable Value Fund holds investments in fully benefit-responsive investment contracts that provide that the Plan can make withdrawals at contract value for benefit-responsive requirements.

The Stable Value Fund does not have a set interest rate due to investments in contracts with varying rates and maturities. Variables impacting future crediting rates include current yield and duration of the assets backing the contracts, existing differences between the market values of assets backing the contracts and the contract values of the contracts.

Note 5: Collective Investment Trust (Continued)

Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment in the Stable Value Fund at contract value. Certain events may limit the ability of the Plan to transact at contract value with the issuer. The plan administrator does not believe that the occurrence of any such event is probable.

Note 6: Notes Receivable from Participants

As of December 31, 2024 and 2023, 151 and 147 participants were indebted to the Plan in the total amount of \$1,315,048 and \$1,121,714, respectively, as the result of loans made to them by the Plan. The loans are evidenced by promissory notes bearing interest at rates varying from 4.25% to 9.50% per annum, and are payable in installments, the latest of which is due in December 2029. The notes are fully secured by the participants' vested account balances.

Note 7: Parties-in-Interest

The Plan offers various investment options to participants which are managed by The Vanguard Group, Inc. on behalf of Ascensus, the trustee of the Plan; therefore, these transactions qualify as party-in-interest transactions. The Plan deducted investment management services fees directly from participants' accounts of \$37,648 and \$34,684 during the years ended December 31, 2024 and 2023, respectively. In addition, the Plan and plan participants paid administrative expenses to Ascensus totaling \$73,383 and \$69,400 for the years ended December 31, 2024 and 2023, respectively. Certain officers of the Plan sponsor are administrators of the Plan, acting as fiduciaries, and are also participants in the Plan.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their employer contribution accounts.

Note 9: Income Tax Status

The Internal Revenue Service (IRS) has ruled in a letter dated June 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA and related trust established by Ascensus LLC qualifies under applicable sections of the Internal Revenue Code (IRC). The plan administrator and the Plan's tax counsel believe that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified and the related trust is tax-exempt. The Plan's federal tax returns are subject to examination by the Internal Revenue Service generally for a period of three years after the returns are filed.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator does not believe that the Plan has any uncertain tax positions. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for any tax periods in progress.

Note 10: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11: Non-Exempt Prohibited Transactions

During 2023, the Company failed to remit to the Plan's trustee certain employee contributions and loan repayments totaling \$13,629 within the period prescribed by the Department of Labor (DOL) regulations. The Company is required to make contributions to the affected participants' accounts to compensate those participants for potential lost income due to the delays. As of December 31, 2024, the Company fully resolved the matter as required by the DOL through the Voluntary Fiduciary Correction Program (VFCP).

Note 12: Reconciliation of Financial Statements to Form 5500
