Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the QuEST Global 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). - Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the QuEST Global 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.



NOTE 1 DESCRIPTION OF PLAN

The following description of the QuEST Global 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established to provide retirement benefits for eligible employees of QuEST Global Services N.A., Inc., SFO Technologies Corporation, Quest Defense Systems & Solutions, Dakota Moon Enterprises, LLC, QuEST Global Engineering Services, EXB Solutions, Inc., and Intelizign LLC (collectively, the Company) who have reached the age of 21 and have two months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments

The Plan was amended effective January 1, 2024 to add EXB Solutions, Inc. and Intelizign LLC as participating employers in the Plan and to allow for the merger of the EXB Solutions, Inc. 401(k) Profit Sharing Plan, see below. The Plan was also amended effective January 1, 2024 to recognize prior service credit for employees of these employers.

Plan Merger and Transfer

As discussed above, the assets of the EXB Solutions, Inc. 401(k) Profit Sharing Plan were transferred into the Plan in January 2024. In connection with the merger, all active participants who were employees of EXB Solutions, Inc. as of December 31, 2023 were 100% vested in all current and future employer contributions, and terminated employees with a balance as of December 31, 2023 follow a three-year graded schedule. The transfer was finalized on January 2, 2024 at which time assets totaling \$16,752,672 were merged into the Plan.

Contributions

Participants may contribute between 1% and 90% of compensation, as defined in the Plan. Participants may designate their contributions as either pre-tax or Roth contributions. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect otherwise. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation, and their contributions are invested in a designated fund until changed by the participant. For all automatically enrolled participants hired after January 1, 2021, there is an auto-increase provision whereby the default pre-tax contribution rate will increase by 1% each year that the participant is employed, up to a maximum rate of 15%.

The Company may make a matching contribution at the discretion of the Board of Directors. The discretionary matching contribution was equal to 50% of the first 5% of the participant's eligible compensation for the year ended December 31, 2024. The Company may also make a profit-sharing contribution at the discretion of the Board of Directors. The Company did not make a discretionary profit-sharing contribution for the year ended December 31, 2024.

Contributions (Continued)

All contributions are subject to certain limitations imposed by the Plan and the Internal Revenue Code (the Code).

Participant Accounts

Each participant's account is credited with the participant's contributions and Company contributions, and allocations of plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations of Company contributions, investment income (loss) and administrative expenses are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested accounts.

Investment Options

Participants may direct their contributions into any of the funds offered by the Plan, which are held at Reliance Trust Company (Reliance). These funds include a variety of investment options with various objectives and degrees of financial risk.

Vesting

Participants are immediately vested in their deferral and rollover contributions, including the earnings on those amounts. Vesting in the Company contributions portion of their accounts is based on years of continuous service. Participants are fully vested in employer contributions upon the completion of three years of service. Certain employees that were part of previous transfers into the Plan follow legacy vesting schedules, as defined in the plan document. Participants are also fully vested upon reaching normal retirement age, death or total disability.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess, if any, of the highest outstanding loan balance of loans from the Plan during the one-year period prior to the date of the loan over the current outstanding loan balance, or one-half of the participant's vested account balance. Loan terms range from one to five years, except for loans to purchase a primary residence, which may be offered over a longer term. The loans are secured by the balance in the participants' accounts and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. The notes currently bear interest at 4.25% to 9.5%. Participants may have up to two loans outstanding at any time. Generally, principal and interest are paid ratably through payroll deductions.

Payment of Benefits

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or reaching normal retirement age, the participant may receive the value of the vested interest in his or her account in various forms of payment, as described in the Plan document.

Payment of Benefits (Continued)

The Plan also allows for in-service distributions if a participant reaches age 59½ and hardship distributions subject to Plan provisions.

The Plan also provides for automatic cash-out and/or rollover distributions into an individual retirement account for terminated participants whose balance does not exceed certain limits as prescribed by the Plan document and IRC.

Forfeitures

Forfeitures of discretionary matching contributions are used to reduce the Company's future contributions or to pay Plan expenses. Forfeited nonvested discretionary accounts totaled \$124,804 and \$157,780 at December 31, 2024 and 2023, respectively. For the year ended December 31, 2024, \$597,092 of forfeitures were used to reduce discretionary Company contributions and \$17,325 was used to pay eligible Plan expenses.

Revenue Sharing

The Plan holds assets in a plan expense account as a result of a revenue sharing arrangement with Reliance. Funds in the account are used to pay qualified plan expenses. For the year ended December 31, 2024, the Plan did not receive or use any funds. The plan expense account had a balance of \$26,644 and \$26,042 as of December 31, 2024 and 2023, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on the trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits to participants are recorded when paid.

Plan Expenses

Certain expenses of maintaining the Plan are paid directly by the Company. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

Risks and Uncertainties

The Plan provides for various investment options. These investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and those changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events were evaluated through October 2, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION BY THE INVESTMENT TRUSTEE

Information presented in the accompanying statements and supplemental schedule as of December 31, 2024 and 2023, and for the year ended December 31, 2024 for investments, notes receivable from participants, investment income and interest income on notes receivable from participants was derived from information certified to be complete and accurate by Reliance Trust Company, the trustee, as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds: Mutual funds are valued at the quoted price of shares held by the Plan at year-end.

Common and Collective Trusts: Certain common and collective trust funds are stated at their net asset values as reported by the investment manager of the fund based on the fair value of the underlying assets and liabilities at the measurement date. Other common and collective trust funds are composed primarily of fully benefit-responsive investment contracts and are valued at the net asset value of the units held of the collective trust. For all common and collective trust funds, the net asset value is used as a practical expedient to estimate fair value.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) Certain investments that are measured using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Investments in all common and collective trusts provide for daily liquidity and the majority of these funds have no redemption features or other restrictions. Certain funds have a 12-month redemption feature on a plan level but there are no restrictions on a participant level.

There were no transfers between levels of investments during the year ended December 31, 2024.

NOTE 5 PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest include recordkeepers and professional service firms who provide services to the Plan. Certain employees of the Company who participate in the Plan perform administrative services to the Plan at no cost to the Plan. Notes receivable from participants are also party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 6 INCOME TAX STATUS

The Plan has adopted a preapproved plan document that received a favorable opinion letter from the Internal Revenue Service (IRS) that it was in compliance with the applicable requirements of the Code. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, the plan administrator believes the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become fully vested in their accounts.

NOTE 8 SUBSEQUENT EVENTS

Effective January 1, 2025, the Company established a new 401(k) Plan, the Quest Global 401(k) Profit Sharing Plan, to segregate the Quest Global participants from the Quest Defense participants for regulatory purposes. Employees of Quest Global Services, N.A., Inc., Quest Global Engineering Services, Dakota Moon Enterprises, LLC, Intelizign LLC, and SFO Technologies Corporation became eligible to participate in this new plan. The account balances of these participants, totaling approximately \$57,460,000, were transferred to the new plan on April 21, 2025 and the account balances of employees of Quest Defense Systems & Solutions and EXB Solutions, Inc. remained in the Plan. In connection with this transaction, the Plan name was changed to 401K QDSS effective May 1, 2025.
