## INDEPENDENT AUDITOR'S REPORT

**Note 1 - Description of Plan**

The following description of the M & D Supply, Inc. (Company) 401(k) Profit Sharing Plan and Trust (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

*General:* The Plan is a defined contribution plan, covering all employees of M & D Supply, Inc. who have 2 months of service and are a minimum age of 21. Employees of a collective bargaining unit and non-resident aliens are not covered. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

*Contributions:* Each year, per Internal Revenue Code regulations, participants may contribute a certain percentage of their compensation to the Plan, up to a fixed dollar amount. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan sponsor may elect to make a discretionary match or profit-sharing contribution. For the year ended December 31, 2024, the employer contributed 50 percent of each participant's contribution up to six percent.

*Participant Accounts:* Each participant's account is credited with the participant's contributions and Company matching contributions, as well as Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*Vesting:* Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion plus the actual earnings thereon commences at two years of continuous service at 20 percent per annum until reaching 100 percent vesting. Participants become fully vested upon reaching their normal retirement age (59½), upon death, or upon becoming disabled while employed.

*Notes Receivable from Participants:* Participants may borrow from their accounts up to a maximum of \$50,000 or 50 percent of their vested balance, whichever is less. The loans are secured by the participant's account balance and bear interest at prime plus two percent.

*Payment of Benefits:* Upon termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the entire value of his or her vested interest in the account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

*Forfeitures:* The non-vested benefits that are left behind by participants who have not been employed long enough to accrue 100 percent of employer contributions are forfeitures. Forfeitures occur after a participant has been paid his or her vested accrued benefit or after five consecutive one-year breaks in service. A participant who terminates with a vested account balance of zero will be deemed to have a distribution and all employer contributions will be forfeited. Forfeitures can be used by the employer to pay plan expenses, restore any forfeited amounts, and reduce or reallocate company contributions. In 2024 company contributions were reduced by \$11,461 from forfeited nonvested accounts. At December 31, 2024 and 2023, the forfeitures balance was \$10 and \$15 respectively.

**Note 2 - Summary of Significant Accounting Policies**

*Basis of Accounting:* The accompanying financial statements of the Plan have been prepared on an accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

**Note 2 - Summary of Significant Accounting Policies** (continued)

*Use of Estimates:* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

*Investment Valuation and Income Recognition:* The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date.

*Notes Receivable from Participants:* Loans to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. All loans are deemed collectable by management; therefore, no allowance has been recorded. If a participant ceases to make loan repayments, the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

*Payments of Benefits:* Benefits are recorded when paid.

*Administrative Expenses:* Certain of the Plan's administrative expenses, such as the audit fee and the third-party administrator/recordkeeping fee, are paid directly by the Company. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

*Reclassification:* Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 presentation.

**Note 3 – Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Note 3 – Fair Value Measurements** (continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

*Cash and cash equivalents:* The fair value of noninterest bearing cash and cash equivalents is estimated to approximate the carrying amounts.

*Mutual funds and money market accounts:* Valued at the daily closing price as reported by the fund. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market accounts held by the Plan are deemed to be actively traded.

**Note 4 – Certified Investment Information (Unaudited)**

Management has elected to have the audits of the Plan performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company has certified that the following investment information is complete and accurate:

- Fair value of investments and the carrying amount of notes receivable from participants as reflected in the Statement of Net Assets Available for Benefits as of December 31, 2024 and 2023
- Investment income and interest income on notes receivable from participants as reflected in the Statement of Changes in Net Assets Available for Benefits for the Year Ended December 31, 2024.
- Investment information as reflected in Note 3 to these financial statements.
- Investment information reflected in the Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024.

As permitted by ERISA Section 103(a)(3)(C), the audit need not extend to any statements or information related to the certified investment information.

**Note 5 - Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

**Note 6 – Plan Termination**

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

**Note 7 – Distributions Payable**

At December 31, 2024 and 2023, net assets available for plan benefits included \$174,912 and \$154,815, respectively, for participants who have terminated employment from the Plan prior to the end of the plan year.

**Note 8 – Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities; it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9 – Significant Concentrations of Credit Risk**

The Plan maintains cash balances in a money market fund which are not covered by the Federal Deposit Insurance Corporation. The amount of uninsured cash balances at December 31, 2024 and 2023 was \$600,918 and \$343,224, respectively.

**Note 11 – Plan Restatement**

This restatement was referred to as Cycle 3. Cycle 3 restatement was required in order for the plan to remain compliant and continue maintaining a pre-approved plan document.

**Note 12 – Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2025, the date which the financial statements were available to be issued.
