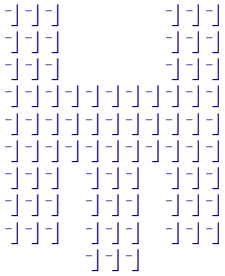

## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Addison Reserve Master Property Owners Association Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Addison Reserve Master Property Owners Association Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

1. **Description of Plan**

The following description of the Addison Reserve Master Property Owners Association Inc. 401(k) Plan (the "Plan"), is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan offered by the Plan Sponsor, Addison Reserve Country Club, Inc., which on December 31, 2018, merged with Addison Reserve Master Property Owners Association, Inc. (the "Association"). The Plan covers all employees of the Association, except employees of a collective bargaining unit, who have at least one year of service to the Association and have attained the age of 21. One year of service is accomplished in the first year an employee completes 1,000 hours of service during 12 consecutive months of employment. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2005, and most recently restated on July 25, 2022, as required by the Internal Revenue Service's (IRS) restatement cycle.
- b) *Plan Administration* – Automatic Data Processing, Inc. (ADP) is the administrator of the Plan. Reliance Trust Company (Reliance) is the trustee, and held custody and serviced the Plan's investment assets as of December 31, 2024 and 2023. Daher Capital Group is the investment manager, which assists with the selection of investment options. Furthermore, ADP is the payroll processor for the Association.
- c) *Contributions* – Each year, participants may contribute up to 80% of pretax annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. Under a Safe Harbor arrangement pursuant to IRS regulations, the Association matches the participant's contribution up to 4% of the participant's compensation. Participants may change their deferral percentage or cease their individual contributions at any time, and will be effective as of the next available payroll.
- d) *Participant Accounts* – Each participant's account is credited with participant's contributions, plan earnings, employer's matching contribution, and charged with an allocation of administrative expenses. Allocations are based on participant's account balances, as defined.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions and rollovers, plus actual earnings thereon. Participants are also immediately vested in the employer's matching contribution portion of their accounts plus actual earnings thereon pursuant to the Safe Harbor provisions of the Plan. Upon death, disability or reaching age of 65, discretionary matching and non-elective contributions become 100% vested.
- f) *Administrative Expenses* – Individual participants pay for loan and distribution fees, and investment management expenses. The Plan sponsor pays for other costs of plan administration.

---

1. **Description of Plan, continued**

- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct the investment of their contributions into various investment options offered in ADP’s portfolio of investments. Participants may change their investment option via phone or internet access.
- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from a period not to exceed five years or up to thirty years for the purchase of a primary residence. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with the local prevailing rates as determined by the loan administrator at the time the loan was taken. Interest rates on participant loans as of December 31, 2024 and 2023 ranged from 5.25% to 10.25%. Principal and interest are paid ratably through bi-weekly payroll deductions. Loans to participants are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants’ investments accounts, therefore, no allowance for uncollectible loans is deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500 and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, termination of service, or attainment of age 59 ½, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account or annual installments. Participants may also withdraw any or part of their rollover contributions account at any time and at any age. In the event of financial hardship, the participant may withdraw their own elective deferrals as well as vested employer matching contributions.
- j) *Forfeitures* – Under the Safe Harbor provisions of this plan, all contributions are 100% vested. Therefore, there are no forfeitures. Upon termination of employment, participants are entitled to their entire account balance.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

---

**2. Summary of Significant Accounting Policies, continued**

- c) *Valuation of Investments and Income Recognition* – The Plan’s investments are valued at fair value as determined from quoted market prices (i.e., net asset value – NAV), if available, of a national securities exchange on the last business day of the year. Investment options that do not have readily available market quotations are valued according to quotations from the trustee. Purchase and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- d) *Payment of Benefits* – Benefits are recorded when paid.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Certain Plan investments are shares of mutual funds and common and collective trust funds managed by the trustee. Change in the trustee’s management may affect operating results of the funds adversely. Additionally, the financial position of the Plan Sponsor, Addison Reserve Master Property Owners Association, Inc., may have a significant impact on the Plan. Specifically, the ability of the Plan Sponsor to continue to make contributions under the program and/or the stability of the Plan Sponsor’s operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service, Employee Retirement Income Security Act of 1974, and/or Department of Labor (DOL).

**3. Fair Value Measurements**

Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

**3. Fair Value Measurements, continued**

- If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions list the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024.

- Mutual funds* – Valued at quoted market prices of a national security exchange on the last business day of the year, of units held by the Plan at year end.
- Common and collective trusts* – Valued at the net asset value (NAV), as quoted by the investment manager, of shares held by the plan at year end. In this instance the NAV is used as a practical expedient to estimate fair value.

**5. Tax Status**

The Plan is utilizing a Non-Standardized Defined Contribution Pre-Approved Plan (Pre-Approved Plan) document provided by its Plan administrator, ADP. The Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Pre-Approved Plan received an opinion letter from the Internal Revenue Service dated October 6, 2020. Furthermore, the Plan's sponsor and administrator believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and therefore believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**6. Plan Termination**

Although it has not expressed an intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

**7. Subsequent Events**

Management has evaluated subsequent events through September 30, 2025, the date on which the financial statements were available to be issued, and determined there were no such events to disclose in these financial statements.
