**NOTE A - DESCRIPTION OF PLAN**

The following description of the Global Tax Management, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

**General**

The Plan is a defined contribution plan, which commenced January 1, 2001. All full-time employees of Global Tax Management, Inc. 401(k) (the "Company") who are age 21 or older are eligible to participate for purposes of salary deferrals and employer safe harbor contributions. All full-time employees of the Company who have completed one year of service and who are age 21 or older are eligible to participate for purposes of matching and profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, participants may contribute to the Plan up to 90% of their gross compensation on both a pre-tax and Roth deferral basis through salary reduction. Participants' elective deferrals subject to the limitations of the Internal Revenue Code Section 401(g). Participants' who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan is a safe harbor 401(k) Plan and as defined in the Plan, the Company will make a contribution equal to 3% of the participants compensation. For the plan year ended December 31, 2024, the Company matching contribution was \$895,111. The Company may make discretionary matching contributions, as defined in the Plan, not to exceed 4% of the participant's compensation as well as discretionary profit-sharing contributions. The Company elected to satisfy the safe harbor non-elective contribution for 2024 and there were no discretionary matching or profit-sharing contributions made in 2024.

**Participant Accounts**

A separate investment account is maintained for each Plan participant. Participants may direct the investment of their account into the various funds specified by the Plan. Participant accounts are credited with the participant's contribution and an allocation of the Company's matching contribution and Plan earnings (losses), as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately 100% vested in their own contributions, the safe harbor non-elective contributions, as well as the earnings on those contributions to the Plan.

Regardless of the vesting schedule, a participant will become fully vested upon death, disability, and at normal retirement age.

**Participant Loans**

Plan participants are eligible to borrow against the Plan by pledging a percentage of their vested account balance as collateral. A loan amount may not be less than \$1,000 nor may it exceed the lesser of 50% of the individual’s vested account balance or \$50,000. The term of the loan may not exceed five years unless the loan qualifies as a home loan (to acquire a principal residence). The interest rate applicable to the loan is determined at the time of application to be prime rate plus 1%. The loans bear interest at rates that range from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Upon default, any loan amounts not repaid will be taxed as a distribution of benefits, as defined in the Plan.

Participants are eligible to receive a distribution of the vested portion of their individual account balance upon the following:

- The occurrence of any of the distributable events specified in the Plan
- The participant’s termination of employment after attaining normal retirement age, or
- Termination of the Plan.

Early retirement is age 60 and competition of 6 years of service. Years of service are determined using years of service for vesting.

The normal retirement age under this Plan is 65.

**Forfeitures**

Employees who terminate employment and are not fully vested will forfeit the nonvested portion of their account balance to the Plan, as specified in the Adoption Agreement. The forfeiture nonvested account balance was \$3,181 and \$3,091 for the years ended, December 31, 2024 and 2023, respectively, and is maintained in an account separate from the individual participant accounts. Amount of forfeitures used to reduce participant accounts during the year ended December 31, 2024 was \$0.

**Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. Upon termination of the Plan by the Company, each Participant shall be 100% vested and have a nonforfeitable interest in the participant's employer matching account.

**Plan Amendments**

On December 29, 2022, the "Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act" was signed into law in the Under States. The Secure 2.0 Act is an expansion of the Secure Act passed during 2019. The Act includes several mandatory and optional provisions that will become effective across several years. The Secure 2.0 Act aims to expand retirement access, increase retirement savings, and simplify plan administration. Plans may choose to operationally implement the provisions of the Secure 2.0 Act, however plan administrators have until December 31, 2026 to officially amend the plan document to reflect the provisions adopted by the plan.

**NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments in mutual funds are stated at fair value at December 31, 2024 and 2023. Quoted market prices are used to value mutual funds. Net appreciation or depreciation of investments is reported on the statement of changes in net assets available for benefits and consists of realized gains and losses and the unrealized appreciation or depreciation of these investments. The Plan's investments in common collective trust are stated at net asset value, as a participant expedient, as reported by the trustee which include a mix of mutual funds and managed accounts. All underlying investment options are valued daily. This daily price is considered the selling price for transfers and withdrawals and is calculated each day when the principal market is open and available to any participant in the Plan.

Purchases and sales of mutual funds shares and the common collective trust are recorded at end of day net asset value. Dividends are recorded as of the record date.

**Participant loans receivable**

Participant loans receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses, excluding transaction fees, are paid by the Company.

**Date of Management's Review**

Management has evaluated subsequent events through August 26, 2025, the date which the financial statements were available to be issued.

**NOTE C - FAIR VALUE MEASUREMENTS**

Professional accounting standards establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value into three broad levels.

**NOTE F - TAX STATUS**

The Plan has adopted a Prototype Plan sponsored by ADP. The Prototype Plan obtained its latest opinion letter on October 6, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the opinion letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G - RISKS AND UNCERTAINTIES**

The Plan provides for investments in a selection of mutual funds and a common collective trust. Mutual funds and the common collective trust are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain mutual funds and the common collective trust, it is at least reasonably possible that changes in the values of mutual funds and the common collective trust will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
