## Independent Auditor's Report

To the Trustees and Plan Administrator of  
Jumpstart For Young Children, Inc. Employees Savings Trust:

### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Jumpstart For Young Children, Inc. Employees Savings Trust (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jumpstart For Young Children, Inc. Employees Savings Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### ***Opinion***

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### ***Basis for Opinion***

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). ### 1. DESCRIPTION OF PLAN

The following description of Jumpstart For Young Children, Inc. Employees Savings Trust (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### a. General

The Plan is a 401(k) defined contribution retirement plan covering substantially all employees of Jumpstart for Young Children, Inc. (the Plan Sponsor). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Administrator is responsible for the oversight of the Plan, determining the appropriateness of the Plan's investment offerings and monitoring investment performance, and reports to the Plan's Fiduciary Committee and Trustees.

#### b. Eligibility

Employees who have reached the age of twenty-one and have completed three months of service are eligible to participate in the Plan. Specific program members, volunteers, fellows, non-resident aliens and residents of Puerto Rico are excluded from the Plan as defined in the plan document.

#### c. Contributions

Each year, participants may contribute up to 50% of pre-tax annual compensation. Contributions are subject to Internal Revenue Service (IRS) limitations. Participants who have attained the age of fifty before the end of the plan year are eligible to make catch-up contributions. The Plan has a Roth component in which participants can elect to make post-tax contributions into the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover contributions). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan Sponsor makes safe harbor matching contributions equal to 100% of a participant's elective deferrals up to 4% of gross wages. The Plan Sponsor made safe harbor matching contributions in the amount of \$224,276 for the plan year ended December 31, 2024. The Plan Sponsor may also make a discretionary non-elective contribution to the Plan based on the Plan Sponsor's approval which is determined annually. For the year ended December 31, 2024, there was no discretionary non-elective contribution made.

#### d. Participant Accounts

Each participant's account is credited with the participant's contribution, the safe harbor matching contributions, and an allocation of the Plan Sponsor's discretionary non-elective contribution, if any, and Plan earnings (loss). Participants are charged with an allocation of administrative fees paid by the Plan, if any. Allocations are based on participant's earnings (losses), account balances, or directly charged, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### e. Vesting

Participants are immediately vested in their voluntary contributions and the Plan Sponsor's safe harbor matching contributions plus actual earnings thereon. Any discretionary non-elective contributions made by the Plan Sponsor are 100% vested after completing two years of service. A year of service is defined as 1,000 hours of credited service.

#### f. Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan allowed is \$500. Participants may only have one outstanding loan at a time. The loan term cannot exceed five years unless proceeds are used to purchase a primary residence, in which case the loan term can be up to thirty years. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with the prime rate as published in the *Wall Street Journal*, plus two percentage points. Principal and interest are repaid ratably through payroll deductions.

#### g. Payment of Benefits

The Plan provides for a normal retirement benefit to be paid to participants who have reached the age of 65, with no option for early retirement. There are also retirement benefits available upon disability and death. The normal forms of benefit payments are installments and direct rollovers, unless the participant elects to receive a lump-sum payment. The Plan requires balances up to \$1,000 to be paid out to participants upon termination. The Plan provides for the direct rollover to an individual retirement account (IRA) for terminated participants with balances greater than \$1,000 and not more than \$5,000, unless directed otherwise by the participant. Effective January 1, 2024, the involuntary cash-out limit was increased to \$7,000 per the provisions of SECURE Act 2.0.

The Plan allows in-service withdrawals upon attainment of age 59 ½. A participant may also request a withdrawal upon demonstration to the Plan Administrator that they are suffering a "hardship". Hardship is defined in applicable regulations promulgated or to be promulgated pursuant to the applicable section of the Internal Revenue Code (IRC) or standards established by the Secretary of the Treasury or their delegate.

#### h. Forfeited Accounts

Forfeitures represent non-vested Plan Sponsor contributions forfeited by participants who terminate their employment or who withdraw from the Plan. Forfeitures of terminated participants' non-vested accounts are used to reduce the Plan Sponsor's safe harbor matching contribution or pay plan expenses. There were \$1,535 and \$132 of unallocated forfeitures as of December 31, 2024 and 2023, respectively. There were \$807 of forfeitures used in 2024 to reduce Plan Sponsor safe harbor matching contributions and plan expenses.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

#### **Basis of Presentation**

The Plan prepares its financial statements in accordance with generally accepted accounting principles (U.S. GAAP) established by the Financial Accounting Standards Board (FASB). References to U.S. GAAP in these notes are to the FASB Accounting Standards Codification (ASC).

#### **Use of Estimates**

The preparation of financial statements in accordance with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of fair value measurement.

The assets of the Plan are invested in mutual funds and a common collective trust. Mutual funds are stated at fair market value as determined by the qualified institution, based upon the last reported sales price on the last business day of the plan year. The Plan's interest in the common collective trust is stated at net asset value (NAV) based on information reported by the investment advisor using the audited financial statements of the collective trust at year-end. Gains and losses are recognized as incurred upon the sale or maturity of investments based on market value changes during the period.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued unpaid interest. Interest income on notes receivable from participants is recorded on the accrual basis. Related fees are recorded as administrative fees and are expensed when incurred. No allowances for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. As of December 31, 2024, there were \$3,808 of defaulted loans that have been deemed distributed and are included in benefits paid to participants in the accompanying statement of changes in net assets available for benefits.

#### **Contributions**

Contributions from plan participants and the safe harbor matching contributions from the Plan Sponsor are recorded in the year which the participant contributions are withheld from compensation. The Plan Sponsor's discretionary non-elective contributions are recorded when such contributions are authorized by the Plan Sponsor.

#### **Payment of Benefits**

Benefits paid to participants are recorded when paid.

#### Administrative Fees

Certain expenses of maintaining the Plan are paid directly by the Plan Sponsor and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and processing of distributions, recordkeeping, and investment advisory services are charged directly to the participants' account and are included in administrative fees. Investment-related expenses are included in net appreciation of investments.

#### Subsequent Events

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued. There were no events that met the criteria for recognition or disclosure in the financial statements.

### 3. INFORMATION PREPARED AND CERTIFIED BY THE PLAN'S QUALIFIED INSTITUTION

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company (Reliance), a qualified institution, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, and the supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024, and the related investment transactions and investment income and interest income on notes receivable from participants reported in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to certified investment information, except for comparing such certified investment information included in the accompanying financial statements and supplemental schedule, Form 5500, Schedule H, Part IV, Line 4i - Schedule of Assets Held at End of Year as of December 31, 2024.

### 4. FAIR VALUE MEASUREMENT

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants as of the measurement date. *Fair Value Measurement* establishes a hierarchy of the valuation techniques based upon whether the inputs to those valuation techniques reflect assumptions other market participants would use based upon market data obtained from independent sources (also referred to as observable inputs). The fair value hierarchy is as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

### 4. FAIR VALUE MEASUREMENT (Continued)

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust:* Valued at the NAV of the units held by the common collective trust (CCT). The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CCT less its liabilities. The NAV is used as a practical expedient to estimate the fair value, unless it is probable that all or a portion of the CCT will be sold for an amount different from NAV. As of December 31, 2024 and 2023, the Plan had no plans to sell the CCT at an amount different than NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the CCT, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. COMMON COLLECTIVE TRUST**

The CCT is represented by the underlying investment in the MetLife Reliance Stable Value Fund 25053 Class O, which invests in fully-benefit-responsive investment contracts, commonly referred to as guaranteed investment contracts (GICs), synthetic investment contracts, and similarly designed contracts issued by insurance companies, banks and other financial institutions. The Plan's investment in the CCT is not considered fully benefit-responsive investment contracts and is reported at fair value (see Note 4).

**6. PARTIAL PLAN TERMINATION**

During 2024, the Plan was subject to IRS rules concerning a partial plan termination when plan participation decreased by greater than 20%. All benefits for participants affected by the partial plan termination were already 100% vested.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested in their accounts and all accrued benefits shall be paid to participants in accordance with the provisions of the Plan.

### **8. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, transactions with investment funds managed and held by the qualified institution and notes receivable from participants are considered party-in-interest transactions. The Plan has a service agreement with ADP Retirement Services (ADP), who has retained Reliance as a subcontractor to provide recordkeeping and trust services for the Plan. Both ADP and Reliance are considered parties-in-interest. The Plan paid \$31,741 of investment advisory fees and record keeping fees during the year ended December 31, 2024.

### **9. TAX STATUS**

The Plan Sponsor has obtained an opinion letter dated October 6, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the IRC. The Plan Administrator timely adopted the restated prototype plan. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions' however, there are currently no audits for any tax periods in progress.

### **10. RISKS AND UNCERTAINTIES**

The Plan provides for various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant balances and the amounts reported in the statements of net assets available for benefits.

### **11. DELINQUENT PARTICIPANT CONTRIBUTIONS**

During 2022, the Plan Sponsor failed to segregate and remit in a timely manner certain participant contributions (salary reduction amounts) and loan repayments from its assets within the required time period as specified by the United States DOL Reg. 2520.3012. Failure to segregate and remit contributions within the specified time period is a prohibited transaction. The Plan Sponsor remitted the lost earnings for the plan year ended December 31, 2022, in November 2024.
