Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Exiger, LLC 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a contributory defined contribution 401(k) plan covering all eligible employees of Exiger, LLC (the “Plan Sponsor” or “Employer”). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was adopted and became effective in January 2017. All employees of the Plan Sponsor who are at least 21 years of age, other than hourly interns, are eligible to participate in the Plan.

In January 2023, Exiger, LLC acquired Supply Dynamics Incorporated. Consequently, the latter’s employee benefit plan, Supply Dynamics 401(k) Plan, merged into the Plan. The Plan document was amended to include Supply Dynamics Incorporated as a participating employer effective January 1, 2023. On February 28, 2023, the transfer of assets from Supply Dynamics 401(k) Plan was made into the Plan amounting to \$2,415,102. The changes in net assets of the combined plans are included in the accompanying statement of changes in net assets available for benefits from January 1, 2023 through December 31, 2024.

Contributions

Contributions to the Plan are made by the participating employees through salary reductions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of eligible compensation. Each year, participants may contribute between 1% and 90% of their annual compensation on a pretax or Roth after tax basis, subject to the maximum amount allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

The Employer makes matching contributions equal to 100% of each employee’s contribution up to 3% of the employee’s compensation. The Plan does not provide for additional discretionary employer contributions.

Participant Accounts

Each participant’s account is credited with the participant’s contribution and employer matching contributions, as well as allocations of plan earnings/losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options

The Plan currently offers various mutual funds through regulated investment companies, as well as two stable value funds. Upon enrollment in the Plan, a participant may direct contributions to any of the investment options, participants may change their investment options daily.

1. DESCRIPTION OF PLAN (Continued)

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate, determined at the time of the loan, is set at two percent above the prime rate of interest as published by The Wall Street Journal. Loans are due over a period not to exceed five years except for loans used to purchase a principal residence, which are payable up to thirty years from the date of the loan. Principal and interest is paid ratably through bi-monthly payroll deductions.

Payment of Benefits

A participant's vested account is payable upon termination, retirement, disability or death. The participant, or designated beneficiary upon the participant's death, may choose to receive a lump-sum payment or installment payments.

Prior to termination of service, participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59 ½. Participants may also withdraw any of their rollover contribution balance at any time.

While employed, a participant may also withdraw his or her vested account balance on account of financial hardship, as defined in the Plan document. All hardship withdrawals must comply with the rules relating to hardships which are uniformly applicable to all participants and be used to pay qualifying expenses of certain immediate and heavy financial need.

Vesting

Participants are immediately vested in their contributions, qualified rollovers, employer matching contributions, and net earnings thereon.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenue and expenses during the reporting period. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain Plan expenses are paid by the Plan Sponsor. Fees paid to the custodian or the recordkeeper for investment management services and bookkeeping services, are paid by the Plan and recorded as a reduction of the investment returns. Certain transactional expenses are charged directly to the related participants' accounts and are reflected as administrative expenses in the financial statements.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit risks and overall market volatility. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Fair Value Measurements

The Plan has financial instruments which are recorded at fair value in the accompanying statements of net assets available for benefits. The Plan makes estimates regarding the valuation of assets measured at fair value in the financial statements. These assets include the investments in the common/collective trust and mutual funds.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The Plan uses various valuation techniques in determining fair value. U.S. GAAP establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. Observable inputs are inputs that market participants would use in pricing the asset or liability developed based on market data obtained from sources independent of the Plan. Unobservable inputs are inputs that reflect the Plan's assumptions about the assumptions market participants would use in pricing the asset or liability, developed based on the best information available in the circumstances.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurements (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment. The Plan's investments in mutual funds are valued utilizing Level 1 inputs.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly. The Plan has no investments valued using Level 2 inputs.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement. The Plan has no investments valued using Level 3

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds - Valued at the fair market value of shares held by the Plan at the daily closing price reported by the funds.

Common/Collective Trusts – Valued based on the fair value using the net asset value (NAV) practical expedient as determined by the issuer based on the current fair values of the underlying assets of the fund.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used in the prior year.

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the year ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 2 and no transfers into or out of Level 3. A description of where the Plan's investments fall within the Accounting Standards Codification (ASC) 820 hierarchy is provided in Note 3.

3. FAIR VALUE MEASUREMENTS

Accordingly, Reliance Trust Company, the custodian of the Plan, has certified that the following data included in the financial statements and the investment information included in the accompanying supplemental schedule, Schedule of Assets (Held at End of Year) – Schedule I, is complete and accurate as of and for the years ended December 31, 2024 and 2023.

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would remain 100% vested in employee and employer contributions.

6. TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not requested its own determination letter from the IRS. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

7. PARTY-IN-INTEREST TRANSACTIONS

Fees paid by the Plan for investment management services, custodial services and bookkeeping services qualify as exempt party-in-interest transactions. The Plan allows current employees who are participants to receive loans under specific circumstances. As such, transactions between the participants that have loans and the Plan also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

8. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

In July 2024, Exiger, LLC acquired XSB, Inc. The XSB 401(k) Profit Sharing Plan was terminated effective December 31, 2024. On January 1, 2025, the Plan was amended to include XSB, Inc. as a participating employer and XSB, Inc. employees became eligible to participate in the Exiger, LLC 401(k) Plan.

On January 1, 2025, ADP Retirement Trust Services, LLC replaced Reliance Trust Company as the Plan trustee and custodian.
