1. Plan description

The following description of the PrimeFlight Aviation Services, Inc. 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering all employees of PrimeFlight Aviation Services Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 80% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The plan sponsor will make matching contributions of 50% of employee contributions up to 4% of compensation or nonelective contributions to the Plan. Contributions are subject to certain limitations.

Participant accounts

The Plan currently offers mutual funds and common collective trusts as investment options for participants. Each participant's account is credited with the participant's contribution and allocations of Plan earnings and the employer's contribution. Allocations are based on participant earnings or account balances, as defined. Each participant is entitled to the benefit that can be provided from his or her vested account.

Vesting

Participants vest immediately in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based upon years of continuous service. Participants are 100% vested in profit sharing contributions and matching contributions after 5 years of service.

Forfeited accounts

At December 31, 2024 and 2023, there were \$22,833 and \$20,140, respectively, forfeited nonvested accounts. Future forfeitures may be used to reduce administrative expenses or employer contributions. During the year ended December 31, 2024, \$99,039 of forfeited accounts were used to decrease contributions and \$41,027 were used to reduce administrative expenses.

Notes receivables from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers to (from) their investment funds from (to) the Participant Loans fund. Loan terms may range from 1 - 5 years for most loans and up to 30 years for the purchase of a primary residence, are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest on loans is to be repaid through monthly payroll deductions.

1. Plan description - continued

Payments of benefits

Plan benefits are available upon termination of employment, death, disability, or retirement. A participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance greater than \$5,000 may also elect to defer payment or receive partial distributions of his or her account.

The Plan also allows for in service withdrawals in limited circumstances, as defined by the Plan.

2. Summary of significant accounting policies

Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Contributions receivable

Contributions receivable are recorded when contributions have been deducted from payroll but have not yet been received by the Plan.

Notes receivable from participants

Notes receivable to participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are paid. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan agreement.

Investment valuation and income recognition

Plan investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and capital gains are recorded on the accrual basis.

Payment of benefits

Benefits are recorded when paid.

Plan expenses

Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. Participant loans fees or transaction expenses are deducted from loan or distribution proceeds, as applicable, or are charged directly to the participant's account. A portion of expenses incurred by the Plan have been paid for by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Date of management's review

Subsequent events were evaluated through October 8, 2025, which is the date the financial statements were available to be issued. No additional disclosures modifications were deemed necessary.

3. Certified investment information

Certain information related to investments are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including the investments and notes receivable from participants held at December 31, 2024 and 2023, and net increase in fair value of investments, interest and dividend income and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

4. Investments

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments.

When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The three levels of the fair value hierarchy are described below.

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

*Level 3* - Inputs to the valuation methodology are unobservable.

Mutual funds - The fair value of mutual funds is based on quoted market prices of the shares held by the Plan at year-end.

Common collective trusts - The fair values of the funds are valued at net asset value of collective trusts, as provided by the fund manager, as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested.

6. Party-in-interest transactions

Plan assets include notes receivable from participants. These transactions qualify as party-in-interest transactions. Investment fees and expenses associated with Plan administration are paid to certain parties-in-interest. All of these transactions are exempt from the prohibited transaction rules under ERISA.

7. Tax status

The Plan sponsor has adopted a pre-approved profit sharing plan and is relying on the pre-approved profit sharing plan's IRS opinion letter for qualification. In the pre-approved profit sharing plan's opinion letter dated October 6, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is not subject to income tax examination for years prior to 2021.

8. Plan administration

Certain administrative functions are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan.

10. Prohibited transactions

Contributions for the year ended December 31, 2024, that were not segregated and remitted in a timely manner totaled \$70,944. Plan management intends to fully correct these late remittances by contributing lost earnings to participant accounts in 2025.

Additionally, during the year ended December 31, 2024, management did not withhold and remit participant contributions from bonuses and certain other compensation paid during the year. Management was not able to determine the dollar amount of the impact to the Plan financial statements as of the date the financial statements were available to be issued. Plan management intends to fully correct these by remitting the missed participant contributions and contributing lost earnings to participant accounts in 2025.

11. Transfers from other qualified plans

On January 1, 2024, the PrimeFlight - Legacy Skytanking, Inc. 401(k) Plan merged into the PrimeFlight Aviation Services, Inc. 401(k) Retirement Plan, and assets of \$420,645, comprised of investments, were transferred into the Plan. All participants in the previous plan became participants in the Plan.

12. Risks and uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
