Independent Auditors' Report

**To the Plan Administrator and Trustees of
Jewish Family Services of Central NJ 401(k) Plan**

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Jewish Family Services of Central NJ 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements (collectively referred to as the "financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jewish Family Services of Central NJ 401(k) Plan Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section –

1. The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
2. The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 Description of Plan

The following description of the Jewish Family Services of Central NJ 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document or Summary of Plan Description for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan under the provision of Section 401(k) of the Internal Revenue Code ("IRC") covering the eligible employees of Jewish Family Services of Central New Jersey (the "Plan Sponsor"). The Plan is subject to the provisions of the Employee Retirement Security Act of 1974 ("ERISA"), as amended. All employees of the Plan Sponsor are eligible to participate following attainment of two months of services, as defined, provided they are at least eighteen years of age.

Plan Contributions

Participants may contribute up to 90% of their pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants are permitted to make rollover contributions of eligible distributions from other qualified defined benefit or defined contribution plans ("rollovers"). Participants direct the investment of their contributions into various investment options offered under the Plan.

The Plan includes an automatic enrollment provision under which all newly eligible employees are enrolled unless they elect not to participate. Effective February 1, 2023, the initial deferral rate for automatically enrolled participants was increased from 1% to 3% of eligible compensation. The deferral rate increases by 1% each year, up to a maximum of 10%. Until changed by the participant, contributions are invested in a designated balanced fund.

Excess contributions are refunded in the subsequent year. As of December 31, 2024 and 2023, excess contributions refundable totaled \$- and \$356, respectively.

In addition, the Plan Sponsor contributed 100% of the first 3% of eligible compensation that participants contributed to the Plan. Effective April 1, 2024, the Plan was amended to provide for a matching contribution of to 100% of the first 1% of eligible compensation contributed by participants. During the year ended December 31, 2024, the Plan Sponsor made matching contributions totaling \$43,474, net of \$24,259 in forfeitures.

Participant Accounts

Each participant's account is credited with their contributions, allocations of Company contributions, and a share of Plan earnings. The participant's account is also charged with an allocation of administrative expenses. Allocations are based on participant compensation or account balances, as defined. The benefits to which participants are entitled are limited to the value of their vested accounts.

Vesting

Participants are immediately vested in their contributions and the earnings thereon. Vesting in employer matching contributions and the earnings thereon is based on years of continuous service. A participant vests according to the following schedule:

Participant Loans Receivable

Participants may borrow from their account no less than \$500 and up to a maximum equal to 50% of their vested account balance up to \$50,000, whichever is less. Loan terms range from one to five years, except for loans used to purchase a primary residence, which may have longer repayment periods as deemed reasonable by the Plan Administrator. Loans are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates at the time the loan is approved. At December 31, 2024, interest rates on the outstanding loans ranged from 5.25% to 10.50%. Principal and interest are paid ratably, generally through payroll deductions. Processing fees are charged against participant accounts.

Payment of Benefits

Upon termination of service due to death, disability, or retirement, a participant may elect to receive benefits in the form of (i) either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or (ii) annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Hardship Benefits

The Plan allows for "hardship withdrawals" of employee benefits from participant's pre-tax elective deferral and ROTH elective deferral accounts based the provisions of the Plan document.

Forfeitures

When a participant withdraws from the Plan and has a nonvested balance in their account, the nonvested portion is forfeited. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$9,597 and \$10, respectively. These amounts will be available to reduce future employer matching contributions. During the year ended December 31, 2024 forfeitures of \$24,259 were used to reduce employer matching contributions.

Note 2 Summary of Significant Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("US GAAP") requires management of the Plan to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies based on information provided by the investment advisers, custodians and insurance company (See Note 4).

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Participant Loans Receivable

Loans receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases making loan repayments and the Plan administrator deems the participant loan to be in default, the outstanding loan balance is reduced and recorded as a benefit payment.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service ("IRS") are recorded as a liability with a corresponding reduction to contributions. The Plan distributes any excess contributions to the applicable participants subsequent to year end.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Expenses

Expenses related to the administration of the Plan are primarily paid by the Plan Sponsor and are not reflected in these financial statements. Fees related to the administration of participant loans are charged directly to the participant's account and are included in administrative expenses. Investment related expenses, other than those paid directly by the Plan, are netted against investment performance.

Subsequent Events

Management has evaluated subsequent events and transactions for potential recognition or disclosure through the date of the auditors' report, which is the date the financial statements were available to be issued.

Note 3 Certified Investments

The information related to investments and participant loans receivable disclosed in the accompanying financial statements and supplemental schedule, including investments and participant loans receivable held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, as well as interest and dividend income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by Reliance Trust Company, the trustee of the Plan.

Note 4 Fair Value Measurements

GAAP establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

At December 31, 2024, the Plan held Level 1 investments, as described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan had the ability to access.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques are designed to maximize the use of relevant observable inputs and to minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There were no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds

Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are mutual funds that are registered with the Securities and Exchange Commission ("SEC"). These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust

Stable value collective trusts are stated at fair value based on the NAV of the underlying investments, as reported to the Plan by the contract issuer. The NAV, as provided by Reliance Trust Company, is used as a practical expedient to estimate fair value.

Withdrawals and transfers can be made by participants on any business day. However, transfers cannot be made to competing funds for a period of 90 days. The issuer reserves the right to require 12 months' notification in order to ensure that securities liquidations are carried out in an orderly business manner.

The common/collective trust's objectives are to protect principal while providing a higher rate of return than shorter maturity investments, such as money market funds or certificates of deposit. To achieve this, the trust invests in instruments which are not expected to experience significant price fluctuations in most economic or interest rate environments. However, there is no assurance that this objective can be achieved.

The common/collective trust seeks to preserve principal and provide book value liquidity on a daily basis for plan permitted, participant directed withdrawals while maintaining a competitive interest rate.

Note 5 Related Party and Party-In-Interest Transactions

During 2024, the Plan paid \$22,017 for administrative services to ADP Inc., a party-in-interest to the Plan. These transactions qualify as party-in-interest transactions.

During the year ended December 31, 2024, the Plan paid \$10,412 to Fiduciary Plan Partners, LLC, a party-in-interest to the Plan, for investment and financial advisory services.

Certain expenses of the Plan were paid directly by the Plan Sponsor and are therefore not included in the accompanying financial statements.

Participant loans receivable qualify as party-in-interest transactions.

All party-in-interest transactions noted above were exempt from the prohibited transaction rules under ERISA.

Note 6 Plan Termination

Although the Plan Sponsor has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, participants will become fully vested, and net assets would be distributed to participants and beneficiaries in proportion to their respective account balances.

Note 7 Tax Status

The IRS has determined and informed the Plan Sponsor by a letter dated October 6, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if a position is taken that is more likely than not to be disallowed upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan remains open for examination for three years.

Note 8 Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rates, market and credit risks. It is at least reasonably possible that changes in the values of investment securities could occur in the near term, and that such changes could materially affect participants' account balances, and the amounts reported in the Statements of Net Assets Available for Plan Benefits.

The Plan's exposure to a concentration of credit risk is mitigated by the diversification of investments across a variety of participant-directed fund options. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments.
