INDEPENDENT AUDITOR'S REPORT

To the Participants and Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hebron Savings Bank 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hebron Savings Bank 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Hebron Savings Bank 401(k) Profit Sharing Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Hebron Savings Bank 401(k) Profit Sharing Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

For the years ended December 31, 2024 and 2023

NOTE 1 - DESCRIPTION OF THE PLAN

The following description of the Hebron Savings Bank 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Hebron Savings Bank (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Effective July 1, 2024, the Plan appointed ADP Retirement Trust Services, LLC and ADP Retirement Services to serve as trustee and recordkeeper, respectively. Previously, Nationwide Financial Services, Inc. served as the recordkeeper and third-party administrator of the Plan; Nationwide Trust Company, FSB, and Nationwide Life Insurance Company (collectively "Nationwide"), served as the custodian and insurance company, respectively, of the Plan (collectively "custodian") until July 1, 2024, at which point all plan assets were transferred to the new trustee.

Eligibility

All employees, except for union employees and non-resident aliens, who are at least 21 years of age and have completed one year of service are eligible to participate in the Plan. Eligible employees may enter the Plan on January 1st and July 1st coinciding with or next following the date they have met the eligibility requirements.

During 2024 the plan sponsor amended the eligibility provisions as follows:

- Effective January 1, 2024, eligibility service is reduced from one year of service to sixty days of service.
- Effective July 1, 2024, Residents of Puerto Rico are excluded from eligible employees.
- Effective July 1, 2024, eligible employees may enter the Plan on the 1st of the month coinciding with or next following the date they have met the eligibility requirements.

Contributions

Each year participants may contribute up to 100% of annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a guaranteed investment contract as investment options for participants.

NOTE 1 - DESCRIPTION OF THE PLAN (Continued)

Effective July 1, 2024, the plan sponsor amended the plan provisions to allow Roth contributions to the Plan, while also changing the maximum allowable amount that each participant may contribute to the plan from 100% to 90% of their annual compensation, as defined in the Plan, subject to the statutory limitations established by the Internal Revenue Code (IRC).

The Company provides a safe harbor matching contribution for all eligible employees, equal to 100% of participants' salary deferrals up to 4% of their compensation, plus 50% of deferrals between 4% and 6% of their compensation. The Company may also make a discretionary matching and profit-sharing contributions, determined annually. During the years ended December 31, 2024 and 2023, the Company made safe harbor matching contributions to the Plan totaling \$330,590 and \$271,313, respectively. The Company made no discretionary matching or profit-sharing contributions in 2024 or 2023.

Participant Accounts

Each participant's account is participant-directed and is credited with the participant's contributions and allocations of the Company's contributions, investment earnings and losses and any administrative expenses paid by the Plan. Allocations are based on participant investments held, account balances, or specific participant transactions, as defined. Plan participants have daily access to their account via phone or internet and may change the allocation of their investments to any of the investment options offered by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their elective deferrals, rollovers, safe harbor contributions and all earnings thereon. Vesting in the employer discretionary matching and profit-sharing contributions is based on years of continuous service. After two years of service, a participant becomes 20% vested in the employer profit sharing and matching contributions in the Plan; the vesting percentage increases by 20% each year until the participant becomes fully vested in his or her account after six years of service. A participant will also become fully vested upon attainment of normal retirement age, early retirement age with at least five years of service for vesting purposes, upon retirement due to disability, upon death, or upon termination of the Plan.

Notes Receivable from Participants

Participants in the Plan may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their eligible account balance, reduced by any outstanding note balance. The loans are secured by the balance in the participant's account and bear interest at the commercially reasonable rate. Effective July 1, 2024, participant loans bear interest at the prime rate plus 1%. The maximum duration of a loan is not to exceed five years, except in cases where funds are used to purchase a principal residence. Plan participants may have up to two loans outstanding at any one time. Principal and interest are paid ratably through payroll deductions. Interest rates on the outstanding loans as of December 31, 2024 and 2023 ranged from 5.25% to 10.50%.

Payment of Benefits

Upon termination of service due to retirement, death, full and permanent disability or attaining age 65, participants may elect to receive either a lump-sum amount equal to the value of their account, a direct rollover into a qualified retirement plan, or a combination of the two. For termination of service due to other reasons, participants may receive their benefits in the form of a distribution equal to the value of the vested interest in their account. The Plan allows in-service withdrawals at age 59½ and hardship withdrawals under certain circumstances, as defined in the Plan document. Withdrawals from rollover contributions are permitted at any time.

Forfeited Accounts

Forfeitures of nonvested balances of terminated participants may be used to pay plan administrative expenses or reduce employer matching contributions. At December 31, 2024 and 2023, the balance in forfeited nonvested accounts totaled \$10 and \$-0-, respectively. During the years ended December 31, 2024 and 2023, the Plan used \$1,466 and \$-0-, respectively from forfeited nonvested accounts to reduce employer contributions.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting standards generally accepted in the United States of America (U.S. GAAP).

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts (FBRIC). Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to FBRIC because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the plan.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for FBRIC, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions

Contributions from Plan participants and the associated Company contributions are recorded in the year in which the employee contributions are withheld from compensation.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses may be paid either by the Plan or directly by the Company. The Plan is not required to reimburse the Company for expenses paid on behalf of the Plan. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses.

The Plan has a revenue sharing agreement with the plan trustee. If the trustee receives fund compensation above a certain amount, this excess compensation is made available to the Plan to offset expenses. As of December 31, 2024 and 2023, the balance available to offset future expenses totaled \$1 and \$-0-, respectively. During the years ended December 31, 2024 and 2023, Plan expenses totaling \$7,156 and \$-0-, respectively, were paid from revenue sharing funds.

NOTE 3 - CERTIFIED INFORMATION

Certain information related to investments held at December 31, 2024 and 2023, net appreciation in fair value of investments and interest and dividend income for the year ended December 31, 2024, disclosed in the accompanying financial statements and ERISA-required supplemental schedule, was obtained by management and agreed to or derived from information certified by Nationwide Trust Company, FSB, and Nationwide Life Insurance Company (collectively "Nationwide") for the period January 1, 2023 through July 1, 2024, and by ADP Retirement Trust Services, LLC for the period July 1, 2024 through December 31, 2024, as complete and accurate in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes receivable from participants and related interest income was certified by ADP Retirement Trust Services, LLC, for the period July 1, 2024 through December 31, 2024. Prior to July 1, 2024, notes receivable from participants and related interest income were not certified.

NOTE 4 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Company Shares

Prior to July 1, 2024, the plan invested in registered investment company shares held by Nationwide Trust Company and offered outside of an annuity contract. Nationwide uses unit values to perform daily account valuations. The unit value is Nationwide's method for valuing accounts and is not the same as the net asset value (NAV) reported by the fund house, although the financial trend should be the same. After the close of the stock market, Nationwide receives a daily price from each fund house. This figure includes the NAV and any dividends and capital gains declared and is adjusted by Nationwide with the addition of a daily admin charge to arrive at the unit value available daily to plan participants on the plan website. Due to the valuation process used, these investments are within Level 2 of the fair value hierarchy. All plan assets were transferred from Nationwide Trust Company to ADP Retirement Trust Services, LLC as of July 1, 2024.

Mutual Funds

Effective July 1, 2024, the plan invests in mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan at December 31, 2024 are open-end mutual funds registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed Investment Contract - non-FBRIC

The Plan participated in a non-fully benefit-responsive guaranteed investment contract (non-FBRIC) with Nationwide Life Insurance Company (Nationwide). The Nationwide Fixed contract is a group annuity contract supported by the general account of Nationwide. Deposits into the Fixed Contract are guaranteed in both principal and interest, minus any applicable fees and expenses (subject to the claims-paying ability of Nationwide). The contract is credited with earnings on a net daily basis at annual effective rates and charged for participant withdrawals and administrative expenses. The net rate, crediting rate and average yield earned are the same and were 1.87% for 2024 and 2023. The repayment of principal and interest to participants holding the investment is a financial obligation of Nationwide. The provisions of the Fixed Contract do not provide for a distribution at book value at some specified future date. Participants in the Nationwide Fixed Contract can request a lump sum distribution with a market value adjustment, or an installment payout, at book value, over a period of years. Participant withdrawals are subject to a plan-level 20% exchange limit for a rolling 12-month period. Plan level liquidity options include either a two-way market value adjustment or a 5-year contract value out and require a 120-day notice. The Fixed contract is not considered to be fully benefit-responsive investment contract as defined by ASC 962, due to the existing restrictions to participants' "reasonable access" to their contract balances and is as a result reported at fair value in the accompanying financial statements. The fair value is determined by discounting the expected cash flows, i.e., the amount participants would receive upon termination of the Contract, considering the creditworthiness of the issuer. Fixed contract monies represent deposit liabilities, with no defined maturities. The fair value is equal to the contract value less any contingent deferred sales charge (CDSC), if applicable, and Market Value Adjustment. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. This contract currently does not have a CDSC adjustment. In determining the reasonableness of the methodology, a variety of factors are evaluated including review of existing contracts, economic conditions, industry and market developments, and overall credit ratings. Effective July 1, 2024, the contract was terminated.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT – FBRIC

Effective July 1, 2024, the Plan entered in a fully benefit-responsive investment contract (FBRIC) with the Lincoln National Life Insurance Company (Lincoln) via an investment in the Lincoln Stable Value Account. Lincoln maintains the contributions in a general account or insulated separate account.

The Lincoln Stable Value Account is managed by Lincoln Investment Management Company (LIMCO) and generally invests in a broadly diversified portfolio of predominantly fixed income instruments with insulation from insurance company obligations through a separate account structure. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula agreed upon with the issuer but may never fall below the contractual guaranteed minimum interest rate of 1%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statement of net assets available for benefits at contract value. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. A 90-day equity wash applies for transfers to competing funds. Upon Plan level termination, book value payout will be over the period of 5 years (on six installments with first installment eligible for payment on payout initiation date and last installment eligible for payment on the fifth anniversary of the payout initiation date). The Stable Value Account remains fully benefit-responsive upon contract termination, and discontinuance fees do not apply. Either party to the contract may terminate the contract with at least 60 days advance written notice to the other party. There are no reserves against account value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at account value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST

The Plan's assets include investments in funds managed by the custodians of the Plan (Nationwide) through July 1, 2024, and ADP Retirement Trust Services, LLC beginning July 1, 2024, and, therefore, the transactions in these funds qualify as party-in-interest transactions. Personnel and facilities of the Company have been used to perform administrative functions for the Plan at no charge to the plan. There were no financial transactions recorded between the Company and the Plan other than contributions made. Notes receivable from participants also qualify as party-in-interest transactions.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

NOTE 8 - TAX STATUS

The Plan has adopted a prototype 401(k) Profit Sharing Plan sponsored by DST Retirement Solutions, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, which states that the non-standardized prototype plan, as then designed, is in compliance with the applicable requirements of the IRC. The Plan has been amended since the date of the opinion letter. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Effective July 1, 2024, the Plan adopted a pre-approved profit-sharing plan sponsored by ADP LLC. The prototype profit-sharing plan has received an opinion letter from the IRS dated October 6, 2020, which states that the prototype plan, as then designed, is in compliance with the applicable requirements of the Internal Revenue Code (IRC). The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 8, 2025, which is the date the financial statements are available to be issued.
