Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. We evaluated the key factors and assumptions used to develop the Plan’s accounting estimates in determining that they are reasonable in relation to the financial statements taken as a whole. The financial statement disclosures are neutral, consistent, and clear.

Supplemental schedule - With respect to the ERISA-required supplemental schedule accompanying the financial statements, we made certain inquiries of management and evaluated the form, content, and methods of preparing the information to determine that the information complies with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the method of preparing it has not changed from the prior period, and the information is appropriate and complete in relation to our audit of the financial statements. We compared and reconciled the ERISA-required supplemental schedule to the underlying accounting records used to prepare the financial statements or to the financial statements themselves.

Hardship withdrawal support - During our review of hardship distribution requests, we noted that a payment in the amount of \$7,618.25 was processed for a participant requesting a distribution to pay for tuition expenses. However, the supporting documentation provided for this request only substantiated tuition expenses totaling \$3,988.

This discrepancy indicates that the amount distributed exceeded the documented financial need, which may not be in compliance with IRS and plan requirements for hardship withdrawals. Under IRS guidance, hardship distributions must be limited to the amount necessary to satisfy the immediate and heavy financial need, as supported by appropriate documentation.

We recommend that management review the procedures for verifying and approving hardship distribution amounts to ensure that all future distributions are fully supported by adequate documentation and are consistent with both plan provisions and regulatory requirements. Additionally, we suggest evaluating whether corrective action is necessary for this specific transaction.
