### *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Northstar Energy Management LLC dba NovaSource Power Services Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### *Opinion*

## Notes to Financial Statements

### 1. Description of Plan

The following description of the Northstar Energy Management LLC dba NovaSource Power Services Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### *General*

The Plan is a defined contribution plan originally established effective May 1, 2020, covering all eligible employees of Northstar Energy Management, LLC now known as Northstar Energy Management, LLC dba NovaSource Power Services (the Plan Sponsor, Employer or Company). Prior service credit (for eligibility, vesting and contribution allocations) were granted for employees based on periods of services with Sunpower Corporation. Effective March 31, 2021, the Plan agreement was amended to provide for prior service credit (for eligibility, vesting and contribution allocations) for employees based on their periods of service with First Solar. Additionally, effective December 31, 2021, the SST Construction, LLC 401k Plan was merged into the Plan. Eligible employees may enroll in the Plan at their discretion. Investments are participant directed and the Company controls and manages the operation and administration of the Plan. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

All plan investments are held and managed by the Plan's trustee, Reliance Trust Company (Reliance or the Trustee). ADP Retirement Services (ADP) is the recordkeeper for the Plan.

#### *Eligibility*

Employees are eligible to participate in the Plan upon hire. Union employees (unless included by a collective bargaining agreement), certain non-resident aliens, leased employees, interns and Puerto Rican Residents are not eligible to participate in the Plan.

#### *Contributions*

The Plan allows for the following types of contributions:

- *Salary Deferral 401(k) Contributions* - The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Internal Revenue Code (the Code). Participants may contribute on a pre-tax or after-tax (Roth) basis. Catch-up contributions are also allowed for those age 50 or older. Employees may voluntarily contribute up to 75% of their eligible compensation, subject to various nondiscrimination tests and limitations prescribed by the Code.
- *Fixed Employer Matching Contributions* - The Plan was amended to provide that the Plan Sponsor will contribute a matching contribution of 100% of the first 4% of eligible compensation that a participant contributes to the Plan.
- *Rollover Contributions* - Participants may make rollover contributions from another qualified plan.

#### *Participant Accounts and Allocations*

The Plan allows participants to self-direct their account balances and contributions among various investment options. Participants are allowed to direct their investments to a single fund or a

combination of funds. Investment earnings and losses are allocated to participants' accounts based on the earnings or losses of the investments selected. Participant accounts may be charged with an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is limited to the vested interest in their individual account.

***Vesting***

Participants are always 100% vested in their voluntary contributions and gains/losses credited thereon. Employer matching contributions, and gains/losses credited thereon vest as follows:

Years of Credited Service	Vested Percentage (%)
1	50
2	100

Participants also become fully vested in their accounts if they reach normal retirement age (age 62), death, or terminate employment due to becoming disabled.

***Forfeitures***

The Employer may use forfeitures to pay any administrative expenses or to reduce any Employer contribution. The non-vested portion of a terminated participant's balance is forfeited as of the date of a five-year break in service. As of December 31, 2024 and 2023, respectively, there were \$10,282 and \$9,194 of forfeited funds available for future use, respectively. There were \$246,512 in forfeitures used to reduce employer contributions during the year ended December 31, 2024.

***Payment of Benefits***

Upon termination or separation of service, death, disability, retirement, or age 59½ (minimum distribution of \$500), a participant may elect to receive their benefits as a lump-sum amount equal to the value of the participant's vested interest in his or her account. Installment and partial withdrawals are also permitted. Withdrawals from the Plan may also be made upon circumstances of financial hardship (minimum distribution of \$500), in accordance with provisions specified in the Plan.

Vested balances, not including amounts attributable to rollover contributions, less than \$5,000 may be automatically distributed in the form of a lump sum payment after termination of employment. Vested account balances over \$5,000 may remain in the Plan unless otherwise required by the Plan's minimum distribution requirements.

***Notes Receivable from Participants***

The Plan allows for participant loans. Participants may only have one outstanding loan at any point in time. Loans may not exceed \$50,000 or 50% of the vested interest of the participant's account and cannot be less than \$1,000. Borrowings are due no later than five years, unless the loan was taken for the purpose of securing a residence. Interest rates on participant notes receivable ranges from 4.25% to 9.50% as of December 31, 2024. Principal and interest are paid ratably through payroll deductions.

***Administrative Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and other participant requested transactions are charged directly to the participant's account and are included in administrative expenses as described in the Plan agreement and service agreements. Certain expenses are paid in the form of an expense ratio within the funds offered and are netted with investment income.

**2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Increases in the unit values of investments are reflected in each participant's individual account. Investments are valued daily.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are recorded as distributions based on the terms of the Plan agreement.

***Payment of Benefits***

Benefits are recorded when paid.

***Contributions and Contributions Receivable***

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

### **3. Certified Investment Information**

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance, a qualified institution.

### **4. Fair Value Measurements**

The Plan follows the provisions of Accounting Standards Codification (ASC) 820, *Fair Value Measurement*. ASC 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under ASC 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds* - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to

transact at that price. The mutual funds held by the Plan are deemed to be actively traded and are considered to fall under the Level 1 in the ASC 820 hierarchy.

*Common Collective Trust (CCT)* - The CCT is valued at the NAV of units of a bank collective trust. The CCT investment is a stable value fund that is composed primarily of fully benefit-responsive investment contracts. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan were to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The fund is a direct filing entity with the Department of Labor.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## **5. Concentrations, Risks, and Uncertainties**

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

There were three investments held at both December 31, 2024 and 2023, respectively, which individually accounted for more than 10% of net assets available for benefits. See Supplemental Schedule of Assets (Held at End of Year) for listing of investments held at December 31, 2024.

## **6. Related Party and Party-in-Interest Transactions**

Party-in-interest are defined under the Department of Labor regulations as any fiduciary of the Plan, any party rendering service to the Plan, the employer, and certain others. Notes receivable from participants are considered party-in-interest transactions, which are exempt from the prohibited transaction rules.

## **7. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their accounts, and the Plan assets, less expenses and liquidation costs, shall be distributed to the Plan participants.

## **8. Income Tax Status**

The Plan uses a pre-approved plan document sponsored by ADP. ADP received an opinion letter from the IRS, dated October 5, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since

the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audit by taxing jurisdictions; however, there are currently no audit for any tax periods in progress.
