Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of P K Willis Company Inc 401K Plan (the "Plan") an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024, and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1: DESCRIPTION OF PLAN

The following description of the P K Willis Company Inc 401K Plan (the “Plan”) provides only summarized general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan established January 1, 2012, to provide retirement benefits for eligible employees of Patrick K. Willis Company, Inc. (the “Plan Sponsor”) and its wholly-owned subsidiaries, American Recovery Services and Skip Busters (collectively the “Company”). Employees that are members of a collective bargaining agreement, leased employees, and employees not required to be taken into account for nondiscrimination testing purposes of the Internal Revenue Code (the “Code”) are not eligible to participate in the Plan. Eligible employees may enroll in the Plan when they have completed one year and 1,000 hours of service. The Plan is intended to satisfy all the requirements for a qualified retirement plan under the appropriate provisions of the Code and similar state tax laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended. Reliance Trust Company serves as the trustee of the Plan and custodian of the Plan assets.

Plan Year

The Plan year begins January 1st and ends December 31st.

Contributions

The Plan allows for the following types of contributions:

- **Employee Salary Deferral 401(k) Contributions**
The Plan includes an elective salary deferral arrangement pursuant to Section 401(k) of the Code. Employees may voluntarily contribute up to 90% of their eligible compensation, subject to various nondiscrimination tests and limitations prescribed by the Code. Employee salary deferrals include pre-tax elective deferrals and Roth after-tax elective deferrals.
- **Employer Matching Contributions**
The Plan Sponsor will make matching contributions equal to 50% of participant salary deferrals up to 3% of compensation, not to exceed an annual contribution of \$1,000 for the years ended December 31, 2024, and 2023. Employer matching contributions are determined each payroll period. The Plan Sponsor made matching contributions of \$103,626 and \$97,166 in 2024 and 2023, respectively.
- **Discretionary Employer Nonelective Contributions**
The Plan Sponsor may make a nonelective contribution equal to a discretionary amount. The discretionary nonelective contribution will be allocated to participants based on the Social Security Integration rules of the Code. Participants must be employed with the Plan Sponsor on the last day of the Plan year to be eligible for the contribution. The Plan Sponsor elected not to make a discretionary nonelective contribution in 2024 and 2023.
- **Employee Rollover Contributions**
Participants may make rollover contributions from another qualified plan.

NOTE 1: **DESCRIPTION OF PLAN (Continued)**

Participant Accounts and Allocations

Each participant's account is credited with the participant's contributions, employer contributions, rollover contributions, an allocation of investment earnings and losses, and an allocation of certain investment expenses, as defined by the Plan document. Investment earnings and losses are allocated to each participant's account based on each participant's pro rata share of the total investments in the particular fund. The benefit to which a participant is entitled is limited to the benefit that can be provided from the participant's vested account. The Plan allows participants to self-direct their account balances among various investment options.

Vesting

Participants are always 100% vested in their salary deferral and rollover contributions. Employer contributions and earnings and losses credited thereon vest as follows:

After 1 year credited service	60%
After 3 years credited service	80%
After 4 years credited service	100%

For vesting purposes, a year of service is based on anniversary date.

Additionally, a participant's interest in their respective account becomes 100% vested when the employee (a) attains age sixty-five while employed by the Plan Sponsor, (b) becomes disabled while employed by the Plan Sponsor, or (c) dies while employed by the Plan Sponsor.

Forfeitures

Forfeitures may be used to pay reasonable Plan expenses or to reduce employer contributions to the Plan at the discretion of the Plan Committee. Forfeitures of \$406 and \$516 were used to reduce employer contributions in 2024 and 2023, respectively, and forfeitures of \$130 and \$152 were included in net assets available for benefits at December 31, 2024, and 2023, respectively.

Retirement

Normal retirement under the Plan is age sixty-five (65).

Payment of Benefits

Payment of benefits may be made at the following times under the Plan: 1) normal retirement; 2) termination of employment; 3) upon demonstration of financial hardship; 4) total and permanent disability; 5) death of the participant; or 6) attainment of age 59 ½. Participants' vested accounts that do not exceed \$5,000 are distributed upon severance of employment. Effective January 1, 2024, participants' vested accounts that do not exceed \$7,000 are distributed upon severance of employment.

Benefit payments are distributed to participants in a single lump sum or installments.

Notes Receivable from Participants

The Plan allowed participants to borrow from their accounts. Loans could not exceed \$50,000 or 50% of the vested interest of the participant's account and could not be less than \$500. Participants were permitted one outstanding loan at a time. Borrowings bear interest at prime plus two percentage points and are due no later than five years. Loans taken for the purpose of acquiring a principal residence are repaid within thirty years. Principal and interest are repaid ratably through payroll deductions and are secured by the balance in the participant's account.

Effective September 1, 2019, the Plan was amended and restated to disallow participants from borrowing from their accounts.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan and the Plan Sponsor. Expenses related to specific participant transactions are charged to the respective participant's account.

NOTE 2: **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (“U.S. GAAP”).

Investment Valuation and Income Allocation

Investments are reported at fair market value. Fair market value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded when earned. Dividend income is recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments purchased and sold as well as held during the year. Changes in the unit values of investments are reflected in each participant’s individual account. Investments are valued daily.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024, and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan in default, the participant loan balance is reduced, and a benefit payment is recorded.

Excess Contributions Payable

Excess contributions payable represents amounts to be refunded to participants to comply with regulatory contributions limitations. Excess contributions are recorded as a liability in the accompanying statements of net assets available for benefits at December 31, 2024, and 2023, and as reductions to contributions in the statements of changes in net assets available for benefits for the years then ended.

Payment of Benefits

Benefits to participants are recorded when paid.

Income Taxes

The Plan has adopted a prototype plan which has obtained a favorable opinion letter dated October 6, 2020, in which the Internal Revenue Service stated that the Plan is acceptable under Section 401(k) of the Code. The Plan has been amended since receiving the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. Plan management has determined that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing authorities; however, there are currently no audits for tax periods in progress.

Estimates and Assumptions

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

NOTE 5: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) ASC 820 provides a framework for measuring fair value. That framework provides a three-tier hierarchy that prioritizes the inputs to valuation techniques used for measuring fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are as follows:

Level 1 - Inputs are unadjusted quoted prices for identical assets or liabilities that the Plan has the ability to access.

Level 2 - Inputs other than level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, model-based valuation techniques for which all significant assumptions are observable in the market, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 - Inputs that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common Collective Trusts: Common collective trust funds invest mainly in mutual funds and stocks, both domestic and international. The majority of the underlying assets have Level 1 quoted pricing inputs and observable Level 2 pricing inputs, including quoted prices for similar assets in active or non-active markets.

Stable Value Collective Trusts: Valued at the NAV of units of a bank collective trust. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The NAV is published daily by the trustee. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the common collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that security liquidations will be carried out in an orderly business manner.

NOTE 6: PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

NOTE 7: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 8: **RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Administrative expenses for recordkeeping services are paid to third party service providers. Indirect compensation for investment management services are recorded in appreciation in the fair value of investments. Notes receivable from participants are considered party-in-interest transactions. These investments and transactions qualify as party-in-interest transactions which are exempt from the prohibited transaction rules of ERISA.

NOTE 9: **SUBSEQUENT EVENTS**

Plan management has evaluated events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued and has determined that no subsequent events have occurred that should be disclosed.
