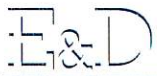

INDEPENDENT AUDITORS' REPORT

To the management of Tourneau/Bucherer 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Tourneau/Bucherer 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Tourneau/Bucherer 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Tourneau/Bucherer 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Tourneau/Bucherer 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. NOTES TO FINANCIAL STATEMENTS

1. PLAN DESCRIPTION

Background - The Tourneau/Bucherer 401(k) Plan (the "Plan"), as amended, is a defined contribution plan as described in the Internal Revenue Code section 401(k) sponsored by Tourneau LLC (the "Company"), a subsidiary of Bucherer AG of Switzerland ("Bucherer"). Carl F. Bucherer North America, Inc. ("CFBNA") is a participating employer in the Plan. The Plan was adopted on January 1, 1995 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Reliance Trust Company is the trustee of the Plan. ADP Inc. is the third-party administrator of the Plan.

The Plan implemented certain provisions of the Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act"), which was signed into law during December 2019. The SECURE Act raised the age for minimum distributions from 70 1/2 to 72 effective January 1, 2020. The SECURE 2.0 Act, which was signed into law during December 2022, raised the age for minimum distributions from 72 to 73 effective January 1, 2023.

During March 2020, the Plan implemented certain provisions of the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act"). For the year ended December 31, 2020, the CARES Act allowed certain eligible individuals to take coronavirus-related distributions, temporarily increased participant loan borrowing limits, allowed for the suspension of repayments on participant loans, and suspended required minimum distribution rules. Participants had the option of repaying distributions under the CARES Act within three years after the date the distribution was received; accordingly, such repayment period extended into 2023.

Written amendments to the Plan to reflect the operational changes in the SECURE and CARES Acts will be adopted in accordance with applicable law and IRS guidance.

Plan Amendments - During July 2022, the Plan sponsor adopted an amended and restated version of pre-approved plan documents, which incorporated recent tax law changes.

The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

1. PLAN DESCRIPTION (continued)

Eligibility - Employees of the Company and CFBNA, excluding (1) leased employees; (2) temporary holiday workers whose regularly scheduled service is less than 1,000 hours of service in the relevant eligibility computation period; and (3) interns, become eligible to participate in the Plan on the first day of the month after attaining age 21 and completing consecutive months of service. If temporary holiday workers actually complete a year of service as defined by the Plan, then such employees would no longer be considered excludable from participation. See Note 7 for a subsequent Plan amendment effective January 1, 2025 which classifies intercompany transfer employees from other countries who remain eligible to continue to receive retirement benefits from their home countries as excluded employees.

Contributions and Vesting - Participants in the Plan may make pre-tax 401(k) salary deferral contributions and Roth 401(k) deferrals on an after-tax basis, which may range from 1 percent to 70 percent of their compensation, subject to section 401(k) maximum limitations (\$23,000 in 2024). Under the Plan's automatic enrollment feature, once an employee meets the Plan's eligibility requirements, 3 percent of salary is automatically deducted and contributed to the Plan as pre-tax 401(k) deferrals, unless the employee specifies a different percentage, elects to make Roth contributions, or elects not to contribute to the Plan.

Employees who have attained age 50 before the close of the Plan year are eligible to make catch-up contributions of up to \$7,500 annually.

An eligible employee may make a transfer to the Plan of a benefit from a qualified retirement plan of another employer, referred to as rollover contributions, with certain restrictions.

Participants are fully and immediately vested with respect to their elective deferral contributions and earnings thereon.

1. PLAN DESCRIPTION (continued)

Effective January 1, 2022, the Company elected to commence discretionary employer matching contributions in the amount of 100 percent of employee deferral contributions up to 3 percent of eligible compensation.

Prior to CFBNA becoming a participating employer, its employees participated in a plan that had a discretionary match of 100 percent of employee deferral contributions up to 4 percent of eligible compensation. The Company elected that such employer matching contribution formula would continue for any CFBNA employees who had participated in the prior plan. For the year ended December 31, 2024, the portion of total employer matching contributions credited to CFBNA employees under the 4 percent match amounted to \$10,699.

Employer contributions and earnings thereon vest at 20 percent after one year of service, increasing 20 percent thereafter, until fully vested after five years of service. Participants are deemed to be fully vested upon attainment of normal retirement age (65), disability or death. See Note 7 for a modification to the vesting schedule effective April 1, 2025.

Forfeitures – When participants terminate employment prior to full vesting, the nonvested amounts in their individual accounts, referred to as forfeitures, may be used to reduce future employer contributions or to pay administrative expenses of the Plan. Unallocated forfeitures as of December 31, 2024 amounted to \$245,928.

Distributions to Participants - Distributions to participants are available upon the following events: retirement, termination of employment, the attainment of age 59 1/2, or death. A participant's benefit is paid in the form of a lump sum payment or a rollover to another qualified plan. Payment shall be made as soon as administratively feasible following the date on which the event occurs provided that the participant's consent is obtained for distributions of amounts in excess of \$7,000. A participant with an account balance in excess of \$7,000 may elect to defer payment until attainment of age 73 or if still employed beyond that age, until retirement. In the absence of the participant's election, if the account balance is between \$1,000 and \$7,000, an automatic rollover is made to an individual retirement account set up on behalf of the participant. The Plan also provides for hardship withdrawals to participants meeting certain requirements as described in the Plan agreement.

Upon enrollment in the Plan, participants are directed to designate a beneficiary or beneficiaries by completing a designation form. If a married participant designates someone other than their spouse as primary beneficiary, then the spouse must consent to this designation by signing the form and his/her signature must be witnessed by a Plan representative or a notary public. A participant's entire account balance is payable to the designated beneficiary upon his/her death.

1. PLAN DESCRIPTION (continued)

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account. The loan interest rate, which is determined by the Plan administrator based on the prime rate plus one percent, remains fixed for the duration of the loan. The interest rate ranged from 4.25 to 9.5 percent per annum on loans outstanding during the year ended December 31, 2024. Principal and interest is paid ratably through various biweekly payroll deductions over periods of 1 to 5 years, or up to 10 years for purposes of using loan proceeds in the purchase of a primary residence.

Administrative Expenses - Certain costs of administering the Plan are paid by the Company and are therefore not reflected in the Plan's financial statements. In accordance with Plan provisions, the Company may, at any time, elect to have some or all of such expenses paid by the Plan. Fees related to the administration of notes receivable from participants and distributions to participants are charged directly to the participant's account. Under fee arrangements with ADP Inc., the Plan's third-party administrator, and Morgan Stanley, the Plan's investment advisor, administrator and investment advisory fees are allocated directly to participants' accounts. Administrative expenses in the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024 consist of recordkeeping, loan and distribution fees paid to ADP, Inc. and investment advisory fees paid to Morgan Stanley.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Presentation - The Plan's policy is to prepare financial statements on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America for defined contribution plans.

Use of Estimates - The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

TOURNEAU / BOUCHERER 401(k) PLAN

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Investment Valuation and Income Recognition – The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further information regarding fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Risks and Uncertainties - The Plan provides for various participant-directed investment options in securities including mutual funds and collective investment trusts. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. As a result of the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and changes in net assets available for benefits.

Termination - The Company intends to continue the Plan indefinitely, but reserves the right to modify or discontinue it at its discretion, subject to applicable provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions and earnings thereon.

Subsequent Events - The Plan has evaluated subsequent events through October 3, 2025, the date the financial statements were available to be issued (see Note 7).

3. INCOME TAX STATUS

In October 2020, the Internal Revenue Service stated in an opinion letter that the prototype plan adopted by the Plan administrator was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). The Plan has been amended since receiving the opinion letter, however, the Plan administrator and management believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Accordingly, they believe that the Plan was qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that would likely not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

Investments in mutual funds - The participant-directed mutual funds offer various investment options ranging from conservative funds which principally seek to preserve capital and provide fixed income to aggressive funds invested principally in common stocks which seek growth of capital over the long term. The mutual funds also include T. Rowe Price Retirement Funds with varied target retirement dates. See Note 5 for a description of mutual funds stated at fair value.

Investment in collective investment trust fund - The Reliance Trust Company Stable Value Fund - MetLife Series 25053 Class 0 ("MetLife Series 25053") is a collective investment trust fund issued and administered by Metropolitan Life Insurance Company ("MetLife") under its Group Annuity Contract No. 25053 (the "Contract"). Reliance Trust Company, the trustee of the MetLife Series 25053, is also the trustee of the Plan. The Contract simulates the performance of a guaranteed investment contract through the guarantee of a specific interest rate and a portfolio of financial instruments that are owned by MetLife and managed by Reliance Trust Company, which provides annual audited financial statements for the collective investment trust fund.

See Note 5 for a description of the measurement of the collective investment trust fund stated at fair value.

5. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- * quoted prices for similar assets or liabilities in active markets;
- * quoted prices for identical or similar assets or liabilities in inactive markets;
- * inputs other than quoted prices that are observable for the asset or liability;
- * inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

5. FAIR VALUE MEASUREMENTS (continued)

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no material changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds - Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective investment trust fund - The fund is valued at the net asset value of the units of the collective investment trust. The net asset value is used as a practical expedient to estimate the fair value. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan were to have initiated a full redemption of the MetLife Series 25053 held by the Plan, the issuer reserved the right to require 60 days' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

6. RELATED-PARTY TRANSACTIONS

The Plan holds a collective investment trust fund (Reliance Trust Company Stable Value Fund MetLife Series 25053), for which the trustee is also the trustee of the Plan. Transactions with the trustee and its affiliates qualify as party-in-interest transactions; however, they are exempt from prohibited transaction rules under ERISA. Administrative expenses in the accompanying statement of changes in net assets available for benefits represents the aggregate of fees paid to ADP Inc. as third-party administrator and Morgan Stanley as investment advisor (see Note 1).

7. SUBSEQUENT EVENTS

ADP Retirement Trust Services, LLC was appointed the Plan's trustee effective January 1, 2025.

The Plan was amended effective January 1, 2025 to exclude from eligibility to participate in the Plan intercompany transfer employees from other countries who remain eligible to receive retirement benefits from their home countries.

The Plan was amended effective April 1, 2025 to modify the vesting schedule for employer contributions to 33 percent after one year of service, 66 percent after two years of service, and 100 percent after three years of service. Any participant with an account balance as of April 1, 2025 and who is not employed with the Company on such date, shall remain subject to the 5 year graded vesting schedule described in Note 1.

The SECURE 2.0 Act of 2022 contains numerous provisions that impact 401(k) plans. These provisions, which will continue to take effect in years subsequent to 2024, address various issues including financial incentives to contribute to a retirement plan, automatic enrollment, required minimum distribution age, contribution limits and part-time worker access.
