

**NOTE 1: Plan Description**

The following description of Astor Chocolate Corp. 401K Plan provides only general information. Further detailed information regarding the plan can be found in the published plan document provided by the plan.

**General**

The plan is a defined contribution plan that was established on January 1, 2001. The plan was established to provide retirement benefits for employees of the sponsor, Astor Chocolate Corp. and its affiliates, who are eligible to participate. This excludes those employees covered by collective bargaining agreement which provide retirement benefits. To be eligible, employees must have completed 90 days of service as defined in the plan document. The board of the Trustees is responsible for the oversight of the plan. The Plan administrator determines the appropriateness of the plan's investment offerings, monitors investment performance, and reports to the board of Trustees. It is subject to the provisions of the Employee Retirement Security Act of 1974 (ERISA).

**Contributions**

Each year participants may contribute up to 15% of pre-tax compensation as defined in the plan document. Participants who have attained age 50 during the plan are eligible to make catch-up contributions. The plan also accepts contribution from other qualified plans (including rollovers). The company contributes each year 50% of the first 6% of base compensation that a participant contributes to the Plan, once the employee has completed one year of service as defined in the plan document. The company may also decide each plan year whether to make discretionary non-elective contributions to the plan accounts. During the year ended December 31, 2024, the company made no non-elective contributions. Contributions are also subject to certain IRS limitations.

**Participant Accounts**

Each participant's account is credited with participant's contributions and the Company's matching contribution as well as allocations of plan earnings. Participants direct the investment of their contributions into various investment options offered by the plan. Each participant's account is charged for investment advisory fees, management fees, administration fees, and fees charged by the underlying investment; all either allocated proportionally or directly charged to the participant's account. In addition, transaction fees related to individual loan accounts and terminated employees have these fees

directly deducted from their accounts. The benefit, to which one is entitled, is the benefit that can be provided from the participant's vested portion of their account balance.

**Vesting**

Vesting in the account is immediate for the employee portion of the contribution and the earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after 5 years of credited service.

**Note Receivable from Participants**

Participants may borrow from their fund accounts an amount ranging from a minimum of \$500 up to a maximum of the lesser of one-half of the vested account balance or \$50,000 reduced by the highest outstanding loan balance in the account during the prior twelve-month period. Participants are permitted to have three outstanding loans from the Plan at any time. Loan terms range from one to five years; however, terms may exceed five years for the purchase of a primary residence. The loans are secured by the balance in the participants account and bear interest at a rate 1% above the Prime Rate as defined in the plan document.

**Payment of Benefits**

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants may receive in-service withdrawal of their vested account balance upon reaching 59.5 years of age. Hardship withdrawals are permitted under the Plan.

**Forfeited Accounts**

Forfeited accounts may first be used to pay administrative expenses and second to reduce future employer contributions. As of December 31, 2024 and 2023, Forfeited non-vested account balances totaled \$14,311 and \$11,731, respectively.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, as well as the disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Basis of Accounting and Income Recognition**

The accompanying financial statements are prepared on the accrual basis of accounting.

Interest income is recorded on the accrual basis and dividend income is recorded on the ex-dividend date; both shown as investment income receivable on the statement of net assets available for benefits if applicable.

**Investments**

The plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to buy an asset (or to transfer a liability) in an orderly transaction between market participants at the measurement date.

The investment alternatives mentioned in Note 1, are held and managed by ADP, LLC, and is the sole provider of the options. They provide administrative services for the plan's investments with its affiliate, Reliance Trust Company, providing custodial and certain reporting services. The options are all publicly traded mutual funds or money market accounts. They are valued daily based on the publicly available market price using a unit of value method.

Transactions are recorded as purchased or sold based on that day's market price. Values are adjusted as of the date the underlying publicly traded investment adjusts its value for dividends, interest, gains & losses, etc. The unit of account concept allows fees to be allocated to the individual accounts.

**Fair Value Measurement**

In accordance with authoritative guidance on fair value measurement the accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 input consists of unadjusted quoted prices in active markets for identical assets and has the highest priority.

Level 2 inputs consist of observable inputs other than quoted prices for identical assets.

Level 3 inputs have the lowest priority. They consist of unobservable inputs.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value.

The plan's investments are in pooled separate accounts and common collective trusts. Although valued daily, based on the publicly traded underlying value, the custodian and trustee use a unit of value concept which only closely approximates the actual fair market value. All mutual fund assets have been assigned valuations within level 1 and the collective common trusts at Level 2.

The accompanying schedules on pages 9-11 show detailed information.

**Plan Participant Loans**

The Plan provides for employee loans under certain circumstances. The interest rates on the loans are between 4.25% and 9.50% and are shown as participant loans receivable on the attached statement of net assets available for benefits, and as loan interest on the statement of changes in net assets available for benefits.

The plan document provides details on loan administration and eligibility. As per the plan document, delinquent loans are reclassified as distributions and are included as such in the statement of changes in net assets available for benefits, when applicable.

**NOTE 4: Party-in-Interest Transactions**

The investment options are all and managed by ADP, LLC and its affiliates, who serve as the as custodian of the plan assets and as a provider of administrative services. As such, they are considered parties in interest but are exempt from the prohibited transactions rules of ERISA.

**NOTE 5: Plan Amendments and Tax Status**

The plan was formed as a prototype plan through ADP, LLC as a volume submitter sponsor. An IRS letter dated July 8, 2014 is on file stating that the plan and related trust are designed in accordance with applicable sections of the code. The plan has been amended over the years with the most recent amendment dated April 20, 2015. As a volume submitter there is no need for additional IRS approval for the restatements.

Plan management has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, here are no uncertain positions taken or expected to be taken that would require recognition of an asset, liability, or disclosure in the financial statements.

NOTE 6: Risks and Uncertainties

The plan invests in various investment securities. These investments are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of these investments will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

In addition, although plan management believes that their valuations of the investments are appropriate, the use of different methodologies to value those assets may result in a different valuation.

NOTE 7: Form 5500

The plan, per government regulations, is required to file an annual report for employee benefit plans (Form 5500). The financial statements, per accounting guidelines, are to be filed on an accrual basis, while form 5500 is to be filed on a cash basis with certain non-accounting concepts.
