Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the MNR Industries, LLC 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. 1. DESCRIPTION OF THE PLAN

The following description of the MNR Industries, LLC 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, which was established by MNR Industries, LLC (the Company) effective October 1, 2005. The Board of Directors of the Company controls and manages the operation and administration of the Plan. The Plan covers substantially all employees who have completed one year of service, defined by the Plan as 1,000 hours during the initial eligibility measuring period or Plan year, and are age 21 or older. Participants will not be eligible to participate in the Plan if (i) their employment is governed by a union contract; or (ii) if they are a non-resident alien. Employees can enter the Plan on the first day of the month coinciding with or following the attainment of the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and was most recently amended with the adoption of a pre-approved plan effective July 1, 2022 (Note 5). Effective January 1, 2024, the Plan implemented the long-term part-time employee eligibility provision of the SECURE 2.0 Act. Under this provision, employees who attained age 21 and completed at least 500 hours of service in each of three consecutive years are eligible to make elective deferrals to the Plan effective January 1, 2024.

Participant Contributions

Participants may elect to defer up to 90% of their annual compensation, as defined in the Plan document, not to exceed the maximum allowable contribution under Section 402(g) of the Internal Revenue Code (the Code) limitations, which totaled \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions, subject to limitations imposed by the Code, which totaled \$7,500 for the years ended December 31, 2024 and 2023. Participant salary deferrals may be traditional 401(k) (pre-tax) or Roth 401(k) (after-tax). Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts.

Company Contributions

During the years ended December 31, 2024 and 2023, the Company made safe harbor 401(k) matching contributions on behalf of each eligible participant in the amount of 100% of the first 4% of compensation that a participant contributes to the Plan. For the years ended December 31, 2024 and 2023, Company safe harbor matching contributions, net of forfeitures applied, totaled \$395,255 and \$386,886, respectively. Additional profit sharing amounts may be contributed at the discretion of the Company's Board of Directors. During the years ended December 31, 2024 and 2023, the Company did not make a profit sharing contribution to the Plan.

Participant Accounts

Each participant’s account is participant-directed and is credited with the participant’s contributions and allocations of the Company’s contributions and Plan earnings (losses) and charged with benefit payments transaction fees related to distributions, and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting

Participants are immediately vested in their contributions and the Company’s safe harbor contributions plus actual earnings thereon. Vesting in the Company’s profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of service, as defined by the Plan, according to the following schedule:

Upon death or disability, a participant becomes 100% vested in the Company’s profit sharing contribution portion of their accounts plus actual earnings thereon.

Effective January 1, 2019, the Main Line Urgent Care Retirement Plan was merged into the Plan. Participants whose assets merged in from the Main Line Urgent Care Retirement Plan, who had 3 or more years of vesting service as of the merger date, remained 100% vested in any old or new profit-sharing contributions. All other participants whose assets merged in from the Main Line Urgent Care Retirement Plan will use the vesting schedule outlined above.

Forfeitures

The Plan’s forfeiture account totaled \$21 as of December 31, 2024 and 2023. Forfeitures may be used to reduce future Company contributions or pay Plan expenses. During the years ended December 31, 2024 and 2023, forfeitures used to reduce Company contributions totaled \$0 and \$117, respectively. No forfeitures were used to pay Plan expenses during the years ended December 31, 2024 and 2023.

Payment of Benefits

Upon termination of service due to death, disability or retirement (age 65), a participant (or their beneficiary in the event of death) is entitled to a distribution of their vested account balance in either a lump-sum amount or various installment options as provided by the Plan. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Amounts contributed on a before-tax basis may only be withdrawn by active participants upon demonstration of financial hardship, disability, or after the participant reaches the age of 59 ½. Distributions are subject to the applicable provisions of the Plan agreement. In all cases, certain income tax penalties may apply to withdrawals or distributions prior to age 59 ½. If a participant's account balance upon termination is less than \$5,000 and no distribution election is made by the participant, the balance will be distributed without participant consent. There were no net assets of the Plan allocated to accounts of participants who had elected to withdraw from the Plan that had not received such distributions as of December 31, 2024 and 2023. Effective May 1, 2025, the Plan implemented the emergency distribution provision of the SECURE 2.0 Act. This provision allows participants to take penalty-free emergency withdrawals from their accounts under certain circumstances.

Plan Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses relating to specific participant transactions (distributions) are charged directly to the participant's account. Investment related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of changes to net assets available for benefits during the reporting periods. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investments in assets that are exposed to risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities may occur in the near term and materially affect the amounts reported in the statements of net assets available for benefits.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Fair Value Measurement

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, defines fair value and establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Fair Value Measurement – cont’d.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Interests in registered investment companies: Valued at the closing price reported in the active market in which the funds are traded.

Interest in common/collective trust: Valued at the net asset value (NAV) determined by the issuer.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain instruments could result in a different fair value measurement at the reporting date. There have been no changes in methodologies used at December 31, 2024 and 2023.

ADP, Inc. serves as the Custodian for the Plan and is related to the Trustee. The Company provides the Plan with certain accounting and administrative services for which no fees are charged. All such transactions qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

5. INCOME TAX STATUS

Effective July 1, 2022, the Plan adopted a pre-approved plan, which received a favorable opinion letter from the Internal Revenue Service (IRS) dated October 6, 2020. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code. Therefore, no provision for income taxes has been included in the Plan's financial statements. As disclosed in Note 1, effective January 1, 2024, the Plan implemented the long-term part-time employee eligibility provision of the SECURE 2.0 Act. Although the Plan is operating in compliance with this provision, the pre-approved plan document reflecting this change has not yet been adopted. The Plan intends to adopt the required amendment by December 31, 2026, the deadline prescribed under the SECURE 2.0 Act.

ASC 740, *Income Taxes*, prescribes a recognition threshold and a measurement attribute for the financial statement recognition and measurement of tax positions taken or expected to be taken in a tax return as well as guidance on de-recognition, classification, interest and penalties and financial statement reporting disclosures. For these benefits to be recognized, a tax position must be more-likely-than-not to be sustained upon examination by taxing authorities. As the Plan is tax exempt and has no unrelated business income, the provisions of ASC 740 do not have an impact on the Plan's financial statements. The Plan recognizes interest and penalties accrued on any unrecognized tax exposures as a component of income tax expense. The Plan does not have any amounts accrued relating to interest and penalties as of December 31, 2024 and 2023.

The Plan is subject to routine audits by the IRS and Department of Labor; however, there are currently no audits for any periods in progress.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.
