To the Plan Administrator and Participants of

1. DESCRIPTION OF PLAN

The following description of the P.R.O.C.E.E.D. Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan, which was established on January 1, 1998 is subsequently restated and amended, is a defined contribution plan under Section 401(k) of the Internal Revenue Code ("IRC"), which covers substantially all employees, as defined, of P.R.O.C.E.E.D. Inc., and certain affiliates (the "Company") who have completed one year of eligible service, i.e. 1,000 hours of service during the first 12 months of employment, and are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions - Each year, eligible participants may elect to make pre-tax contribution to the Plan up to 85% of their compensation, as defined, not to exceed the maximum amount allowable under the IRC in any calendar year. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds, pooled separate accounts, common collective trust funds, and one guaranteed investment contract as investment options for participants. In addition, the Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 1% of eligible compensation, with their contributions invested in a designated balanced fund until changed by the participant.

A discretionary profit-sharing contribution may be contributed at the option of the employer. In order to receive a discretionary employer contribution, the participant must be actively employed as of the last day of the Plan year. The employer did not make a discretionary profit sharing or a discretionary matching contribution for the years ended December 31, 2024 and 2023.

Effective January 1, 2006, the employer contributes safe harbor contributions to the Plan equal to 100% of the participant's salary deferral contribution up to 6% of base compensation that a participant contributes to the Plan. If any employer matching contributions were contributed to the Plan before the Plan provided for Safe Harbor Matching Contributions, such contributions are subject to the vesting schedule below:

For the year ended December 31, 2024, the Company's Safe Harbor Matching Contributions amounted to \$229,320.

Participant Accounts - Each participant's account is credited with the participant's contribution, the Company's matching contribution, and an allocation of plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (continued)

Allocation of Investments

Participants make an election designating the proportion in which contributions are to be allocated among the specific assets, funds or other investments permitted under the Plan (participant-directed investment program). Participants may change their allocations and make transfers among funds.

Vesting - Participants are vested immediately in their voluntary contributions plus actual earnings thereon. Funds contributed by the Company and actual earnings thereon vest based on years of continuous service. A participant becomes 20% vested after two years of credited service and 20% per year for each additional year of credited service and is fully vested after six years of credited service.

Forfeited Accounts - Forfeited balances are made available first to reinstate previously forfeited account balances of former participants who have been reemployed by the Employer, second to reduce the Employer's matching contributions or to pay administrative expenses. As of December 31, 2024, forfeited non-vested accounts totaled \$4,192.

Notes Receivable from Participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expenses when they are incurred.

Payment of Benefits - On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account, or annual installments over a ten-year period. For termination of service for other reasons, a participant may receive the value of the vested interest in their account as a lump-sum distribution.

Hardship and in-service withdrawals are available pursuant to specific guidelines as set forth in the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates - The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition - The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the valuation policies utilizing information provided by the investment advisors, custodians, and other professionals. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits - Benefit payments to participants are recorded upon distribution.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events Evaluation Date - In accordance with FASB ASC 855-10-50. "Subsequent Events," the Plan has evaluated subsequent events and transactions and determined there were no significant events to report through October 7, 2025, which is the date the financial statements were available to be issued.

3. INVESTMENT CERTIFICATION

The Plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the U.S. Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Accordingly, certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and the supplemental schedule, including investments and notes receivable from participants held at December 31, 2024, and net appreciation in fair value of investments, interest and dividends, and contract administrative fees for the years ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Reliance Trust Company (the custodian of the Plan).

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification 820 (ASC 820), "Fair Value Measurements and Disclosures," establishes a framework for measuring fair value. The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1 Level 1 assets and liabilities are those that input to the valuation methodology unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access. All investments recorded at fair value are within Level 1 of the fair value hierarchy.

Level 2 Level 2 asset and liability fair values are based on observable inputs that include: quoted market prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Level 3 assets and liabilities are inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

4. FAIR VALUE MEASUREMENTS (continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual Funds: Valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. These are classified as a level 1 investment within the fair value hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

During 2024, the Plan's investments are held with Reliance Trust Company, the custodian of the Plan, thus a party-in-interest.

There were no reportable transactions or non-exempt transactions with known parties-in-interest as defined in ERISA during the 2024 plan year. Total fees paid by the Plan amounted to \$29,517 for the year ended December 31, 2024.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

7. QUALIFIED TAX STATUS

The Internal Revenue Service has determined and informed the Employer by a letter dated March 31, 2008, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has since been amended; however, the Employer and Plan administrator believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been recorded.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the taxing authorities. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
