INDEPENDENT AUDITORS' REPORT

To the Plan Administrator
BrightFarms, Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C)

We have performed audits of the accompanying financial statements of BrightFarms, Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan:

The following brief description of the BrightFarms, Inc. (the "Company") 401(k) Profit Sharing Plan & Trust (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan covers substantially all employees of the Company who are 21 years or older and have completed one month of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Management oversees governance of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Management.

Contributions

Participant Contributions

Employees may elect to reduce their salaries and contribute up to 90% of their annual compensation, subject to limits determined by the Internal Revenue Code (the "Code").

Participant Catch-Up Contributions

Participants age 50 or older may elect to make additional salary deferral contributions, subject to limits determined by the Internal Revenue Code.

Participant Roth Contributions

Participants may elect to make an after-tax contribution to a Roth Contributions Account. Such Roth elective deferrals are salary deferral contributions that are made in lieu of all or a portion of the participant's pre-tax salary deferral contribution.

Employer Contributions

The Company matches an amount equal to 100% of employee elective deferral contributions, up to 3% of compensation, plus 50% of each dollar contributed that is between 3% and 5% of eligible compensation, for a total matching contribution of up to 4% of eligible compensation, for all employees. Additional amounts may be contributed at the discretion of the Company's Board of Directors. The total annual contributions may not exceed the maximum amount deductible for income tax purposes.

Profit Sharing Contributions

The Company may contribute to each eligible participant's account, a discretionary profit sharing contribution equal to a percentage of each participant's compensation divided by the total compensation of all participants also eligible to share in the contribution. Employees are eligible for profit sharing contributions after completing one year of service.

Notes Receivable

Participants may borrow against their vested account balances. The minimum borrowing amount is \$1,000 and may not exceed the lesser of \$50,000 or fifty percent of the participant's vested benefits. The interest rate on outstanding loans is the prime rate plus 1% and ranges between 4.25% and 9.50%. Loans are repayable within five years from the date of the loan, unless the loan is for the purchase of a participant's primary residency. Principal and interest is paid ratably through payroll deductions.

Note 1 - Description of Plan (Continued):

Participant Accounts

Each participant's account is credited with the participant's contribution plus an allocation of any additional contributions made by the Company and Plan earnings. In addition, participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their voluntary contributions plus actual earnings thereon, as well as employer safe harbor contributions. Vesting in the discretionary profit sharing contributions plus actual earnings thereon is based on years of continuous service. A participant becomes fully vested in profit sharing contributions upon six years of credited service. Any participant who attains normal retirement age, becomes disabled, or dies becomes fully vested regardless of length of service.

Investment Options

Upon enrollment in the plan, a participant may direct contributions among various investment choices. Participants may change their investment options any business day during the plan year.

Payment of Benefits

On termination of service due to death, disability, retirement, or any other reasons a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants may additionally elect to receive funds in the form of installment payments, partial payments requested from time to time, or through an annuity.

Forfeited Accounts

If participants terminate service prior to being fully vested in the employer's contribution account, the non-vested amount is forfeited. The balance in the forfeited non-vested account can be used to pay administrative expenses or reduce any future employer contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11. The Plan used \$1,421 to reduce employer contributions for the year ended December 31, 2024. During the year ended December 31, 2024, no forfeitures were used to pay fees.

Death Benefits

Upon the death of a participant, the amount held for the benefit of that participant shall be paid to the participant's designated beneficiary.

Note 2 - Summary of Significant Accounting Policies:

Accounting Method

The accompanying financial statements have been prepared in accordance with the accrual basis of accounting.

Investment Valuation and Income Recognition

Shares of mutual funds are stated at fair value based on quoted market prices which represent the net asset value of the shares held by the Plan at year-end. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade date basis. Gains and losses are based on an average cost basis. Dividends are recorded on the ex-dividend date. Net depreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Note 2 - Summary of Significant Accounting Policies (Continued):

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which participant compensation is earned.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Administrative fees, including fees related to the administration of notes receivable from participants and investment-related expenses are included in administrative expenses and are charged directly to the participant's account. The Company absorbs certain costs of Plan administration.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts of net assets available for benefits and charges therein. Accordingly, actual results may differ from those estimates.

Other

The Plan presents in the statement of changes in net assets available for benefits the net appreciation (depreciation) in the fair value of its investments, which consists of the realized gains or losses and the unrealized appreciation (depreciation) on those investments.

Note 3 - Fair Value Measurements:

The "Fair Value Measurements and Disclosures" Topic 820 (ASC 820) of the FASB Accounting Standards Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under the "Fair Value Measurements" Topic 820 of the FASB Accounting Standards Codification are described below:

Level 1: Quoted prices (unadjusted) in active markets that are accessible at the measurement date for assets or liabilities.

Level 2: Other inputs that are observable directly or indirectly, such as quoted prices for similar assets and liabilities or market corroborated inputs.

Level 3: Unobservable inputs are used when little or no market data is available, which requires the Company to develop its own assumptions about how market participants would value the assets or liabilities.

Note 3 - Fair Value Measurements (Continued):

In determining the fair value, the Company utilizes valuation techniques that maximize the use of observable inputs and minimize the use of unobservable inputs to the extent possible in its assessment of fair value.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at fair value on quoted market prices which represent the net asset value of the shares held by the plan at year-end.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective future fair values. Furthermore, while the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

Note 4 - Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested.

Note 5 - Tax Status:

The Plan adopted the Prototype Non-Standardized Profit Sharing Plan With CODA, which received a favorable opinion from the Internal Revenue Service (IRS) on October 6, 2020 which stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended and restated since receiving the determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, the Plan administrator believes that the Plan remains qualified and tax-exempt as of the financial statement date.

Note 5 - Tax Status (Continued):

Accounting principles generally accepted in the United States of America (“GAAP”) requires management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for tax periods in progress.

The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2022.

Note 6 - Information Certified by Plan’s Trustee:

The Plan’s assets, which consist of mutual funds, are held by the Trustee of the Plan.

The investment information presented in the accompanying statements of net assets available for benefits, statement of changes in net assets available for benefits, and supplemental schedule has been derived from information certified as complete and accurate by Reliance Trust Company as of December 31, 2024 and 2023 as permitted by the election made by the plan administrator under 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

Note 8 - Risks and Uncertainties:

The Plan invests in mutual funds. In general, these investments are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statement of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

Note 9 - Missed Contributions:

During 2024, the Plan sponsor failed to contribute an employer match for one pay period to an employee due to a new company not being set up correctly resulting in a missed employer match of \$162. Upon discovery of the error, the plan sponsor made a corrective contribution to the plan including lost earnings of \$37.

During 2023, the Plan sponsor failed to withhold employee deferrals on bonus amounts resulting in multiple employees having a missed deferrals of \$806 as well as a corresponding employer match contribution of \$696. Upon discovery of the error in 2024, the plan sponsor made corrective contribution to the plan including lost earnings of \$281.

Note 10 - Subsequent Events:

The Company has evaluated all events subsequent to the statement of net assets available for benefits date of December 31, 2024, through October 7, 2025, which is the date these financial statements were available to be issued, and have determined that, except as set forth below, there are no subsequent events that need to be recorded or that are required to be disclosed under the "Subsequent Events" topic of the FASB Accounting Standards Codification.

Effective January 1, 2025, the Plan definition of compensation was amended to exclude bonuses and car allowances from eligible compensation.
