We have performed an audits of the financial statements of Printful, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Note 1. Description of the Plan

The following description of Printful, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General - The Plan is a defined contribution plan and covering substantially all employees, except for certain employee classes of Printful, Inc. (the “Company”). The Plan document and related provisions were adopted effective January 1, 2021 and restated effective June 17, 2022 for Internal Revenue Service Cycle 3 for the qualified pre-approved 401(k) plan documents. Employees may participate in the Plan after obtaining age 18. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2024, the Plan was amended to allow other employers to adopt its provisions. Pursuant to this amendment, Snow Commerce LLC adopted the Plan as a participating employer effective January 1, 2024. All eligible employees of Snow Commerce LLC 401(k) Plan became eligible to participate in the Plan in accordance with its terms and conditions as of the adoption date. See Note 12 for Plan Amendments.

Contributions - Each year, participants may contribute a percentage between 1% and 90% of their pretax or after-tax compensation, as defined by the Plan, not to exceed the annual limits as defined by the Internal Revenue Code. Participants who have attained the age of 50 before the end of the year are eligible to make catch-up contributions. Participants may contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options and participants may change their allocations among the various investment options at any time.

The Employer makes a safe harbor matching contribution equal to 100% of participants’ salary deferrals that do not exceed 4% of participants’ compensation. This safe harbor matching is 100% vested.

Vesting - Plan participants are always 100% vested in rollover contributions, employee contributions, safe harbor matching contributions and any earnings thereon. Discretionary matching contributions and any earnings thereon will be vested in accordance with the following schedule:

Participant Accounts - Each participant's account is credited with the participant's contributions, employer matching contributions, rollover contributions and earnings, and is charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investments - Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds and common collective trust funds as investment options for participants.

Payment of Benefits - Payment of benefits from a participant's account may be made only for the following reasons: termination of employment, financial hardship, in-service at 59 1/2, retirement, death or disability. Upon occurrence of one of these events and upon election of the participant, the Plan will distribute to the participant 100% of the participant's vested account balance. A participant may receive an installments or lump sum amount equal to the value to the participant's vested interest in his or her account. Also, Participant may partial withdraw his or her Rollover account balance. The Plan Sponsor may elect to distribute funds to terminated participants through the mandatory involuntary cash-out provision, for any balances less than \$5,000 directly to the participant.

Forfeitures - Forfeitures represent the non-vested portion of employer contributions that are forfeited by participants upon termination of employment before becoming fully vested. In accordance with the provisions of the Plan, forfeitures may be used to reduce future employer contributions, pay plan expenses, or be reallocated to participants. During the years ended December 31, 2024 and 2023 respectively, forfeitures in the amount of \$24,064 and \$14,904 were used to reduce employer contributions or pay plan expenses. As of December 31, 2024 and 2023 the balance of unallocated forfeitures available for future use was \$1,392 and \$10, respectively.

Recordkeeping and Investment Expenses - The Plan's fees and expenses are paid either by the Plan or the Plan Sponsor as provided by the Plan document.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting - The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Payment of Benefits - Benefits paid to participants are recorded when paid.

Use of Estimates - The preparation of the Plan's financial statements in conformity with accounting principles generally accepted in the United States requires that the Plan administrator make estimates and use assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates. The Plan administrator is not aware of any condition or event that is likely to severely affect its estimates in the near-term.

Investment Valuation and Income Recognition - The Plan's investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date. See Note 4 for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of net appreciation in fair market value of investments for such investments.

Contributions

Contributions from Plan participants and Employer matching contributions are recorded in the year in which the employee contributions are withheld.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent events

The Plan has evaluated subsequent events through September 17, 2025, the date the financial statements were available to be issued.

Note 3. Information Prepared by and Certified by the Trustee

As permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA, and as instructed by the Plan administrator, no audit procedures have been performed on certain information certified as complete and accurate by the Reliance Trust Company, ("the Trustee"), except to compare such information to the information included in the accompanying financial statements and supplemental schedule. Information certified by the Trustee includes investments and notes receivable from participants included in the Statements of Net Assets Available for Benefits at December 31, 2024 and 2023, investment related income and interest on notes receivable from participants as included in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and investments included in the Schedule of Assets (Held at End of Year).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by the observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Fair value measurements are classified within the valuation hierarchy based on the lowest level of any input that is significant to the fair value measurement.

The valuation methodology for the Plan’s assets are as follows at December 31, 2024 and 2023:

Mutual Funds – Mutual funds are registered investment companies that pool the funds of multiple investors into a portfolio. The fund offers shares of the portfolio, which an investor may redeem for current value (NAV, or net asset value) of the fund’s assets through a public market.

Common collective trust funds – The value of a fund unit will be based on the net asset value as a practical expedient (“NAV”) per unit of each of the portfolios in which assets of a fund are invested. The NAV per unit is determined by the portfolio and equals the total value of its assets, less its liabilities, divided by the number of its outstanding units. Units are only valued as of the close of regular trading on the New York Stock Exchange (“NYSE”) each day and the exchange is open for trading.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as an international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7. Income Tax Status

The Plan has timely adopted a restated, via a non-standardized adoption agreement, pre-approved plan. The plan was restated on June 17, 2022. The pre-approved plan has received an opinion letter from the IRS dated October 6, 2020, whereby the IRS stated that the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). While the Plan cannot rely on the pre-approved 's opinion letter, the Plan administrator believes that the Plan has been operated in compliance with the applicable requirements of the IRC and, therefore, believes that the plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be substantiated upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become 100% vested in their accounts.

Note 9. Exempt Party-In-Interest Transactions

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of distributions to participants are charged directly to the participant’s account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Fees paid by the Plan to ADP Retirement Services, Inc. for administrative services amounted to \$7,214 and Merrill, Lynch, Pierce, Fenner and Smith for investment advisory services amounted to \$21,472 for the year ended December 31, 2024.

Note 10. Concentrations in Credit Risk

Plan assets are mostly invested with two investment management companies. Such investments are subject to credit and market risk associated with (1) the credit worthiness of the investment management company, (2) the credit worthiness of underlying issuers, and (3) fluctuations in market value inherent with changes in economic conditions.

Note 11. Prohibited Transactions

The Plan Sponsor did not remit to the Plan’s trust certain employee contributions totaling \$205,513 for the year ended December 31, 2024 within the period prescribed by the Department of Labor regulations. Delays in remitting contributions to the trust were due to administrative errors. Plan management has not made the necessary corrections for these late deposits, including calculating and remitting the lost earnings to affected participants accounts in accordance with the U.S. Department of Labor and/or Internal Revenue Service guidelines as of December 31, 2024.

Note 13. Plan Amendment
