Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of PCC Medical Holdings LLC 401K Plan, (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) Audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from Reliance Trust Company, a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

Basis for Opinion

NOTE 1 – DESCRIPTION OF PLAN

The following description of the PCC Medical Holdings LLC 401K Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The PCC Medical Holdings LLC 401K Plan is a 401(k) deferred compensation plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) as amended, and is administered by Reliance Trust Company (the “Certifying Entity”). The Plan was established effective January 1, 2006.

The Owner and Trustee of the Plan, William Steele, is responsible for oversight of the Plan. Michael DeGenova of Jaffe Tilchin Wealth Management, Inc., is responsible to determine the appropriateness of the Plan’s investment offerings, monitors investment performance, and reports to the Owner of the Company, William Steele.

Eligibility

All employees of PCC Medical Holdings, LLC. (the “Company”) and any participating affiliates, if applicable except employees covered by a collective bargaining agreement with the employer and employees not required to be taken into account for nondiscrimination testing purposes under Code Section 410(b)(6)(C) but only during the Code Section 410(b)(C) transition period are eligible to participate in the Plan. In order to participate in the Plan, you must be at least 21 years of age and have completed 3 months of service. Participants will receive credit for one month of service for each month in which you complete one hour of service.

Contributions

Participants may elect to defer a percentage of their eligible compensation into the Plan after they have satisfied the Plan’s eligibility requirements. The percentage of eligible compensation elected by the participant will be withheld from each payroll and contributed to an account in the Plan on the participants’ behalf. For pre-tax contributions being withheld from a participant’s compensation, the percentage deferred is subject to an annual limit of the lesser of 100% of eligible compensation or \$23,000 (the maximum pre-tax contribution for the year ended December 31, 2024).

Participants are eligible to make two kinds of elective deferrals, pre-tax elective deferrals and/or Roth elective deferrals.

The Plan provides that participants who are projected to be age 50 or older by the end of the calendar year and who are making deferral contributions to the Plan may also make a catch-up contribution. Catch-up contributions are subject to certain limitations established by the Internal Revenue Service. The maximum pre-tax catch-up contribution for the year ended December 31, 2024 was \$7,500.

The Company will make a matching contribution equal to 50% of the participant’s elective deferrals. The Company will not match elective deferrals that exceed 3% of the participant’s eligible earnings.

Participant Accounts

The assets in the Plan are invested in available investment options and a separate account is established for each participant who receives and/or makes a contribution. The value of the participants account is updated each business day to reflect any contributions, exchanges between investment options, investment earnings or losses for each investment option and withdrawals..

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Participant Loans

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account. The loans bear interest at a rate of Prime Rate plus 2%. As of December 31, 2024 and 2023, interest rates on outstanding loans range from 5.25% to 10.50%, and maturity dates range from January 16, 2025 to September 25, 2029.

Vesting

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after three years of credited service. Participants are vested in profit sharing contributions under the following schedule:

In addition, a participant is immediately 100% vested in any amount which has been transferred or rolled over into the Plan from another qualified employee benefit plan.

Payment of Benefits

A participant can request a distribution due to disability, retirement or termination of employment from their employer or related employer. The beneficiary or beneficiaries of a participant may request a distribution of the participants vested account balance in the event of the participant's death. The value of a participant account balance will continue to increase or decrease, as appropriate, based on the investment returns until it is distributed.

A participant may defer receipt of their distribution until a later date. However, a participant cannot postpone it if their account balance is \$5,000 or less in which case the Plan administrator will direct the Certifying Entity that any amount exceeding \$1,000 be distributed to an Individual Retirement Account (IRA) for their benefit. If a participant vested account balance is \$1,000 or less, the Plan administrator will direct the Trustee to distribute it to the participant as a lump sum distribution without the consent of the participant. Prior to such distribution, the participant still has the right to request that the amount be distributed directly to them in the form of a lump sum payment or to request that it be rolled-over to a different IRA provider or another retirement plan eligible to receive rollover contributions.

Payment of Benefits (Continued)

A participant may generally withdraw funds from any of their accounts under the Plan prior to their retirement for any of the following reasons:

- Severance of employment
- Death
- Disability
- Attained age of 59 ½
- Plan termination
- Hardship

In addition, a participant may withdraw their rollover contribution accounts at any time subject to IRS limitations.

Forfeited Accounts

Forfeitures are applied to reduce the Company's contribution at the end of the next plan year during which the participant has received distribution of their vested interest. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$12,714 and \$13,722 respectively. These accounts will be used to reduce future employer contributions. During December 31, 2024 and 2023, employer contributions were reduced by \$27,439 and \$9,527 from forfeited nonvested accounts, respectively.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for investments in fully benefit-responsive investment contracts. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fully benefit-responsive investment contracts are reported at contract value because contract value is the amount that participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan does not invest in a fully benefit-responsive investment contract. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes receivable from participants / Participant loans

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Plan administrative services, such as legal, consulting, audit, accounting, trustee, and recordkeeping services, may be required to administer the Plan. The cost for these services may be paid by the Company or from the Plan, or both. Administrative fees for certain services or transactions participants request may be charged directly to the participant's account.

NOTE 3 – PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan subject to the provisions set forth in ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

NOTE 4– RISKS AND UNCERTAINTIES

The Plan invest in various investment securities. These investments are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of such investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 5 – RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the Certifying Entity and qualifies as a party-in-interest. All investments and investment activity as presented in the accompanying financial statements and supplemental schedule are considered transactions with a party-in-interest according to the Department of Labor guidelines.

Certain employees of the Plan had outstanding loans (notes receivable from participants) with the Plan as of December 31, 2024 and 2023. These loans are considered party-in-interest transactions according to DOL guidelines. Total notes receivable from participants as of December 31, 2024 and 2023 were \$37,871 and \$16,250, respectively. Interest income on participant loans amounted to \$1,662 and 1,231 for the years ended December, 31, 2024 and 2023, respectively.

NOTE 6 – INFORMATION CERTIFIED BY THE CERTIFYING ENTITY

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by Reliance Trust Company, the Certifying Entity of the Plan, except for comparing such information certified by the Certifying Entity to information in the Plan's financial statements and supplemental schedule of assets held for investment purposes at the end of the Plan year.

NOTE 7 – FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

ASC 820, *Fair Value Measurements*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

ASC 820 establishes a three-level valuation hierarchy for measurement and disclosure of fair value. The valuation hierarchy is based upon the transparency of inputs used to measure fair value. The three levels are as follows:

Level 1 – asset value is based on actual quoted prices in active markets for identical securities (mark-to-market).

Level 2 – other significant observable inputs are used to arrive at fair value (including yield, quality, coupon rate, maturity, issue type, quoted prices for similar securities, prepayment speeds, trading characteristics, etc.).

Level 3 – significant unobservable inputs (including management's own assumptions in determining the fair value of investments).

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

- *Registered Investment Company*: valued at the quoted net asset value of share held by the Plan at the end of the Plan year.
- *Collective Investment Trust*: the fair value of conventional investment contracts is determined using a discounted cash flow methodology where the individual contract cash flows are discounted at the prevailing interpolated yield curve rate as of year-end. Individual assets of the synthetic investment contract are generally valued at representative quoted market prices.

The following information included in the accompanying financial statements and supplemental schedules was obtained from data that has been provided and certified to as complete and accurate by the trustees.

NOTE 8 – INCOME TAXES

The Plan is a type of qualified retirement plan commonly referred to as a 401(k) Plan. The sponsor received a favorable determination letter, in which the Internal Revenue Service states that the Plan, as then designated, was in compliance with applicable requirements of the Internal Revenue Code (the "IRC").

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 9 – SUBSEQUENT EVENT

The Plan's management has evaluated subsequent events through September 30, 2025, the date which the financial statements were available to be issued. No material events have occurred since December 31, 2024 that require recognition or disclosure in the financial statements.
