NOTE 1 - DESCRIPTION OF PLAN

As of February 29, 2024, the Plan was amended to change its name from Waste-Away Group, Limited Employees' 401(k) Plan and Trust to Himes Holdings, Inc. 401(k) Plan and Trust. The following description of the Himes Holdings, Inc. 401(k) Plan and Trust (the "Plan") provides only general information. Plan participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan was established May 1, 1987 and provides eligible employees of Himes Holdings, Inc. and entities affiliated through common ownership (Borden Waste-Away Service, Inc., Himco Waste-Away Service, Inc., Integra Certified Document Destruction LLC, Mechanic, Inc., Recycling Works, Inc., Pine Cone Recycling, LLC, Superior Containers, Inc., Site Works Municipal Solutions, LLC and Site Works Services, LLC) (collectively referred to as the "Company" or the "Employer") the opportunity to make regular and systematic contributions through salary reductions. Eligible employees are those who are not contract or leased employees, not a resident of Puerto Rico, and those who have completed 60 days of service, regardless of age. As of February 29, 2024, the Plan was amended to only cover employees of Himes Holdings, Inc., Superior Containers, Inc., Site Works Municipal Solution, LLC and Site Works Services, LLC. The Plan is subject to Section 401(k) of the Internal Revenue Code ("IRC") and the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") as amended.

Participation and Contributions: All full-time employees of the Company who have completed the service requirement may participate in the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation which will be automatically increased each year by 1% increments up to a maximum of 10% of eligible compensation. Effective September 1, 2023, the automatic deferral rate is set at 6% of eligible compensation to be automatically increase each year by 2% increments up to a maximum of 20% of eligible compensation. Approximately 30 days prior to enrollment in the Plan, participants are provided with an auto-enrollment notice inclusive of default investment options. A participant may elect to opt out of the auto-enrollment or the automatic increase provisions of the Plan at any time by making an affirmative election not to participate in the Plan or to participate at a different deferral rate. Each eligible employee who participates in the Plan may contribute any whole percentage of their compensation per payroll period, up to 100% of the participant's compensation. Employer matching contributions for non-union participants are discretionary and are determined annually by the Company's Board of Directors. No discretionary matching contribution was made for the 2024 plan year. Employer matching contributions for union participants are based on the applicable collective bargaining agreement. Employer matching contributions, if any, are allocated to non-union participants' accounts based on a percentage of the participants' salary reductions and to union participants' accounts based on hours paid.

Participant Accounts: Each participant's account is credited with the participant's contribution and an allocation of the Employer contributions, if any, and Plan earnings, and is charged with withdrawals and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting: Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are fully vested in the remainder of their accounts after three years of credited service.

Payment of Benefits: On termination of service due to death, disability, or retirement, the normal form of payment to a participant is a lump-sum equal to the value of the participant's vested interest in his or her account.

Withdrawals: Withdrawals are not permitted before the age of 59 ½ except in the event of death, hardship or termination of employment.

Retirement, Death and Disability: A participant or beneficiary is entitled to 100% of their account balance upon retirement, death or disability.

Forfeited Accounts: The non-vested portion of terminated participant accounts plus earnings thereon are forfeited and can be used by the Plan to reduce the amount of future Employer contributions to the Plan and pay Plan expenses. As of December 31, 2024 and 2023, there were \$3,089 and \$4,763 in forfeited non-vested accounts, respectively. The Company used none of the forfeitures to reduce Employer contributions during the year ended December 31, 2024.

Notes Receivable from Participants: The Plan allows participants to borrow funds against their account balance limited to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prevailing rate at the time of the issuance of the loan. Principal and interest are paid through payroll deductions.

Administrative and Investment Management Expenses: Loan origination fees associated with notes receivable from participants and the Plan's record keeping and trustee fees are paid by the Plan and are reflected in the financial statements as administrative expenses of the Plan. Investment management fees are charged to the Plan as a reduction of investment return and included in the investment income reported by the Plan. All other expenses of the Plan are paid by the Company and are excluded from these financial statements.

Investment Options: Each participant can direct their contributions into any of the investment options available under the Plan.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition: The Plan's investments are reported at fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions: Contributions from participants are recorded in the period the Employer withholds payroll deductions from Plan participants. The Employer's discretionary contributions, if any, are accrued at the end of the Plan year based on the amount the Board of Directors determines is to be contributed to the Plan.

Notes Receivable from Participants: Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest, with no allowance for credit losses, as repayments of principal and interest are received through payroll deductions and the notes are collateralized by the participants' account balances.

Payment of Benefits: Benefits are recorded when paid.

Use of Estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures, and actual results may differ from these estimates.

Risks and Uncertainties: The Plan provides for various investments options. The underlying investments are exposed to various risks, such as interest rate, market, liquidity and credit risks. Due to the level of risk associated with certain investments and the sensitivity of certain fair value estimates to changes in valuation assumptions, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 3 - CERTIFIED INVESTMENTS AND NOTES RECEIVABLE FROM PARTICIPANTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by T. Rowe Price Trust Company (The trustee of the Plan).

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is the price that would be received by the Plan for an asset or paid by the Plan to transfer a liability (an exit price) in an orderly transaction between market participants on the measurement date in the Plan's principal or most advantageous market for the asset or liability. Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs.

The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

Collective trusts – The fair value of interests in the collective trusts are based upon the net asset values per unit as reported by the fund managers of such funds after an adjustment to reflect all investments at fair value, including direct and indirect interests in fully benefit-responsive contracts, as reported in the audited financial statements of the fund as of the Plan’s financial statement date. The collective trusts provides for daily redemptions by the Plan, with no advance notification requirement or redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value for certain financial instruments could result in a different fair value measurement at the reporting date.

* Investments measured at fair value using net asset value per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the hierarchy tables for such investments are intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statement of net assets available for benefits.

NOTE 5 - RIGHTS UPON PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA and its related regulations. In the event of plan termination, participants will become fully vested in their accounts. As a part of the amendment on February 29, 2024 discussed in Note 1, there was a partial Plan termination. Approximately 70% of participants were terminated due to the sale of companies affiliated through common ownership. The affected employees became fully vested upon their distribution.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under the Department of Labor's Rules and Regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employer and certain others. The Plan holds funds managed by affiliates of T. Rowe Price, the trustee of the Plan; therefore, these transactions and the Plan's payment of trustee fees and investment management fees to the trustee and affiliates qualify as party-in-interest transactions. The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it received no compensation. Certain fees are paid by the Company for administration of the Plan and are excluded from these financial statements. Notes receivable from participants are also considered party-in-interest transactions.

Investment management expenses paid by the Plan to Lincoln Financial Advisors Corp. which are reflected as a reduction of the Plan's investment return, qualify as party-in-interest transactions.

NOTE 7 - INCOME TAX STATUS

The Internal Revenue Service issued an opinion letter dated August 19, 2020, indicating that the prototype plan adopted by the Plan, as then designed, was in compliance with applicable requirements of the IRC. Although the Plan has been amended from the original prototype document, the Plan administrator believes the Plan is currently being operated in accordance with the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
