Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Salon Services Pro Inc. 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Salon Services Pro Inc. 401k Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

NOTE A.--DESCRIPTION OF PLAN

The following description of the Salon Services Pro Inc. (Company or Plan Sponsor) 401k Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution 401(k) plan originally established by the Company effective February 1, 1994. The Plan was most recently restated July 31, 2022 as part of the Cycle 3 restatement requirements, and most recently amended August 1, 2022 to change the Plan name to Salon Services Pro Inc. 401k Plan and September 1, 2022 to change the address. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). An eligible employee is any person employed by the Company, excluding nonresident aliens and residents of Puerto Rico. An employee becomes eligible to participate in the Plan after completing one year of service. The entry date is the first day of each month following completion of eligibility requirements. See also Note J.

Contributions: The Plan is funded by eligible participant elective deferrals which may range from 1% to 75% of eligible compensation, safe harbor matching contributions and discretionary non-elective contributions. Eligible participants are automatically enrolled in the Plan with a deferral amount of 1% of their eligible compensation. The safe harbor match is the sum of 100% of the first 4% of participant deferrals. The Company has not historically made any discretionary non-elective contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Also, all participants who are eligible to make elective deferral contributions may designate all or any portion of their future deferrals as Roth elective deferral contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans. In-plan Roth rollover contributions are not allowed. Contributions are subject to certain limitations. See also Note J.

Participant Accounts: Each participant's account is credited with the participant's contribution, an allocation of any Company contributions, an allocation of plan earnings (losses), and charged with certain administrative expenses. Allocations are based on participant compensation, account balances, or specific participant transactions, as applicable, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the vested portion of the participant's account.

Vesting: Participants are immediately vested in elective deferrals, safe harbor match, and rollover contributions plus actual earnings thereon. Vesting in employer discretionary contributions that are not safe harbor match is based on a five-year graded vesting schedule in which the participant is 100% vested after five years of service at a rate of 20% per year after year one. Participants will be 100% vested upon death or disability.

NOTE A.--DESCRIPTION OF PLAN (Continued)

Retirement: The normal retirement date is the date the participant turns 65. Early retirement is permitted once a participant reaches age 55.

Payment of Benefits: On termination of service due to disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, partial withdrawals, or installments over a certain period of time. Upon death of a participant, payment made to a beneficiary will be paid in a lump sum. If the beneficiary is a spouse, the beneficiary may elect to roll over the balance to another qualified plan or IRA.

For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution or may continue to participate in the plan investments and benefits will be provided upon retirement or death. For terminated participants, if the balance of the vested accounts is \$1,000 or less excluding any rollover contributions, payment may be made in a lump-sum without the participant's consent. If such balance is less than \$5,000 but greater than \$1,000, without other election, it will automatically be rolled over into an IRA established by an IRA provider selected by the Company. Effective January 1, 2024, as part of the SECURE 2.0 Act, the cash out limit was increased from \$5,000 to \$7,000. In-service distributions at age 59½, qualified reservist distributions, and certain hardship distributions may be made in accordance with Plan provisions.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are issued by the Plan and secured by the balance in the participants account. Loan transactions are treated as a transfer to (from) the investment fund from (to) the loan fund. The loans are to bear a reasonable rate of interest, further defined as prime plus 2%. Only one outstanding loan is permitted per person. All loans must be repaid within a period of five years, unless the loan is used to purchase a principal residence, in which case, the loan must be repaid within thirty years. Principal and interest are paid through payroll deductions.

Investment Options: Participants are allowed to direct their contributions and account balances in a variety of investment options among the investments offered under the Plan. The Plan Sponsor periodically reviews the investment options available to participants and changes them as warranted. Participants may change their investments at any time.

Plan Expenses: Expenses of maintaining the Plan may be paid by the Company or the Plan. Certain expenses maintaining the Plan are paid for directly by the Company and are excluded from these financial statements. Certain fees such as for distributions and notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses including 12b-1 fees and revenue sharing fees are deducted from each funds' earnings and included in net appreciation (depreciation) in fair value of investments.

Forfeitures: Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and shall be used to restore forfeitures or reduce Company contributions or pay plan expenses. As of December 31, 2024, and 2023, forfeited non-vested accounts totaled \$17,489 and \$13,781, respectively. For the year ended December 31, 2024, \$2,492 was forfeited from participant accounts, and \$0 of forfeitures were utilized to offset employer contributions.

NOTE B.--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the financial statements and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's committee determines the Plan's valuation utilizing information provided by the investment advisor and trustee and custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits: Benefits are recorded when paid.

NOTE C.--CERTIFIED INFORMATION

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, dividend income, and interest income on notes receivable from participants, for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company, the trustee and custodian of the Plan.

NOTE D.--FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets;
 - Quoted prices for identical or similar assets or liabilities in inactive markets;
 - Inputs other than quoted prices that are observable for the asset or liability;
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3 Inputs to the valuation methodology are unobservable and significant to fair value measurement.

NOTE D.--FAIR VALUE MEASUREMENTS (Continued)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E.--RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds managed by the trustee and custodian, Reliance Trust Company; therefore, these transactions qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan.

NOTE F.--TAX STATUS

The Plan was amended and restated effective July 31, 2022 and adopted a non-standardized pre-approved profit sharing/money purchase plan with cash or deferral arrangement, which received a favorable opinion letter from the Internal Revenue Service (IRS) on October 6, 2020, which stated that the Plan is designed in accordance with applicable sections of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan has been amended since the date of this determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination.

The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE G.--PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provision of ERISA. In the event of Plan termination, the respective accounts of the participants under the Plan shall become fully vested and non-forfeitable.

NOTE H.--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as foreign currency exchange rate, interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

NOTE I.--NONEXEMPT TRANSACTIONS

Late Remittances: As reported on the supplemental Schedule H, Line 4a – Schedule of Delinquent Participant Contributions, certain Plan contributions of \$33 for plan year December 31, 2023 were not remitted to the trust within the time frame specified by the Department of Labor’s Regulation 29 CFR 2510.3-102, thus constituting nonexempt transactions between the Plan and Company for the year ended December 31, 2023. The Company made contributions to the affected participants’ accounts for excise tax and to compensate for potential lost earnings resulting from the delay in contributions for the nonexempt transactions during 2024.

NOTE J.--SUBSEQUENT EVENTS

Subsequent to year end, the Company signed an agreement to transfer the Plan and change their trustee and custodian of the Plan to Principal Trust Company effective January 1, 2026. As part of the change to Principal Trust Company, the Plan adopted the optional SECURE 2.0 Act provision allowing employers to deposit matching funds into an employee's Roth 401(k), with an effective date of January 1, 2026.

Plan management has evaluated subsequent events through October 6, 2025, the date the financial statements were available to be issued.
