Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of the R&Q Solutions 401k Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan (a prototype plan) is a defined contribution 401(k) deferred compensation savings plan covering all employees of R&Q Solutions (the “Company”) and any participating affiliates, if applicable, except for employees not required to be taken into account for nondiscrimination testing purposes. An employee is eligible to participate in the Plan in the third month of service and after attaining the age of twenty-one. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan if they have not completed a salary deferral agreement within 30 days after becoming eligible to enter the Plan and make salary deferrals. Automatically enrolled participants have their deferral rate set at 2% of the employee’s eligible earnings for each payroll period and contribute that amount to the Plan as a Pre-Tax Elective Deferral. The Plan does not contain auto-escalation provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The effective date of the Plan was June 1, 1991.

Effective January 1, 2022, a Roth deferral option was introduced for participants as well.

The Setting Every Community Up for Retirement Enhancement (“SECURE”) Act 2.0 was signed into law in December 2022, delivering dozens of new retirement-related provisions. These changes build on the original SECURE Act, which altered the rules around how employees can save and withdraw money from their retirement accounts.

On June 27, 2024, R&Q Insurance Holdings LTD (“R&Q”), parent of the Company, announced the sale of 100% of its equity interest in Accredited Insurance Holdings, Inc. (“AIH”). The sale was completed and approved by the board of R&Q. In preparation of the sale, the last active employment date for the AIH employees was April 30, 2024. As part of closing terms of the above sale, R&Q announced on June 19, 2024, that it would be filing for provisional liquidation in Bermuda. On June 21, 2024, R&Q filed, in the Bermuda Supreme Court, an application to appoint Joint Provisional Liquidators (“JPLs”) to oversee the liquidation and a petition to take the initial steps to commence the winding up of R&Q. The R&Q Solutions 401K Plan is still solvent and there is no impact on the Plan.

Participant Contributions

Participants may contribute up to the maximum amounts permitted by the Internal Revenue Code (“IRC”), including catch-up amounts for participants age 50 and over, as defined in the Plan. This limitation is an aggregate limit that applies to all deferrals made to this Plan, and to any other salary deferral plan. Contributions from participants are recorded in the year in which the participant contributions are withheld from compensation.

The SECURE Act 2.0 increases the limit for catch-up contributions for individuals ages 60 to 63, effective for taxable years beginning after December 31, 2024. In addition, SECURE Act 2.0 requires that participants whose prior-year wages from their current employer that exceeded \$145,000 make any catch-up contributions as Roth (post-tax) beginning January 1, 2024. The Internal Revenue Service (“IRS”) granted a two-year administrative transition period in the provision’s effective date to January 1, 2026.

Rollovers

Rollover contributions are permitted into the Plan in accordance with IRS regulations and Plan provisions. Employees may rollover eligible amounts from other qualified plans to the Plan except for rollovers of designated Roth contributions. No rollover contributions were made in 2024.

Notes to Financial Statements

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Employer Contributions

The Company has elected a Traditional Safe Harbor 401(k) Plan and will make a Safe Harbor Matching Contribution equal to 100% of the first 4% of the participant's elective deferrals. For those participants electing less than 4% contribution, the recalculation was adjusted accordingly. During the year ended December 31, 2024, the Company made matching contributions of \$510,177.

In addition, non-elective discretionary contributions may be made at the option of the Company. No non-elective contributions were made for 2024.

Eligible compensation for computing contributions under the Plan is the taxable compensation for a Plan year reportable by the Company on their IRS Form W-2, adjusted to include compensation which was not includible in such income. These adjustments include salary reduction contributions made to an employer-sponsored cafeteria plan, SEP deferrals, transportation fringe benefits, 401(k) plan and 403(b) and 457(b) programs.

Participant Accounts

Each participant's account is self-directed and maintained by Reliance Trust Company ("Reliance"), the trustee.

Each participant's account is credited with the participant's deferral contribution, a proportionate amount of any employer contributions, and an allocation of the Plan earnings. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

The participant determines the percentage of compensation to be deferred (subject to the limitations stated above) and the investment selections from any of the investment options offered by the Plan.

Vesting

Participants are 100% vested in their deferral contribution, safe harbor matching and rollover (if any) contribution accounts. If the Company makes a qualified matching contribution (qualified nonelective contribution), the participant is 100% vested in this contribution account. A participant becomes 100% vested in case of death, total and permanent disability, or attainment of age 65, the Plan's normal retirement age or age 59.5, which is the early retirement age under the terms of the Plan.

If a participant leaves the Company for any other reason, the Company's matching contributions other than safe harbor matching contributions, if any, are vested based on the following graded schedule:

All years of service are credited to determine a participant's vesting service.

Forfeited Accounts

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,111 and \$27,656, respectively. These accounts are used to pay for the Plan's administrative expenses or reduce future employer contributions. During the year ended December 31, 2024, there were forfeitures of \$55 utilized to reduce the 2024 employer match contribution.

Notes Receivable From Participants

Loans to participants are allowed in accordance with provisions of the Plan agreement. A participant may borrow the lesser of 50% of his/her vested account balance or \$50,000, subject to a \$500 minimum. However, the \$50,000 is reduced by the highest outstanding loan balance the participant had under the Plan during the previous one-year period. A participant may only have one loan outstanding at a time.

The loans are secured by the balance in the participant's account. The interest rate applicable to new participant loans is the prime interest rate, plus two percentage points, in effect in the month the participant's loan is effective. The interest rate shall remain fixed throughout the duration of the loan. Repayment of the loan is required to be made in level payments of principal and interest through payroll deductions each pay period over a term not exceeding five years, or 30 years for loans used for the purchase of a primary residence. As of December 31, 2024, the notes bear interest at rates ranging from 5.25%-10.50%.

Payment of Benefits

A participant may elect to receive benefit payments at the normal retirement age of 65. The Plan also provides for distribution of benefits upon death or in the event of disability of the participant. Upon retirement, death or disability, the participant becomes 100% vested and all amounts credited to the participant's account shall be distributed to the participant or his or her beneficiary, in a lump-sum payment of the entire account balance. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution.

In-service distributions may be made from a participant's account at any time upon or after the occurrence of the following events:

- Due to hardships, as defined in the Plan agreement,
- Attainment of normal retirement age.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Payment of Benefits (continued)

Under the SECURE Act, participants may defer receipt of their required minimum distribution until age 72 from the previous age of 70½. The SECURE Act 2.0 increased the age at which individuals must begin taking required minimum distributions to age 73 from 72, beginning January 1, 2023, as well as other increases starting in 2030.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustees determine the Plan's valuation policies utilizing information provided by the investment advisor, Reliance. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions in accordance with the terms of the Plan agreement.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions owed to participants as of December 31, 2024 and 2023.

Payment of Benefits

Benefit payments to participants are recorded when paid.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Expenses

Administrative expenses of the Plan are paid directly by the Company or by the Plan at the election of the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

NOTE 3 – FAIR VALUE MEASUREMENTS

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There were no Plan assets requiring the use of Level 2 or 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Although it has not expressed any intention to do so, the Company has the right to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in any employer contributions.

NOTE 6 – TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the IRS dated October 6, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 – RELATED-PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for investment management services are included in net appreciation in fair value of investments, as they are paid as a percentage of the average daily assets in the investment, ranging from an annual rate of .00150% to .00325%, rather than direct payment. Notes receivable from participants as of December 31, 2024 in the amount of \$27,707 are also considered party-in-interest transactions.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits.
