## 1. Description of Plan

The following description of the Miller & Chevalier Chartered Cash or Deferred Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

### General

The Plan was established by Miller & Chevalier Chartered (the Firm) as of April 1, 1981 as a defined contribution plan, to provide cash or deferred profit sharing benefits to certain eligible members and staff of the Firm, as defined in the plan document. The Plan was most recently restated as of January 1, 2014. Substantially, all full-time members and staff who have completed at least one year of service are eligible to participate in the Plan, which is administered by the Firm. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

### Contributions

As defined under the Plan, the Firm contributes a matching contribution equal to 7.5% of the participant's compensation. The Firm contributes an additional 5% of a participant's compensation in excess of the Social Security wage base and may make additional discretionary contributions in accordance with the terms of the plan document. The Firm made no such additional discretionary contributions in 2024. Compensation for plan purposes is limited to the maximum amount permitted under the Internal Revenue Code (IRC). Participants may elect to make 401(k) contributions, which are in addition to Firm contributions, up to the lesser of 60% of their total eligible compensation or \$23,000 for the year ended December 31, 2024. A participant age 50 or over, who is contributing the maximum elective deferral, is allowed to defer an additional amount as a "catch-up" contribution up to \$7,500 for the year ended December 31, 2024. Participants also may contribute amounts representing distributions from either qualified defined benefit or defined contribution plans (rollovers).

### Participant Accounts

Each participant's account is credited with the participant's contributions, allocations of the Firm's contributions and an allocation of the Plan's earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Vesting

Each participant's account balance will be 100% vested in Firm contributions upon completion of three years of service from the hire date as a full-time employee. Each participant is immediately 100% vested in his or her elective 401(k) contributions.

### Notes Receivable From Participants

Upon written application, a participant may borrow from his or her account an amount equal to the lesser of \$50,000 or 50% of the participant's vested balance. A participant can have a maximum of two notes outstanding at any given time. Note terms range from one to five years, and principal and interest are paid ratably through payroll deductions. Outstanding note balances are secured by the balances in the participants' accounts. The notes bear interest at *The Wall Street Journal* Prime Rate plus 2% and are subject to terms specified in the plan document.

## Payment of Benefits

Upon retirement, death, termination or disability, a participant or his or her beneficiary, is entitled to receive a payment equal to the value of the participant's vested account. A participant or the surviving spouse or beneficiary, may elect to receive payment in a lump-sum, in annual installments over a fixed number of years or in partial distributions with a minimum of the lesser of \$5,000 or the participant's remaining vested account balance. Participants may elect to receive a maximum of five of such partial distributions in any plan year.

## Forfeited Accounts

The nonvested percentage of a participant's account is forfeited by the participant on the date he or she terminates employment. All forfeitures are held by Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC and Principal Bank (the Trustees) in a separate account until they are used to reduce future Firm contributions or pay for plan expenses. During the year ended December 31, 2024, the Firm used approximately \$138,000 of forfeitures to reduce Firm contributions. Forfeitures remaining to be offset against future Firm contributions or pay for plan expenses were \$20,481 and \$75,238 as of December 31, 2024 and 2023, respectively.

## 2. Summary of Accounting Policies

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company, as applicable. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

## Payment of Benefits

Benefits are recorded when paid.

## Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Firm. Expenses that are paid by the Firm are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

## Recent Regulatory Update

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of the SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

## Subsequent Events

Subsequent events were evaluated through October 1, 2025, the date the financial statements were available to be issued.

## 3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Values are based on quoted market prices of the shares held by the Plan at year-end.

*Mutual funds:* Values are based on quoted market prices of the shares held by the Plan at year-end.

*Self-directed brokerage accounts:* Includes investments in interest-bearing cash, government obligations, corporate bonds, common stocks and mutual funds. The investments in mutual funds, interest-bearing cash and common stocks are based on quoted market prices. The fair values of investments in corporate bonds and government obligations, for which quoted market prices are not available, are valued based on yields currently available on comparable securities of issuers with similar credit ratings.

## 4. Concentrations

As of December 31, 2024 and 2023, the Plan had investments of \$106,682,635 and \$96,234,540, respectively, that were concentrated in three funds.

## 5. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Ascensus, LLC, as agent for Ascensus Trust Company and Newport Trust Company, LLC and Principal Bank, the Trustees of the Plan, have certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

## 6. Related-Party and Party in Interest Transactions

Certain plan investments are shares of registered investment company funds managed by affiliates of the Trustees as defined by the Plan, and therefore, these transactions qualify as party in interest transactions exempt from the prohibited transactions of ERISA

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Trustee receives revenue from investment fund service providers for services the Trustee provides to the funds. This revenue is used to offset certain amounts owed to the Trustee for its administrative services to the Plan. If the revenue received by the Trustee from such investment fund service providers exceeds the amount owed for its services, the Trustee remits the excess to the Plan's trust on a quarterly basis. The Plan or Plan Sponsor may make a payment to the Trustee for administrative expenses not covered by revenue sharing.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Firm. No such officer or employee receives compensation from the Plan.

## 7. Plan Termination

Although it has not expressed any intent to do so, the Firm has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

## 8. Tax Status

The IRS has determined and informed the Plan by a letter dated July 6, 2017, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.


