Independent Auditors' Report

To the Participants and Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Tax Deferred Annuity Plan of Visiting Nurse Association of Southeastern Connecticut, Inc. (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

1. Description of the Plan

The following description of the Tax Deferred Annuity Plan of Visiting Nurse Association of Southeastern Connecticut, Inc. (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan was established by the Visiting Nurse Association (VNA) of Southeastern Connecticut, Inc. (the Employer) on January 1, 1980. The purpose of the Plan is to accumulate retirement income for its employees which will supplement retirement benefits provided them by Social Security. The Plan is a contributory single-employer defined contribution plan under Section 403(b) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors of the VNA of Southeastern Connecticut is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Participants may contribute a percentage of their annual compensation, as defined by the Plan, including bonuses, up to the maximum allowed by the IRC. Participants who are at least age 50 before the end of the plan year may make catch-up contributions equal to any whole number percentage of their eligible compensation or whole dollar amount. Additionally, participants who were employees of a hospital or a home health agency, health and welfare service agency, church or educational organization may be eligible to make additional contributions. To be eligible for this special catch-up contribution, participants must have completed 15 years of service with their present employer. Participants may not contribute more than the maximum allowed by the IRC. These deferrals are made through payroll deductions and may be changed at any time during the plan year.

Rollovers and transfers of funds from other qualified plans in which employees cease to participate are permitted and are fully vested.

Employer contributions are made to a separate qualified 401(a) plan. Therefore, Employer contributions are not included in these financial statements.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Contributions are paid to custodial accounts, which are administered by the Trustees, Mutual of America Life Insurance Company (Mutual) and American Funds, who are responsible for receiving contributions, making distributions, maintaining accounts and records and rendering annual reports. Participants designate their desired allocation of contributions to the Plan's investment funds and retain the right to change their investment allocation on a daily basis. Participants' accounts are credited with their contributions. The earnings (losses) generated by the investments, administrative expenses and specific participant allocations are allocated to participants' accounts daily, based upon the proportionate value of all active accounts to accounts participating in the fund as of the valuation date, as defined in the Plan.

Eligibility

Employees are eligible to participate in the Plan upon hire.

Vesting

Participants are vested immediately in their contributions, plus actual earnings thereon.

Retirement, Death and Disability

A participant is entitled to 100% of his or her account balance upon retirement, death or disability.

Payment of Benefits

Upon termination of service, death, disability or retirement, a participant or beneficiary, as applicable, may elect to receive benefits in a single lump sum or in monthly, quarterly, semi-annual or annual installments over the life of the participant or over the lives of the participant and a designated beneficiary.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balances. The loan term may generally not be longer than five years. Loans made for the purchase of a primary residence may be for a longer term. The loans are secured by the balance in the participant's account and earn interest at rates established by the plan administrator. As of December 31, 2024 and 2023, there were no participant notes outstanding with the Plan. However, there are notes outside of the Plan issued by Mutual, the Trustee. See Note 7 for a discussion of related-party transactions. The current loans outstanding as of December 31, 2024 have repayment terms that vary from one to five years with an interest rate on the loans of 5.33% to 5.53%.

Hardship Withdrawals

A hardship withdrawal may be authorized by the Employer in an amount up to 100% of the participant's contributions if certain criteria are met.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Cash Equivalent

The Plan considers all highly liquid investments with an original maturity of three months or less when purchased to be cash equivalents.

Payment of Benefits

Benefits are recorded when paid.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observables and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Separate accounts are valued based on the net asset value (NAV) per unit of participation in the account. The NAV is based on the fair value of the underlying investments held by the account less its liabilities and is considered to be a readily determinable fair value. The accounts invest principally in equity securities, fixed income instruments and short-term instruments in accordance with each account's investment objectives.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily quoted NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

7. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by the Trustees, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Effective June 2, 2025, the Plan's investments are managed by Fidelity Management Trust Company, who became the successor trustee of the Plan. Effective August 1, 2025, the Plan terminated its vendor agreement with American Funds.

Mutual, one of the Trustees, issues loans to plan participants which are secured by the participant's account balance through contractual agreements between the Trustee and the plan participant and are funded by the Trustee's general interest account. These transactions qualify as party in interest transactions. Participant account balances which were held in the Mutual general interest account that collateralized these loans totaled \$119,187 and \$98,426 at December 31, 2024 and 2023, respectively.

Certain administrative functions of the Plan are performed by officers or employees of the Employer. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right, at any time, to terminate the Plan subject to the provisions of ERISA.

9. Tax Status

The Plan has been designed to qualify under Section 403(b) of the IRC. The Plan is required to operate in conformity with the IRC to maintain the tax-exempt status for plan participants under Section 403(b). The plan administrator believes that the Plan has been designed to comply with and is operating in accordance with the applicable requirements of the IRC, and therefore, believes the Plan is qualified and the related trust is tax-exempt. The Employer believes that the Plan is in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.


