Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of PhysicianOne Urgent Care 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. Description of the Plan

The following description of the PhysicianOne Urgent Care 401(k) Plan (the Plan) is provided for only general information. Participants should refer to the Summary Plan Description or Plan agreement for a more complete description of the Plan's provisions.

General

The Plan, established on September 1, 2009, is a defined contribution plan with a salary reduction feature under Internal Revenue Code (IRC) Section 401(k). The Plan is the retirement plan of Happy Mountains, LLC and its subsidiaries (collectively, the Company or Plan Sponsor). The Plan Administrator/Sponsor is Happy Mountains, LLC. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan Trustees oversee governance of the Plan, as well as determine the appropriateness of the Plan's investment offerings and monitors investment performance.

On April 4, 2025, the Plan Sponsor approved a resolution to amend the Plan name to Yale New Haven Health Urgent Care 401(k) Plan effective February 13, 2025.

Eligibility

All employees of the Company are immediately eligible to participate in the Plan upon reaching 18 years of age. Participants are eligible to participate in the safe harbor contribution component of the Plan upon completing one year of service.

Contributions

Participants, at their option, can defer up to 100% of qualified compensation, as defined in the Plan, on a pre-tax basis, not to exceed Internal Revenue Service (IRS) annual limits. Participants age 50 and over, before the end of the plan year, may voluntarily contribute additional catch-up contributions subject to IRS limits. Such contributions are not subject to federal income taxes until withdrawn from the Plan, in accordance with Section 401(a) of the IRC. Participants, at their option, may contribute on an after-tax basis (Roth contributions). Participants are also allowed to contribute amounts representing distributions from other qualified plans (rollovers).

During 2023, the Plan added an automatic enrollment feature whereby the Company automatically withholds 3% of the eligible participants' compensation on a pre-tax basis, unless the participant notifies the Company, and affirmatively elects not to participate in the automatic enrollment feature. If a participant fails to choose an investment option, such funds are automatically invested in the Plan's default investment option until the participant selects a different investment option available under the Plan. The Plan has elected to utilize the managed account service of Stadion Money Management, LLC (Stadion) as the qualified default investment alternative, whereby contributions are automatically invested into an investment profile managed by Stadion based on the participant's age.

The Plan requires a safe harbor, nondiscretionary matching contribution of 100% of salary deferrals, up to a maximum of 3% of compensation plus 50% of salary deferrals that exceed 3% but not in excess of 5% of compensation.

Contributions are subject to certain IRS limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution and an allocation of the Company's discretionary contribution and plan earnings/losses (based on participant's investment election and account balance), and charged with the allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings, account balance, or specific participant transactions, as defined. The benefit to which a participant is entitled to is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their voluntary contributions, including rollover contributions and employer contributions plus actual earnings.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000, up to a maximum, not to exceed the lesser of (a) 50% of the participant's vested balance, or (b) \$50,000, reduced by the excess, if any, of the highest outstanding principal balance of loans from the Plan to the borrower during the preceding year, subject to certain conditions as defined by the Plan agreement. Each borrowing is evidenced by a note bearing interest at a reasonable rate as determined by the Plan Administrator, based on prevailing interest rates charged by persons in the business of lending money for loans which would be made under similar circumstances, and must be repayable over a period not to exceed five years (other than loans for the purchase of a primary residence). Principal and interest payments are credited to the borrowing participant's account. Principal and interest are paid in level amortization payments made through payroll deductions. The loans are secured by the vested balance in the participant's account. Loans will become due and payable in full upon the participant's death, retirement, or other termination of employment with the Company.

The current receivables outstanding as of December 31, 2024 have repayment terms that vary from one to five years and interest rates ranging from 4.25% to 9.50%.

Payment of Benefits

Plan benefits are available at normal retirement age (age 62), deferred retirement, disability retirement, death, or termination of employment. Participants will receive the vested portion of their account as a lump sum payment. If at the time of termination, the amount of a participant's vested account is \$5,000 or less, the Plan Administrator may distribute the vested account without participant consent.

Withdrawals

The Plan allows for annual in-service withdrawals from the vested portion of a participant's account upon the participant's attainment of age 59½. Hardship withdrawals are prohibited.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Trustees of the Plan, who are members of management, determine the Plan's valuation policies utilizing information provided by the investment trustee. See Note 3 for discussion of fair value measurements.

The Plan's investments in fully benefit-responsive contracts are reported at contract value. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon terms of the plan document. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Payment of Benefits

Benefits are recorded when paid.

Recent Regulatory Updates

The SECURE 2.0 Act of 2022 was signed into law on December 29, 2022. This legislation includes a vast array of provisional changes to retirement plans, becoming effective in 2023 and beyond. Plan management adopted mandatory provisions effective for the year ended December 31, 2024, and continues to evaluate the impact of the adoption and implementation of this legislation on the Plan. The application of SECURE 2.0 Act did not have a material effect on the Plan's financial statements.

Subsequent Events

The Plan has evaluated subsequent events for recognition or disclosure through October 8, 2025, the date the financial statements were available to be issued.

3. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value except for fully benefit-responsive investment contracts, which are reported at contract value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under authoritative guidance are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan did not hold any assets that are required to be reported within the fair value hierarchy as of December 31, 2024 or 2023.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts - The Plan has investments in participation units held in pooled separate accounts through sub-accounts of an insurance company. The net asset value (NAV) is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

Included in the pooled separate accounts are funds considered common collective trusts for which the NAV is based on the market value of the underlying investments.

The other underlying securities in the pooled separate accounts are listed on national securities exchanges and valued on the basis of year-end closing prices. The Plan has concluded that the NAV as adjusted (for mutual fund dividends, mutual fund splits, and administrative charges and other items) and reported by the insurance company approximates fair value of the investments. The investments are redeemable at the adjusted NAV under agreements with the insurance company.

It is possible that the redemption rights may be restricted or eliminated in the future. Due to the nature of the investments, changes in market conditions, liquidity requirements and the economic environment, it may significantly affect the net asset value of the pooled separate accounts and, consequently, the fair value of the Plan's investments.

The methods described previously may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurement at the end of the reporting date.

As of December 31, 2024 and 2023, investments for which fair value is measured using the net asset value per share practical expedient, consisted of pooled separate accounts in the amount of \$13,149,722 and \$10,474,526, respectively. The pooled separate accounts allow for daily redemptions, and do not require a notice period for participant level transactions, but require a 60-day notice period for plan-level withdrawals. There are no unfunded commitments.

4. Concentration

As of December 31, 2024 and 2023, the Plan had investments of \$5,711,317 and \$3,639,072, respectively, that were concentrated in three and two funds, respectively.

5. Fully Benefit-Responsive Investment Contract

The Plan holds a traditional fully benefit-responsive guaranteed investment contract, for which contributions are maintained in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by the sponsoring trustee, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The traditional investment contract held by the Plan is a guaranteed investment contract. The contract issuer is contractually obligated to repay the principal and interest at the specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1%. The crediting rate is reviewed on an annual basis for resetting. The contract cannot be terminated before the scheduled maturity date. The average yield based on actual interest credited to participants was 3.89% and 3.59% in 2024 and 2023, respectively. The contract value was \$417,103 and \$174,020 at December 31, 2024 and 2023, respectively.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. These events may be different under each contract. Such events include (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. These events may be different under each contract. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

6. Information Certified by Trustee

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ameritas Life Insurance Corp., the custodian of the Plan, has certified to the completeness and accuracy of all investments reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reported in the Statements of Changes in Net Assets Available for Benefits for the years ended December 31, 2024 and 2023. Such information was obtained by management and agreed to or derived from information certified as complete and accurate by a qualified institution.

7. Related-Party and Party in Interest Transactions

Certain of the Plan's investments are managed by the custodian, and therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment manager services are included in net appreciation in the fair value of investments, as they are paid through revenue sharing, rather than a direct payment. Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

8. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participant accounts will be distributed to participants in accordance with the provisions of the Plan.

9. Tax Status

The Plan adopted a volume submitter plan offered by FIS Business Systems, LLC stating that the written form of the underlying specimen plan is qualified under Section 401(a) of the IRC. The volume submitter plan received an IRS Advisory Letter dated June 30, 2020, stating that the Plan (as amended) is qualified under Section 401(a) of the IRC, and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. Subsequent to this determination by the IRS, the Plan was amended. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan, as amended, is qualified and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.
