### NOTES TO THE FINANCIAL STATEMENTS

#### **Note A - Description of the Plan**

The following description of the V&L Management Company Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan was established effective January 1, 1992, as a defined contribution plan for the benefit of eligible employees of V&L Management Company Inc. (the "Company"). The Plan is subject to the provisions of the Employee Income Security Act of 1974 ("ERISA").

#### **Administration**

The Sponsor has appointed Mid Atlantic Trust Company to act as the Custodian of the Plan. PB&H Benefits is recordkeeper and Third-Party Administrator ("TPA") of the Plan.

#### **Eligibility**

Employees of the Company who have attained the age of 18, and completed one month of service are eligible to contribute deferrals to the Plan and receive safe harbor contributions. Employees of the Company who have attained the age of 21 and completed one year of service, as defined, will become eligible for employer matching contributions and nonelective contributions. The entry date of the Plan for eligible participants is on the first day of the month coinciding with or next following the date requirements are met.

Nonresident aliens, union employees and leased employees are excluded from participating in the Plan.

#### **Contributions**

Each year participants may contribute a percentage of their pre-tax annual compensation not to exceed the limitation (\$23,000 and \$22,500 in 2024 and 2023 respectively) set forth in Section 402(g) of the Internal Revenue Code ("IRC"). Participants who are (or will be) age 50 or older by the end of the calendar year may make pre-tax or after-tax catch-up contributions that exceed the annual elective deferral limit. Participant's total catch-up contributions during 2024 and 2023 cannot exceed \$7,500 and \$7,500, respectively. Participants may also make rollover contributions from other plans.

### **Note A - Description of the Plan, continued**

For the Plan year ended December 31, 2024, the Sponsor contributed a safe harbor 3% nonelective contribution in the amount of \$232,306 and a profit-sharing contribution of \$140,723.

Each participant's account is credited with the participant's contributions, the Sponsor matching contribution and an allocation of any non-elective contribution and earnings (losses) on the investments selected by the participant. Allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested interest in his or her account.

### **Investment Options**

Upon enrollment in the Plan, participants may direct the investment of their contributions and the Sponsor's contributions into various investment options offered by the Plan.

### **Vesting**

Participants are vested immediately in their elective contributions, plus any earnings on such contributions. The vesting of matching Sponsor contributions plus any earnings thereon is based on years of continuous service accrued by the participant while in covered employment. Participants are vested 20% after two years of service and are 100% vested after six years of service.

### **Participant Loans**

Participants loans are not permitted.

### **Participant Investment Rollovers**

Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

### **Payment of Benefits**

Payment of benefits is recorded when paid.

### **Forfeited Accounts**

All employer contributions credited to a participant's account, but not vested, are forfeited by the participant upon his/her termination from the Plan. Per the Plan document forfeitures may be used to offset future employer contributions or to pay Plan expenses. As of December 31, 2024, there was \$6,919 in forfeitures that have not yet been applied. This balance must be used by no later than the end of the following plan year.

## **Note A - Description of the Plan, continued**

### **Administrative Expenses**

Certain expenses incurred in the administration of the Plan are paid directly by the Plan. During the year ended December 31, 2024, the Plan paid fees of \$35,596.

## **Note B - Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amount of net assets available for the benefits and changes therein. Actual results could differ from those estimates.

### **Risk and Uncertainties**

The Plan provides for various investment options. These investment options are exposed to market risk, which generally means the risk of loss in the value of certain investment securities due to changes in interest rates, commodity prices and general market conditions. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the Statement of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### **Investment Valuation and Income Recognition**

Investments are stated at fair value, which is determined using quoted market prices. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note D for discussion of fair value measurements. Investments in fully-benefit responsive investment contracts are reported at contract value as discussed in Note C. Investments in money market funds are valued at amortized cost, which approximates fair value. Net appreciation (depreciation) in fair value of investments includes realized gains and losses on investments sold during the year and unrealized appreciation (depreciation) of investments held at the end of the year.

## **Note B - Summary of Significant Accounting Policies, continued**

### **Subsequent Events**

The Plan has evaluated subsequent events through September 22, 2025, the date which the financial statements were available to be issued. No events have occurred subsequent to the date of the statement of net assets available for benefits that would require adjustment to, or disclosure in, the financial statements.

### **Contributions**

Contributions from Plan participants and the matching contribution, if any, from the Plan Sponsor, are recorded in the year in which the participant contributions are withheld from amounts paid. Profit sharing contributions, if any, are recognized upon authorization and in the year the underlying compensation is recognized. All participant and employer contributions are participant-directed.

### **Expenses**

Plan administrative expenses are paid by the Plan.

## **Note C - Insurance Investment Contract**

On December 31, 2024 and 2023, the Plan had a traditional fully benefit-responsive guaranteed investment contract, in the amount of \$370,640 and \$605,917 respectively with Reliance Trust Company (“RTC”). RTC Stable Value Fund Collective Investment Trust, Series 25053 was formed for the purpose of allowing participating plan sponsors, who maintained defined contribution plans qualified under Sections 401(a) and 501(a) of the IRC, to invest in MetLife Group Annuity Contract 25053 and MetLife Group Annuity Contract 37000 (“Contracts”) issued by Metropolitan Life Insurance Company to RTC, for use as the primary underlying investments for their stable value collective investment trust fund. RTC is a wholly owned subsidiary of Reliance Financial Corporation. Reliance Financial Corporation is an indirect wholly owned subsidiary of Fidelity National Information Services, Inc. Units are issued and redeemed daily at contract value (See “Circumstances That Impact the SVF” below for definition of contract value.). Contract value represents contributions, plus interest, less participant-initiated withdrawals or transfers.

The Stable Value Fund is stated at contract value and invests in an actively managed, highly diversified portfolio of fixed and floating rate securities. MetLife, an AA rated company, guarantees the contract value of the SVF and is the sole wrap provider. The fair value of the underlying Contracts is determined by MetLife based on quoted market prices of the underlying investments owned by MetLife.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the plan to transact at contract value with the participants.

## **Note D - Fair Value Measurements**

FASB ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted process for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical assets or liabilities in inactive markets.
- Inputs other than quoted process that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset of liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use to unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1 input).

Exchange Traded Funds Valued at NAV. The NAV is the value of each share measured by the value of all the fund's underlying holdings at their closing prices. However, because the ETF trades throughout the day, there are times when the NAV and the actual market price differ, although the differences tend to be minuscule.

**Note D - Fair Value Measurements, continued**

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The following tables set forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023.

**Note E – Information Certified by the Custodian (Unaudited)**

On December 31, 2024 and 2023, the Plan’s investments were held by the Custodian. The following is a summary of the Plan’s financial information that is included in the financial statements based on information certified by the Custodian, Mid Atlantic Trust Company, as complete and accurate in accordance with Section 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Mid Atlantic Trust Company also certified to the completeness and accuracy (including gains and losses on investments bought and sold, as well as held during the year) of \$566,315 of net appreciation in the fair value of investments, \$147,867 of dividends and net gain on the sale of assets of \$109,363.

#### **Note F – Plan Termination**

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

#### **Note G – Tax Status**

The Plan obtained its latest opinion letter dated December 9, 1997, and an opinion letter dated March 31, 2008, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving these letters. The Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been made in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note H – Party-in-Interest Transactions**

The Plan allows participant loans. These transactions qualify as party-in-interest transactions. However, such transactions are permitted under the provisions of the Plan and are exempt from the prohibition of party-in-interest transactions under ERISA.

Certain Plan investments are funds managed by the Trustee and the Custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services and certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party-in-interest transactions.

#### **Note I – Benefit Claims Payable**

On December 31, 2024, there were no benefit claims payable for distributions requests made prior to year-end.

#### **Note J – Recent Accounting Pronouncements**

Recent accounting pronouncements issued by the FASB did not or are not believed by management to have a material impact on the Plan's present or future financial statements.
