Opinion

NOTE 1 - DESCRIPTION OF PLAN

The Roger Bettis Trucking, Inc. 401(k) Plan (the "Plan") is a retirement savings plan designed to invest voluntary employee contributions, safe harbor matching contributions and discretionary employer contributions for the benefit of the participating employees. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Roger Bettis Trucking, Inc. ("Plan Administrator" or "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA").

Eligibility

Employees of the Plan are eligible to participate on either January 1 or July 1 immediately following the completion of six months of service.

Contributions

Eligible participants may contribute up to 100% of their annual compensation on a pre-tax basis, limited by current maximum amounts as determined by law. Eligible participants may also contribute on an after-tax basis through Roth 401(k) deferrals, which are subject to federal income tax in the year of deferral. In addition, the Plan contains a catch-up option for participants who have attained age 50 before the end of the Plan year, permitting them to make an additional elective deferral. Participants direct the investments of their contributions into various investment options offered by the Plan.

Eligible participants who have completed six months of consecutive employment are eligible to receive the Plan Administrator's safe harbor matching contributions. The safe harbor matching contribution is equal to 100% of salary deferrals up to the first 3% of Plan compensation plus an additional 50% of salary deferrals up to the next 2% of Plan compensation. The Plan Administrator's safe harbor matching contributions for the years ended December 31, 2024 and 2023 were \$245,404 and \$273,514 respectively.

Eligible participants may also receive an employer discretionary matching contribution made by the Plan Administrator. This discretionary matching contribution can either be a uniform percentage of deferrals or a flat dollar amount for each participant. No discretionary matching contributions were made for the years ended December 31, 2024 and 2023.

Rollovers

Participants may transfer eligible cash distributions from any other employer sponsored qualified plan under Section 401(a) or 403(a) of the Internal Revenue Code ("IRC") into the Plan by a direct transfer from such other plan.

Forfeitures

As forfeitures become available, the Company may apply such forfeitures to Plan expenses or use the forfeitures to reduce the employer safe harbor matching and/or discretionary matching contributions. Total forfeitures available for use were \$12,153 and \$19,421 as of December 31, 2024 and 2023, respectively.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of (a) the Plan Administrator's matching and/or profit sharing contribution and (b) investment earnings. All accounts are valued daily by Capital Bank and Trust Company (the "Custodian"). Allocations are based on participant compensation or account balance, as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon and the employer safe harbor contributions. The vesting percentage for the employer discretionary matching contribution, and prior to January 1, 2014, for the employer matching contributions, was determined according to the following schedule:

Payment of Benefits

On reaching normal retirement age of 65 or termination of service, a participant may elect to receive a lump sum payment or defer payment until their normal retirement date. Upon the termination of service, a participant may elect to take a partial withdrawal or defer payment for a reasonable period following the date of the participant's termination. If a participant's vested account balance is less than \$5,000, an automatic rollover to an Individual Retirement Account is made. Upon attaining age 59 ½, a participant may elect to withdraw all or any portion of their vested account balance or defer payment for a reasonable period.

In the event of financial hardship, participants may apply to receive a distribution from their vested pre-tax elective deferral and Roth 401(k) after-tax deferral accounts, subject to Internal Revenue Service ("IRS") mandated rules for hardship withdrawals. The minimum amount of a hardship distribution is \$1,000.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the participant's vested account balance, whichever is less. The notes receivable from participants are secured by the balance in the participants' accounts and bear interest at reasonable rates of interest, as defined under the Plan document, at the time of approval. Principal and interest payments are made through payroll withholding and generally do not exceed 60 months unless the note is for the purchase of a principal residence. Participants may only have one note outstanding at a time.

Notes receivable are in default when payments are not made by the end of the calendar quarter following the quarter in which the payment was due. In the event of default, the entire outstanding note balance and all accrued and unpaid interest will remain as the participant's obligation. Participants have the opportunity to repay the note or to resume current status by paying all missed payments. If distribution is or becomes available under the Plan, the participant's vested balance will be offset by the outstanding balance of the note and deemed a distribution.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless paid by the Company. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net (depreciation) appreciation of investments.

Plan Termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value estimates are made at a specific point in time based on relevant market information about the financial instrument. These estimates are subjective in nature and involve uncertainties and matters of significant judgment and, therefore, cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net (depreciation) appreciation of investment includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when paid.

Income Taxes

Under the Income Taxes Topic of the Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC"), Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by taxing authorities. Management has analyzed the tax positions taken by the Plan, and has concluded that as of and for the years ended December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements.

Subsequent Events

The Plan has evaluated subsequent events through August 6, 2025, the date the financial statements were available to be issued.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is a market-based measurement that is determined based on assumptions that market participants would use in pricing an asset or liability. As a basis for considering such assumptions, the Plan uses a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value as follows:

- Level 1 – Observable inputs such as quoted prices in active markets;
- Level 2 – Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3 – Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The classification of fair value measurements within the hierarchy is based upon the lowest level of input that is significant to the measurement. Valuation methodologies used for assets and liabilities measured at fair value are as follows:

- *Mutual funds*: Valued at fair value as determined by quoted market prices on active markets.
- *Common/collective trust fund*: Valued at the net asset value ("NAV") of the underlying investments held by the funds, less their liabilities. NAV is used as a practical expedient to estimate fair value. Transactions (purchase and sales) may occur daily. The plan has no future investment commitments or redemption requirements related to the fund as of December 31, 2024 and 2023.

The methods described above may produce a fair value calculation that may not be indicative of the net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in methods used to value investments.

NOTE 5 - TAX STATUS

Effective January 1, 2014, the Plan Administrator adopted the ASC Institute, LLC Defined Contribution Volume Submitter Plan and Trust Basic Plan Document ("Volume Submitter Plan"), a prototype non-standardized profit sharing plan. The Volume Submitter Plan obtained its latest determination letter on March 31, 2008, in which the IRS stated that the Volume Submitter Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. However, the Plan Administrator is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status and believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

NOTE 6 - PARTY-IN-INTEREST TRANSACTIONS

During the year ended December 31, 2024 and 2023, certain Plan investments were shares of mutual funds that were fully-managed by the Custodian. These transactions are party-in-interest transactions. Fees paid by the Plan for administrative services amounted to \$1,075 and \$1,025 for the years ended December 31, 2024 and 2023, respectively. There were also indirect fees deducted directly from investment earnings of the Plan.
