### ***Basis for Opinion***

Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### **DESCRIPTION OF PLAN**

During 2023, the plan sponsor was sold and at that time the Plan was amended which changed several provisions as described below. Additionally, effective January 23, 2023, all plan assets were transferred from Meeder Asset Management, Inc. to Transamerica Retirement Solutions, LLC. Additionally, the Plan name was changed to the Abrasive Technology, Inc. Retirement Plan. The amended plan allows for employee contributions and an employer match.

The following brief description of the Abrasive Technology, Inc. Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

#### **General**

The Plan is a defined contribution retirement plan covering all eligible employees of Abrasive Technology, Inc. ("Plan Sponsor), Abrasive Technology France, LLC, Abrasive Technology Mexico II, LLC, Abrasive Technology Mexico, LLC, Abrasive Technology Aerospace, Inc. and Manufacturing with Heart, Inc. (the "Company"). The Plan is funded by discretionary Company contributions, which are subject to the limitations of the Internal Revenue Code. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

An employee shall be eligible to participate and are automatically enrolled in the Plan after 3 months or 500 hours of service, and at attainment of age 18.

#### **Contributions**

Prior to the amendment from January 2023, employee contributions were not permitted and the employer could make discretionary profit sharing contributions to the Plan. Previously, the profit sharing contribution was based on a percentage of the participant's gross earnings. Employer contributions were 100% vested after 6 years of service in accordance with the following schedule: 0 year – 0%, 1 year – 10%, 2 years – 20%, 3 years – 40%, 4 years – 60%, 5 years – 80%, and 6 years – 100%.

After the amendment in January 2023, to participate in the Plan, an eligible employee must enter into a contribution agreement with the employer authorizing the employer to deduct and withhold from such employee's compensation a specified amount, or percentage thereof, ranging from 1% to 100% limited by the maximum contributions allowable by the Internal Revenue Code (IRC), and to contribute such amount to the employee's account in the Plan. Eligible employees can make pre-tax and after-tax (Roth) salary deferrals. Additionally, the Plan allows for safe harbor contributions to the Plan from the Company. The safe harbor contributions are 100% of elective deferrals up to 3% of the employee's eligible compensation and 50% of elective deferrals for the next 3% of employee's eligible compensation. No contributions shall be made on behalf of a participant to the extent that, when added to the participant's salary deferral contributions, it would cause the amounts allocated to exceed the limitations allowed by the IRC.

#### **Investment Options**

A participant is permitted to control the assets in their own accounts and to determine the investments for all or part of this interest in their accounts. A participant shall exercise this investment right by submitting written investment instructions to the Trustee on a form approved by the Trustee. If this right is not exercised, all contributions credited to a participant's accounts will be invested by the Trustee in the Target Date Retirement Portfolios 1 through 5 (the default investments).

The Plan Sponsor continually monitors the investment options and may make changes from time to time in an effort to provide the best return for the participants.

***DESCRIPTION OF PLAN - Continued***

***Account Types***

***General Account Fund***

The General Account Fund is the portion of plan assets that are allocated to all the employees. The employees can direct their retirement funds to any of the investment options listed above.

***Specific Account Fund***

The Specific Account Fund is the portion of plan assets that are allocated to the owner. These funds are self-directed at his own discretion into any investment option of his choosing.

After the plan amendment in January 2023, the Specific Account Fund was removed.

***Payment of Benefits***

The form of payment under the Plan may be a lump sum distribution or periodic installment payments over a period not exceeding the normal life expectancy of the participant and their designated beneficiary at the time of commencement of payment. A participant's account shall be payable to him or her, or in the event of death to a beneficiary, upon the earlier of disability, termination of employment, or retirement date. Retirement date is upon attainment of age 59½.

***Administrative Expenses***

The Plan's administrative expenses are paid by the Plan or Abrasive Technology, Inc., as provided in the plan document. The expenses paid by the Plan are allocated to the Plan participants' accounts based on participant earnings, account balances, or specific transactions, as defined.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts up to a maximum of \$50,000 or 50% of their vested account balance for a maximum of five years unless for a primary residence, for which the maximum is 15 years. The loans are secured by the balance in the participant's account and bear interest at local prevailing rates as determined by the Plan administrator. Delinquent loans are classified as distributions.

***Forfeited Accounts***

Forfeitures represent the non-vested portion of employer contributions to accounts of former participants. The balance in the account at December 31, 2024 and 2023 was \$130,780 and \$17,120, respectively. These accounts are non-participant directed and will be reallocated to administrative fees. The amounts reallocated for the years ended December 31, 2024 and 2023, were \$35,318 and \$27,520, respectively.

***Plan Amendments or Terminations***

The Plan Sponsor reserves the right at any time to amend or terminate the Plan, provided that no such amendment or termination shall have the effect of giving the Plan Sponsor any right, or of reducing the rights of any participant, in the funds then held by the Trustee. No amendment to the Plan shall have the effect of eliminating or reducing a retirement benefit, or eliminating an optional form of benefit with respect to benefits attributable to service before the amendment.

***SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES***

The financial statements of the Plan are prepared on the modified cash basis of accounting, which differs from accounting principles generally accepted in the United States of America. Consequently, certain revenues (primarily interest and dividends) and the related assets are recognized when received rather than when earned and certain expenses (primarily administrative expenses) are recorded when paid rather than when the obligation is incurred.

Following are the significant accounting policies adopted by the Plan and used in the preparation of these financial statements:

***Investment Valuation and Income Recognition***

Investments are recorded at fair value based upon quoted market prices at year end. Transactions are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Cost of investments is determined using the average cost basis and is used when determining realized gains and losses upon disposition.

***Contributions***

Contributions are recorded as earned on the accrual basis when discretionary contributions are allocated by the Plan Sponsor.

***Payment of Benefits***

Benefits are recorded when paid.

***Use of Estimates***

The preparation of the financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Although these estimates are based on the Plan administrator's knowledge of current events and actions it may undertake in the future, they may ultimately differ from actual results.

***Risks and Uncertainties***

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes would materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

***REPORTABLE TRANSACTIONS***

The Plan's assets are participant-directed, and thus, the schedule of reportable transactions is not required.

***RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500***

No reconciliation was necessary for 2024 and 2023.

## ***PARTY-IN-INTEREST TRANSACTIONS***

Meeder Asset Management, Inc., Huntington National Bank, and Merrill Lynch provided trustee, investment and record-keeping services to the Plan from January 1, 2023 until January 23, 2023. Transamerica Retirement Solutions, and Reliance Trust Company provided trustee, investment, and record-keeping services to the Plan from January 23, 2023 until December 31, 2023 and for the year ended December 31, 2024. BHM CPA Group, Inc. serves as the Plan's auditor. As a result, transactions with these parties qualify as party-in-interest transactions.

Certain administrative functions are performed by officers or employees of the Plan Sponsor. No such officer or employee received compensation from the Plan. Certain administrative expenses of the Plan are paid directly by the Plan Sponsor and are not charged to the Plan.

## ***INCOME TAX STATUS***

The Internal Revenue Service (IRS) has determined the Plan meets the requirements of Section 401(a) of the IRC and, therefore, the Plan is exempt from federal income tax.

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan, as then designed, was in compliance with the applicable requirements of the Code including all amendments through December 31, 2019. Based on this, the Plan Administrator believes that the Plan is in compliance with the applicable requirements of the Code, is qualified and the related trust is tax-exempt as of the financial statements date.

The modified cash basis of accounting requires plan management to evaluate the tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan administration is not aware of any tax positions taken by the Plan that it considers to be uncertain. Tax returns for the years ended 2021, 2022 and 2023 are open and subject to examination by the IRS.

## ***PREPAID CONTRIBUTION***

On December 30, 2024, the plan processed contributions relating to the first payroll for the 2025 plan year. This is recorded as a liability of \$56,741 on the balance sheet for the year ended December 31, 2024.

## ***FAIR VALUE MEASUREMENTS***

The Plan complies with Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, to account for and report fair value. ASC 820 provides a single definition of fair value, a framework for measuring fair value and expanded disclosures concerning fair value. It also defines fair value as the price that would be received for an asset or paid to transfer a liability (an exit price) in the principal or most advantageous market for the asset or liability in an orderly transaction between market participants on the measurement date.

Fair value of certain assets and liabilities are determined based on the fair value hierarchy, which requires an entity to maximize the use of observable inputs and minimize the use of unobservable inputs when measuring fair value. Observable inputs are inputs that reflect the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances.

The standard describes three levels within its hierarchy that may be used to measure fair value which are:

**Level 1**

Values are based on unadjusted quoted prices in active markets for identical assets or liabilities.

**Level 2**

Values are based on quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

**Level 3**

Values are generated from unobservable inputs that are supported by little or no market activity and that are a significant component of the fair value of the assets or liabilities. These unobservable inputs would reflect management's estimates of assumptions that market participants would use in pricing related assets or liabilities. Valuation techniques might include the use of pricing models, discounted cash flow models or similar techniques.

A financial asset or liability's classification within the hierarchy is determined based on the lowest level input that is significant to the fair value measurement. The assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the classification of fair value assets and liabilities within the fair value hierarchy levels.

The fair value of money market, common and preferred stock are publicly traded and are valued at their listed trading price at year end. As a result, they are considered Level 1. Registered Investment Companies are mutual funds valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

U.S. Government Securities are valued using pricing models maximizing the use of observable inputs for similar securities and as a result are considered Level 2.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while Plan administration believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

***CERTIFIED INFORMATION***

In accordance with 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator has elected to restrict the scope of the auditor's examination with regard to investments or information prepared and certified by Reliance Trust Company the trustee. Reliance Trust Company acted as the trustee and held the Plan's investments and executed all investment transactions. Reliance Trust Company has certified as to the completeness and accuracy of the investments held, changes in net assets arising from investment activity, and the schedule of assets held at the end of the year as of and for the years ended December 31, 2024 and 2023, respectively.

***DEFAULTED PARTICIPANT LOANS***

Participant loans are measured at their unpaid principal balance plus any accrued but unpaid interest. Loans that are in default and have been deemed distributed under Internal Revenue Code Section 72(p) are classified as deemed distributions. These loans are not removed from plan assets but are reported separately in the notes to the financial statements. As of December 31, 2024, benefit payments paid to participants include \$18,119 of loans that are in default and have been deemed distributed. These deemed distributions are taxable to the participant and are reported on Form 1099-R in the year of default. However, they remain in the plan's records as outstanding loans until a distributable event occurs or the loan is formally offset.

***DELINQUENT CONTRIBUTIONS***

As disclosed in the accompanying supplemental schedule, deferrals for one employee were not remitted to the Plan within the timeframe required by the DOL, because they were incorrectly excluded from the automatic deferral. With the assistance of the Plan's advisors, the Company has determined the amount of related lost earnings and will remit those amounts to participants' accounts as a qualified nonelective contribution (QNEC) subsequent to year end.

***SUBSEQUENT EVENTS***

Subsequent events were evaluated through September 17, 2025, which is the date the financial statements were available to be issued.
