INDEPENDENT AUDITOR'S REPORT

TO THE PARTICIPANTS AND ADMINISTRATOR OF DELAWARE OTSEGO CORPORATION AND THE NEW YORK, SUSQUEHANNA AND WESTERN RAILWAY CORPORATION 401(k) SAVINGS PLAN & TRUST

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **DELAWARE OTSEGO CORPORATION AND THE NEW YORK, SUSQUEHANNA AND WESTERN RAILWAY CORPORATION 401(k) SAVINGS PLAN & TRUST** (“the Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Delaware Otsego Corporation and The New York, Susquehanna, and Western Railway Corporation 401(k) Savings Plan & Trust Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the accompanying financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Delaware Otsego Corporation and The New York, Susquehanna, and Western Railway Corporation 401(k) Savings Plan & Trust and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.



NOTE 1 – DESCRIPTION OF THE PLAN

The following description of the Delaware Otsego Corporation and The New York, Susquehanna and Western Railway Corporation 401(k) Savings Plan & Trust (the “Plan”) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Delaware Otsego Corporation and Subsidiaries (the “Company”) who are age 21 or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions

Each year, participants may contribute up to 100% of pre-tax annual compensation, subject to Internal Revenue Service (“IRS”) limitations. Participants over the age of 50 may contribute additional amounts as allowed by IRS regulations. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan includes a “Safe Harbor” contribution option. Under the Safe Harbor Plan, the Company will make matching contributions equal to 100% of each participant’s elective deferrals that do not exceed 3% of their annual compensation and 50% of the amount of elective deferrals that exceed 3% of compensation but that do not exceed 5% of compensation. The Company may also be required to make discretionary or qualified non-elective contributions (“QNECs”) to satisfy certain nondiscrimination requirements, as determined each plan year by the Company. The Company has made all required contributions.

Participant Accounts

Separate accounts are maintained for each participant. The trustee invests the contribution amounts, as instructed by the participants, in one or more of the separate investment funds offered under the Plan. Each participant’s account is credited with (a) the amount of the participant’s elected contributions; (b) the amount of the participant’s Company matching and discretionary contributions; (c) the amount of any attributable investment earnings and market appreciation or depreciation; and (d) charged with direct administrative expenses when applicable. The benefit to which a participant is entitled is the final market value of the participant’s account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon, employer matching contributions, qualified matching, and qualified non-elective contributions. A participant is 100% vested in employer non-elective contributions (other than QNECs) after three years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund account an amount not to exceed the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan Agreement. The principal and interest thereon shall be repaid over a period not to exceed five years (except for certain residential loans which can be repaid over a reasonable period of time in excess of five years). The loans are secured by the balance in the participant's account and bear interest at a rate (3.75% – 9.00%) comparable to the interest rate a bank or other financial institution would charge for making a loan under similar circumstances. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments, either annually or more frequently. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Terminated participants with vested account balances greater than \$5,000 may elect to defer payment of benefits until age 65. A financial hardship withdrawal provision is available, enabling a participant to withdraw an amount to cover an immediate and heavy financial need, in accordance with current IRS regulations.

Forfeited Accounts

At both December 31, 2024 and 2023, forfeited non-vested accounts totaled approximately \$3,300 and \$0, respectively. Forfeitures can be utilized to reduce plan expenses or employer contributions. Plan expenses were not reduced during the years ended December 31, 2024 and 2023, from forfeited non-vested accounts.

NOTE 2 – SIGNIFICANT ACCOUNTING POLICIES

The accounting principles and practices which affect the more significant elements of the financial statements are:

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to the common collective trust because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure on contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchase and sales are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net gain (loss) from investments include plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are reported at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Certain indirect expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and withdrawals are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net investment gain (loss) from investments.

Payment of Benefits

Benefits are recorded when paid.

Risks and Uncertainties

The Plan provides for various investment options in any combination of mutual funds. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the values of the investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Date of Management's Review

The Plan has evaluated events from December 31, 2024 through October 6, 2025, which is the date the financial statements were available to be issued. Management has determined that no such events have occurred.

**NOTE 3 – FINANCIAL INFORMATION CERTIFIED BY PLAN
CUSTODIAN**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator has obtained a certification from NBT Bank, the custodian of the Plan, that all of the information provided by them is complete and accurate. Information included in the accompanying financial statements as of and for the years ended December 31, 2024 and 2023 pertaining to investments, dividend and interest income, net investment gain (loss) from investments and all information in the supplemental schedule is presented in reliance solely upon those certifications.

NOTE 4 – TAX STATUS

The Employer has adopted the Epic Advisors Inc. Prototype Defined Contribution Plan. The Plan obtained its latest determination letter on June 30, 2020, in which the IRS ruled that the prototype plan of Epic Advisors Inc. is acceptable under Section 401(a) of the Internal Revenue Code ("IRC") and, therefore, is not subject to federal income tax under present law.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. As the Plan is tax-exempt, the Plan administrator has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

NOTE 5 – FAIR VALUE

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money Market Funds: Valued at the daily closing price as reported by the fund.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification ("FASB ASC") 820, *Fair Value Measurements* are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities that the Plan can access at the measurement date.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

NOTE 6 – TRANSACTIONS WITH PARTIES IN INTEREST

NBT Bank, N.A. provides trustee and custodial services for the Plan, which qualify as party-in interest transactions. Fees incurred and paid directly by the Plan for recordkeeping, loan processing and benefit payment services were approximately \$4,000 for both the years ended December 31, 2024 and 2023. In addition, during both the years ended December 31, 2024 and 2023, fees of approximately \$11,000 for other administrative services rendered by NBT Bank were paid by the Plan sponsor.

NOTE 7 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.
