## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of Alpine Intel 401(k) Plan:

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

## **Basis for Opinion**

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



## NOTES TO FINANCIAL STATEMENTS

### AS OF DECEMBER 31, 2024 AND 2023, AND FOR THE YEAR ENDED DECEMBER 31, 2024

---

#### 1. DESCRIPTION OF THE PLAN

The following description of the Alpine Intel 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the comprehensive Plan document for a more complete description of the Plan’s provisions.

**General**—The Plan is a defined contribution retirement plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA) and became effective on January 1, 1988. The Plan is sponsored by Alpine Intel, LLC (the “Company”) and is joined by the following subsidiaries and/or affiliates of the Company: Donan Engineering, LLC; Donan Solutions, LLC; HVAC Investigators, LLC; Strike Check, LLC; Veracity Research Co., L.L.C.; Alpine Intel Forensics, LLC; Robison Group Investigative Solutions, LLC; and Alpine Intel Commercial Solutions, LLC (collectively, the “Employer”).

During the year ended December 31, 2024, the Company completed the following acquisitions to expand its service offerings and geographic presence. The acquired entities include:

1. Veracity Research Company, LLC (Acquisition Date: April 1, 2024)
2. Techloss Consulting & Restoration, Inc. (Acquisition Date: November 15, 2024; Alpine Intel Forensics, LLC is the new name for Techloss when Alpine acquired it as it was an Asset Purchase)
3. Robison Group Investigative Solutions, LLC (Acquisition Date: November 19, 2024)
4. BSC Experts, LLC (Acquisition Date: December 19, 2024; Alpine Intel Commercial Solutions, LLC (new name for BSC Experts when Alpine acquired it as it was an Asset Purchase)

The qualified defined contribution plans maintained by the acquired entities were terminated through board resolution or plan amendments. Participants from these acquired entities were added to the Plan during 2024 and permitted to rollover the account balances into the Plan. The total amount of rollover contributions associated with the enrollment of these participants was \$1,143,141 and is reported in the total rollover contributions within the statement of changes in net assets available for benefits for the year ended December 31, 2024.

The Plan covers substantially all employees of the Company.

**Plan Amendments**—As a result of the corporate acquisitions described above, the Plan document has been amended to include the names of the following employers: Veracity Research Co., L.L.C.; Alpine Intel Forensics, LLC; Robison Group Investigative Solutions, LLC; and Alpine Intel Commercial Solutions, LLC.

**Trustee and Administration of the Plan**—The recordkeeper of the Plan is Fidelity Workplace Services LLC. The trustee is Fidelity Management Trust Company (“Fidelity” or “trustee”). The administrator of the Plan is the Company. The trustee holds all assets of the Plan in accordance with the

service provider contract with the Company. The Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

**Eligibility**—There is a six-month eligibility waiting period for newly hired employees. During 2024, the Company grandfathered in employees' services during their tenure with the acquired entities for purposes of eligibility and vesting service. Existing employees remain eligible to enter the Plan on the first day of the month on or following the later of their date of hire or attainment of age 21. At that time, participants can begin deferring compensation into the Plan, and become eligible for both the employer matching and discretionary nonelective contributions.

**Contributions**—Participants may contribute up to the maximum allowable annual contribution as defined by the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Employer shall make a safe harbor matching contribution equal to 100% of the participant's elective deferrals up to 3% and 50% of the next 2% of eligible participant's compensation. Participants receive safe harbor matching contributions at the same time 401(k) contributions are contributed. The Employer may also elect to contribute a discretionary nonelective contribution, to be determined by the Employer, although none was made for the year ended December 31, 2024.

**Participant Accounts**—Individual accounts are maintained for each participant of the Plan. Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of Plan earnings. Participant accounts are charged with withdrawals and an allocation of Plan losses and administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

**Vesting**—Participants are vested immediately in their contributions, plus actual earnings thereon. Participants vest in Employer contributions at 20% per year after the first two years of service and become 100% vested after six years of service. With the adoption of safe harbor provisions effective January 1, 2023, participants immediately vests 100% in Employer contributions.

**Investments Options**—Participants may direct the investment of their contributions and any Employer contributions and/or account balances into various investment options offered by the Plan and may change investments and transfer amounts between funds daily.

**Notes Receivable from Participants**—Participants may borrow up to a maximum of the lesser of \$50,000 or 50% of their vested balance, reduced by the highest outstanding loan balance in the preceding 12 months ending on the day before the date of the new loan. The loans are secured by the balance in the participant's account and bear interest at the prime rate, plus 1%. Principal and interest are paid ratably through payroll deductions. Defaults on participant loans are deemed distributions under Internal Revenue Service (IRS) regulations and are reported as deductions from the Plan's net assets. Each participant may only have one loan outstanding at a time. These loans are subject to certain restrictions as defined by the Plan document and applicable restrictions under the IRC.

As of December 31, 2024, participant loans have maturities through 2029 at interest rates ranging from 4.25% to 9.50%.

**Payment of Benefits**—On termination of service due to death, disability, retirement, or other reasons, a participant whose vested account balance is greater than \$5,000 may elect to receive either a single lump-sum distribution, installments over a period of time, or a direct rollover to another qualified plan equal to the value of the participant's vested interest in his or her account. On termination of service, a participant whose vested account balance is not greater than \$5,000 will receive his or her benefits as a

single lump-sum payment or by direct rollover to another qualified plan. Participants are also eligible to make hardship withdrawals from their deferred contributions in the event of certain financial hardships.

**Forfeitures**—Forfeitures may be used to pay any administrative expenses and reduce future employer contributions. Amounts forfeited and available for use as of December 31, 2024 and 2023, were \$74 and \$361, respectively. During 2024, forfeitures totaling \$110,454 were used to reduce Employer matching contributions.

## 2. SUMMARY OF ACCOUNTING POLICIES

**Basis of Accounting**—The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

**Use of Estimates**—The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

**Risk and Uncertainties**—The Plan provides various investment options to its participants. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

**Concentration of Investments**—The Plan has a concentration of investments in two mutual funds at December 31, 2024, and in three mutual funds at December 31, 2023. At December 31, 2024 and 2023, these funds represented 48% and 50%, respectively, of the Plan's investments at fair value. A change in the value of these funds could cause the value of the Plan's net assets available for benefits to change due to this concentration.

**Investment Valuation and Income Recognition**—The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains or losses on investments bought and sold as well as held during the year. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by its investment advisers and trustee. See Note 4 for discussion of fair value measurements.

**Notes Receivable from Participants**—Notes receivable from participants are measured at their unpaid principal balance, plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits**—Benefits are recorded when paid. There were no participants, who elected to withdraw from the Plan, but had not yet been paid at December 31, 2024.

**Contributions**—Employee contributions and employer matching contributions are recorded when withheld from the pay.

**Excess Contributions Payable**—The Plan is required to return contributions received during the Plan year in excess of the IRC limits. Excess contributions payable as of December 31, 2024 were \$2,427. There were no excess contributions due to participants as of December 31, 2023.

**Administrative Expenses**—Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant’s account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments.

### 3. CERTIFIED INVESTMENT INFORMATION

The following is a summary of the information regarding the Plan as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included in the Plan’s financial statements and supplemental schedule that were prepared by or derived from information prepared by Fidelity Management Trust Company, the trustee of the Plan and furnished to the Plan administrator. The Plan administrator has obtained certifications from the trustee that such information is complete and accurate.

### 4. FAIR VALUE MEASUREMENTS

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

**Level 1**—Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2**—Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3**—Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument’s level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used on December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

**Mutual Funds and Money Market Funds**—Mutual funds and money market funds represent investments with various investment managers. The mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

## 5. TAX STATUS

The Plan uses a preapproved plan document sponsored by Fidelity. Fidelity received an opinion letter from the IRS dated June 30, 2020, which states that the preapproved Plan document, as then designed, satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS and has since been amended. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

## 6. PLAN TERMINATION

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are in funds and accounts that are managed by Fidelity or its subsidiaries and affiliates. Participant loan and distribution processing fees are paid to Fidelity by participants. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to Plan operations and investment activity to various service providers.
