In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditors' Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users made on the basis of these financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control–related matters that we identified during the audits.

***Supplemental Schedule Required by ERISA***

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### (1) Description of Plan

The following brief description of the Stockwell Elastomerics Perpetuity Employee Stock Ownership Plan (ESOP or the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

SRC Elastomerics, Inc. d/b/a Stockwell Elastomerics, Inc. (formerly Stockwell Rubber Company, Inc.) (the Company) established the Plan on January 1, 2017, in order to acquire stock of the Company and to provide a retirement program for its eligible employees. The Plan is a stock bonus plan under Section 401(a) of the Internal Revenue Code of 1986 as amended (IRC) and is designated to comply with Section 4975(e)(7) of the IRC and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The ESOP trustee and the Company's Board of Directors are responsible for oversight of the Plan.

In August 2017, the Plan purchased 30,000 shares of common stock of the Company for an aggregate purchase price of \$2,851,085, or \$95.04 per share that was financed by a loan issued to the Company. In September 2021, the Plan purchased an additional 15,000 shares of common stock of the Company for an aggregate purchase price of \$2,400,000, or \$160.00 per share that was financed by a loan issued to the Company. In October 2024, the Plan purchased an additional 27,500 shares of common stock of the Company for an aggregate purchase price of \$7,030,128, or \$255.64 per share that was financed by a loan. The loan was originally issued to the former majority stockholder and was subsequently transferred to the Company.

The borrowings are collateralized by the unallocated shares of common stock and are guaranteed by the Company. The financial statements of the Plan as of December 31, 2024 and 2023, and for the years then ended, present separately the assets and liabilities and changes therein pertaining to:

- a. The accounts of employees with rights in allocated common stock (allocated), and
- b. Common stock not yet allocated to employees (unallocated).

#### **Eligibility**

All employees, other than employees governed by collective bargaining agreements, leased employees, and interns of the Company, become eligible to participate in the Plan after completing 1,000 hours of service in a plan year and attaining at least 18 years of age. Entry into the Plan occurs the first day of January each plan year. Participants who do not have at least 1,000 hours of service during such plan year or are not employed on the last working day of the plan year are generally not eligible for an allocation of Company contributions for such year.

#### *Contributions*

The Company is obligated to either make contributions in cash or shares of Company stock to the Plan which equal the amount necessary to enable the Plan to make regularly scheduled payments of principal and interest due on its term loan. Employee contributions are not permitted.

#### *Payment of Benefits*

Distributions on account of death, disability, or retirement are made in lump sum in the Plan year following the event. Distributions for other separations from service are allowable following the sixth year following the separation from service and may be deferred until the participants normal retirement date. The amount to be distributed is based upon the immediately preceding valuation date. Distributions are made in cash or, if a participant elects, in the form of Company common stock plus cash for any fractional share of common stock.

If a participant terminates employment before their normal retirement age and the vested account balance is less than \$5,000, the participant may elect to receive their distribution by the close of the next plan year. If the vested balance is over \$5,000, they may elect to receive their balance by the end of the sixth plan year following the plan year of termination. If no election is made by the age of 65 or death, payments will be made at that time.

If a participant should die while employed, the beneficiary will be paid the vested value of the account. If the account has not yet begun to be paid out, payments will begin by the end of the plan year following the year in which death occurs and the benefit will be fully paid following the fifth anniversary of the date of death. If a participant dies after payments have already begun, the payments will continue to their beneficiary on the same payment schedule.

If a participant should become permanently disabled while employed by the Company, the participant will be paid the vested value of the account and the payments will begin by the end of the plan year following the year in which the participant was determined to be disabled.

#### *Administrative Expenses*

The Plan trustees control and manage the operation of the Plan. As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the administrative expenses of the Plan.

#### *Voting Rights*

All voting rights of Company common stock are exercised by the trustees. Under certain circumstances such as approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, or sale of substantially all the assets of a trade or business, each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and not held in the unallocated suspense account. Each participant shall have one vote for each share of Company stock in his or her account and the trustees shall vote such allocated shares of Company stock as instructed by participants. Allocated shares for which no direction is received shall be voted by the trustees in their discretion. The trustees are required, however, to vote any unallocated shares on behalf of the collective best interest of plan participants and beneficiaries.

#### *Participant Accounts*

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each plan year with an allocation of cash contributed into the Plan, shares of the Company's common stock released by the trustees from the unallocated account, and forfeitures of terminated participants' nonvested accounts. Each participant account is debited as of the last day of each plan year with an allocation of cash payments made by the trustees for acquisition of Company stock. Only those participants who are eligible employees of the Company as of the last day of the plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant account based on the ratio of the participant's beginning of the year account balance to all participants' beginning of the year account balances.

#### *Vesting*

If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balance in his or her account based on total years of service with the Company. The participants' vesting schedule is as follows:

Participants become 100% vested upon attainment of normal retirement date while employed by the Company, or upon the participant's death or disability.

#### *Put Option*

Under federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the current value of the stock. The Company may pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

#### *Diversification*

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. The trustees may offer alternative investments under the Plan or in another qualified plan maintained by the Company, in lieu of making a cash distribution.

#### *Forfeitures*

Plan forfeitures are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the plan year. There were no unallocated cash forfeitures or shares of common stock as of December 31, 2024 and 2023.

### (2) Summary of Significant Accounting Policies

#### *Basis of Accounting*

The financial statements of the Plan are prepared using the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *Allocations*

The financial statements of the Plan present separately the assets and liabilities and changes therein pertaining to (a) the accounts of employees with rights in allocated stock ("allocated") and (b) stock not yet allocated to employees ("unallocated"), including shares that are committed-to-be-released. Shares are released from collateral and become allocated generally in the period in which debt service is paid.

#### *Investment Valuation and Income Recognition*

The common stock of the Company is stated at estimated fair value. Estimated fair value is determined annually by an independent appraisal. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for fair value measurements.

#### *Investment Valuation and Income Recognition, Continued*

Purchases and sales of securities are recorded on a trade date basis. Realized gains and losses from security transactions are reported on the average cost method. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### *Payment of Benefits*

Benefits are recorded when paid.

#### *Subsequent Events*

The Plan has evaluated subsequent events through October \_\_, 2025, the date the financial statements were available to be issued.

As a result of the pay down of the loan (See Note 5) during 2023, 3,750 shares of the Company's common stock were transferred to the allocated category.

#### (4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Interest bearing cash:* Interest bearing cash deposits are stated at cost plus accrued interest, less outstanding checks, which approximates fair value.

*Stockwell Elastomerics, Inc. common stock:* The Company's common stock is not actively traded, and significant other observable inputs are not available. The fair value of the common stock is determined by an independent valuation firm using accepted valuation methods (discounted cash flows). The inputs used in the valuation of the Company including historical operating results and projected operating financial data, the economic outlook and industry review. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. Additional information on the Company's financial operating results can be obtained from its reviewed financial statements. Plan management, the Plan trustees, and the Company's Board of Directors review and approve the appraisal before it is finalized. As of December 31, 2024 and 2023, the stock was valued at \$161.21 and \$226.06, per share, respectively, and is categorized as level 3.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### *Changes in Fair Value of Level 3 Investments*

During 2024 and 2023, there were no transfers or purchases of the investment included in Level 3 of the fair value hierarchy. The unrealized gain (loss) on the Company's common stock is included in the net appreciation (depreciation) in fair value of investments on the statement of changes in net assets available for benefits.

### (5) Notes Payable

In September 2021, the Plan entered into a \$2,400,000 term loan bearing interest at the thirty-day LIBOR rate plus 350 basis points adjusted annually on the anniversary date of the note. The proceeds of the loan were used to purchase 15,000 shares of the Company's common stock. Unallocated shares were collateral for the loan. Shares were released from collateral and allocated to participants as payments of principal and interest were made. In 2023, the loan was paid in full. This resulted in 3,750 shares being released and allocated for the plan year ended December 31, 2023.

In October 2024, the Plan entered into a \$7,030,128 term loan bearing interest at 4.10% and requiring annual principal and interest repayments of \$521,880 from September 2025 through September 2045. The proceeds of the loan were used to purchase 27,500 shares of the Company's common stock. Unallocated shares are collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral multiplied by the ratio of the current year payments divided by the total of this year's payments, plus all future years' principal and interest payments. In 2024, there was no payment required and therefore no shares were released and allocated for the plan year ended December 31, 2024.

### (6) Related Party Transactions and Party in Interest Transactions

The Plan assets, which consist principally of Company common stock, are administered by the trustees of the Plan. Company contributions are held and managed by the trustees, which invest cash received and interest income, and make distributions to participants. Employees of the Company perform certain administrative functions. No such employees received compensation from the Plan. Administrative expenses may be paid by the Plan or the Company.

### (7) Risks and Uncertainties

The Plan invests primarily in common stock of the Company, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on earnings, cash flows or other such techniques. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimates and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

### (8) Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the interest of each participant in the trust fund shall immediately become fully vested and shall not thereafter be subject to forfeiture. The total amount of an effected participants' account may be paid in a lump sum or may be retained in trust for disposition under the terms of the Plan.

### (9) Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated May 22, 2018, that the Plan and related trust are designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
