Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Wasserstrom Holdings Associates 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN:

The following description of the Wasserstrom Holdings Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees, subject to certain exclusions, as defined, of Wasserstrom Holdings, Inc. and any related companies that have adopted the Plan (collectively, the Employer) who are age eighteen or older (effective January 1, 2025, the age requirement was eliminated). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Participants are permitted to select from several mutual fund investment options. The Plan holds Wasserstrom, Inc. (a C corporation) common stock (the Wasserstrom common stock). The participant's investment in The Wasserstrom common stock may only be sold at certain intervals throughout the year. At the time of sale, the participant's stock is sold to other plan participants who elect to purchase the stock. Since participants are able to direct the sale of The Wasserstrom common stock in their accounts only at certain intervals throughout the year, The Wasserstrom common stock investment is considered nonparticipant-directed. The Plan also allows Employer stock subaccounts for those amounts invested in The Wasserstrom common stock and an unallocated Employer contribution account for those amounts contributed by the Employer but not yet allocated to participants.

Put option

The Wasserstrom common stock that is held by the Plan and its participants is not readily tradable on an established market. Accordingly, under federal income tax regulations, the stock must include a put option. The put option is a right to demand that the Employer buy any shares of its common stock distributed to a participant for which there is no market. The put price is the current fair market value of the stock at the exercise date. The Employer can pay for the purchase as a lump-sum or with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

Contributions

Each year, participants may contribute a portion of their eligible annual compensation, as defined in the Plan, subject to certain limitations established by law. Participants are automatically enrolled in the Plan at 3% of eligible compensation unless the participant has elected otherwise. In addition, all Plan participants experience an automatic step-up in contribution percentage by 1% each year beginning with the first contribution made in July, capping out at a total contribution percentage of 10% of the employee's base compensation. Participants have the option to opt out of the automatic step-up process. Participants are permitted to make elective Roth contributions to the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers).

The Plan provides for discretionary Employer profit sharing and discretionary Employer matching contributions. Discretionary Employer profit sharing contributions are allocated based on participants' wages. Discretionary Employer matching contributions are contributed based on the amount of the participants' elective deferrals.

The Employer did elect to make a discretionary profit sharing contribution for the years ended December 31, 2024 and 2023. The Employer did not make a discretionary Employer matching contribution during the years ended December 31, 2024 or 2023.

Participant accounts

Each participant's account is credited with the participant's contribution and allocations of Employer contributions and Plan earnings and losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings and losses or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Employee deferrals credited to a participant's account, Employer matching contributions and earnings thereon are 100% vested at all times. Profit sharing contributions and earnings thereon become vested based on years of continuous service as noted below. Earlier vesting may occur upon one of the following events: (1) participant's attainment of age 63; (2) death; (3) total or permanent disability; or (4) termination of the Plan.

Payment of benefits

In accordance with the Plan, a participant may receive the vested value of his or her account upon normal retirement at age 63, attainment of age 59½, total disability or termination. Upon the death of a participant, the beneficiary shall be entitled to the full value of the account. Distributions shall be made in a lump sum. Before a participant attains the normal retirement age or age 59½, he or she may elect to withdraw any or all of his or her pretax contributions only in the event of a financial hardship, as defined in the Plan. The Plan administrator must approve all hardship withdrawals and such distribution shall be limited solely to the participant's contributions

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Note terms range from 1-5 years or a longer period of time as determined by the Plan administrator for the purchase of a primary residence. The notes are secured by the balance in the participant's account and bear interest at a rate of prime plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Board of Directors determines the Plan's valuation policies utilizing information provided by the investment advisers, trustee and independent appraiser.

Purchases and sales of securities are recorded on the trade date basis. Interest is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of benefits

Benefit distributions are recorded when paid.

Administrative expenses

Certain administrative expenses are paid by the Employer and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distribution or other participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Certain investment related expenses are included in net appreciation in fair value of investments.

Subsequent events

The Plan evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

3. INFORMATION PREPARED AND CERTIFIED BY TRUSTEE:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the trustee, has certified to the completeness and accuracy of all investments (other than investments in The Wasserstrom common stock) and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental schedule of assets (held at end of year) (other than investments in The Wasserstrom common stock) as of December 31, 2024 and the related investment activity (other than dividends and net appreciation earned on The Wasserstrom common stock) and interest income on notes receivable from participants reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

5. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 or 2023.

- Money market fund: Valued at cost, which approximates fair value.
- Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.
- The Wasserstrom common stock: The fair value of the investment in The Wasserstrom common stock is based upon an independent appraisal obtained by the Plan administrator as of September 30, 2024 and 2023 (which approximated the value as of December 31, 2024 and 2023). This appraisal was based on a discounted cash flow method consistent with prior years. The appraiser took into account projected cash flow and net income, weighted average cost of capital, and a lack of marketability discount. The valuation process includes Plan management accumulating the data for the appraiser based on audited financial statements of the Company. The appraiser prepares a preliminary report which the Plan administrator reviews in detail and approves.

6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

Certain Plan investments are managed by The Vanguard Group and certain administrative fees incurred by the Plan for services from The Vanguard Group are included in administrative expenses. Vanguard Fiduciary Trust Company, an affiliate of The Vanguard Group, is the trustee as defined by the Plan and, therefore, transactions involving these funds qualify as party-in-interest transactions. Additionally, transactions involving shares of The Wasserstrom common stock are party-in-interest transactions. During the years ended December 31, 2024 and 2023, dividend income related to The Wasserstrom common stock amounted to \$26,525 and \$24,939, respectively.

7. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS:

The Employer elected to adopt a non-standardized pre-approved profit sharing plan with CODA. The Internal Revenue Service (IRS) issued an opinion letter dated June 30, 2020 that the Plan is designed in accordance with applicable sections of the IRC. While the Employer has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. As described in Note 1, the Plan holds common stock of Wasserstrom, Inc. During 2024 and 2023, the Plan did not receive unrelated business income related to this investment. Therefore, no provision for income taxes has been included in the Plan's financial statements.

9. FORFEITURES:

As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$113,896 and \$111,055, respectively. Forfeitures may be used to pay Plan expenses or may be allocated to eligible participants on the basis of, and in proportion to, their respective compensation. During the years ended December 31, 2024 and 2023, forfeitures used to pay Plan expenses totaled \$37,558 and \$28,705, respectively.

10. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
