Opinion

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF THE PLAN

The following description of the Ashland Foundry & Machine Works, LLC (Plan Sponsor or Employer) Group Medical Plan (the Plan) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions, copies of which may be obtained from the Plan Sponsor.

General

The Plan provides health and other benefits to eligible employees of the Plan Sponsor and Weatherly Casting & Machine Co LLC, an affiliated employer. All regular full-time employees working at least 30 hours per week are eligible to participate in the Plan upon date of hire.

The Plan was amended effective January 1, 2024, to add Sawbrook Steel Castings Co. as a participating affiliated employer.

Plan assets are held in the Ashland Foundry & Machine Works Health Benefit Trust. These assets are used to provide health care benefits under the Plan. The Health Benefit Trust was established on January 1, 2021. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Benefits

The Plan provides medical and prescription benefits. The Plan also provides continuation of certain benefits if the health coverage ceases through the Consolidated Omnibus Budget Reconciliation Act (COBRA), Uniformed Services Employment and Reemployment Rights Act (USERRA), or the Family and Medical Leave Act (FMLA).

The Plan has a health reimbursement arrangement (HRA) that is funded solely through Company contributions. The HRA allows eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. The HRA balance remaining at the end of the year will be forfeited.

Stop Loss Coverage

The Plan has entered into a stop loss insurance arrangement in an effort to limit its exposure for self-insured benefits (individual participant claims over a specific dollar amount, as well as its aggregate exposure for all claims).

Self-insured Benefits

All Plan benefits are self-insured. The claims for self-insured benefits (medical and prescription) are processed by the Plan's third-party claims processors under administrative services only (ASO) arrangements. The claims processors pay claims directly to or on behalf of participants and are then reimbursed by the Plan's trust or the general assets of the Plan Sponsor. Despite the Plan's utilization of third-party claims processors, ultimate responsibility for payments to providers and participants is retained by the Plan.

Contributions

In addition to deductibles and co-payments, participants contribute specified amounts based on applicable monthly premiums for their respective benefit elections. Participants pay a portion of the premiums for medical insurance based on the current group rate premiums. The Plan Sponsor makes contributions based on the maximum rate per participant as defined by the stop loss contract. If actual claims are less than the amount funded, the surplus is netted against future employer contributions. The surplus for the year ended December 31, 2024 was \$337,997.

HRA contributions are made to the Plan by the Plan Sponsor for qualified medical expenses exceeding the employee's deductible in an amount not to exceed \$2,500 for individuals and \$5,000 for families annually.

The Plan Sponsor makes contributions to the Plan as needed to fund claims in excess of participants' contributions. Any deficiency of the Plan's net assets over benefit obligations is funded by the Plan Sponsor on a pay-as-you-go basis.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements, in accordance with accounting principles generally accepted in the United States of America, requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies and procedures. See Note 4 for discussion of fair value measurements.

Interest income is recorded on the accrual basis of accounting.

Payment of Benefits

Premiums paid by the trust are recorded as premiums paid in the accompanying statement of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have not been reimbursed by the Plan are recorded as claims payable to claims administrators in the accompanying statements of net assets available for benefits.

Stop Loss

Premiums for stop loss insurance are included in premiums paid in the accompanying statement of changes in net assets available for benefits. Refunds due as of the financial statement date are reported as a receivable, with the offset being netted against claims paid. Stop loss refunds totaling \$301,418 have been netted with claims paid in the accompanying statement of changes in net assets for the year ended December 31, 2024.

Administrative Expenses

Substantially all expenses are paid by the Plan.

Subsequent Events

Management evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

3. CLAIMS INCURRED BUT NOT REPORTED

Plan obligations as of December 31, 2024 and 2023, for claims incurred but not reported, are estimated by the Plan Sponsor based on claims data provided by the Plan's third-party claims administrator. These amounts are paid by the Plan only if claims are submitted and approved for payment.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Interest-bearing cash – Valued at cost, which approximates fair value, and classified within Level 1 of the valuation hierarchy.

5. ADMINISTRATIVE EXPENSES

The Plan pays expenses related to administrative fees paid to third-party claims administrators, management fees, and broker expenses. These expenses are reported on the statement of changes in net assets available for benefits as administrative expenses.

6. TAX STATUS

A trust was established under the Plan to hold the Plan's assets. The trust applied for an EIN under the Internal Revenue Code effective January 1, 2021. From time to time, the interest earned on the Plan's interest-bearing cash may be subject to income taxes. There were no material federal or state income taxes owed during the year ended December 31, 2024.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if it has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to modify the benefits provided to participants, the right to modify the contributions required of participants, the right to discontinue its contributions, and the right to terminate the Plan, subject to the provisions of ERISA. In the event the Plan terminates, remaining assets will be applied in a uniform and nondiscriminatory manner toward the provision of benefits for or on account of the participants. No assets of the Plan may revert to the Plan Sponsor or be used for purposes other than for the exclusive benefit of the Plan's participants.

8. PARTY IN INTEREST TRANSACTIONS

The Plan has several arrangements with service providers as described in Notes 1 and 5. The Plan's interest-bearing cash is held by UMB Bank, the custodian of the Plan. These transactions are party in interest transactions under ERISA.

9. RISKS AND UNCERTAINTIES

The Plan maintains cash balances at a financial institution. The cash balances are secured by the Federal Deposit Insurance Corporation (FDIC) up to applicable FDIC limits. At times, the Plan's deposits may exceed insured limits.

The Plan Sponsor's estimate of benefit obligations is subject to certain assumptions that are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near-term would be material to the financial statements.
