INDEPENDENT AUDITORS' REPORT

To the Plan Management of
Miller & Long Employees Combined Retirement Plan

SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT

We performed audits of the accompanying financial statements of the Miller & Long Employees Combined Retirement Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, the related Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

OPINION ON THE FINANCIAL STATEMENTS

BASIS FOR OPINION

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; this includes the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

NOTE 1 **DESCRIPTION OF PLAN**

The following brief description of the Miller & Long Employees Combined Retirement Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan documents or the Summary Plan Description for more complete information.

General

The Plan is a defined contribution plan open to all full-time employees of Miller & Long Co., Inc. and Miller & Long DC, Inc. (collectively referred to as the Company). Employees who complete 90 days of service with the Company, as defined in the Plan, are eligible to participate. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Investment Committee is responsible for the oversight of the Plan and determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the Plan's Board of Trustees.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes matches at the Company's discretion. The Company also makes prevailing wage contributions (wage rate contributions) based upon Davis-Bacon Act compensation paid to eligible employees of the Plan. The Company may also make a profit-sharing contribution at the discretion of the Board of Directors. There were no profit-sharing contributions made to the Plan for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

Participant Accounts

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of any Plan earnings. Participants' accounts are charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, Company matching contributions, and Company wage rate contributions, plus actual earnings thereon. A participant's interest in the Company's discretionary profit-sharing contributions becomes fully vested and nonforfeitable upon five years of service credited as defined by the Plan.

Upon enrollment in the Plan, a participant may direct contributions to specified investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options at any time.

Notes Receivable From Participants

Participants may borrow from their fund accounts up to the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years. The loans are secured by the balance in the participant's account. The loan interest rate is set at the prevailing rate at the time of making the loan. Principal and interest are paid ratably through weekly payroll deductions.

Payment of Benefits

In the case of normal retirement, retirement due to permanent disability, or termination of employment, a participant may elect to receive the value of the participant's account in a lump-sum distribution or mutually agreed-upon alternative manner. If a participant dies before retirement, the beneficiary will receive the value of the participant's account in a lump-sum distribution or mutually agreed-upon alternative manner.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and excluded from these financial statements. In addition, the Company provides services to the Plan without charge.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$300,663 and \$2,396, respectively. These accounts will be used to reduce the Company's contributions and administrative expenses in accordance with the Plan documents. In 2024, the Company's contributions and administrative expense of the Plan were reduced by forfeitures of \$8,136 and \$11,637, respectively.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Accounting Standards Codification

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

Basis of Accounting

The accompanying financial statements were prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

Valuation of Investments

The Plan's investments are reported at fair value, except for fully benefit responsive investment contract which are reported at contract value. See Note 4 for a discussion of fair value measurements.

Payments of Benefits

Benefits are recorded when paid.

Risk and Uncertainties

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

Notes Receivable From Participants

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

Subsequent Events

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 6, 2025, the date the financial statements were available to be issued.

NOTE 3 **INFORMATION CERTIFIED BY THE CUSTODIANS**

Plan investments were held by the Custodians, Principal Trust Company and Principal Life Insurance Company, at December 31, 2024 and 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. That information, which was not audited by independent auditors, is summarized below.

NOTE 4 **VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the Codification are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

(See Independent Auditors' Report)

Level 2 Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value. There was no change in the methodologies used at December 31, 2024 and 2023.

Money Market Fund and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Account/Common and Collective Trusts: Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

Equity Limited Partnership: Stated at the estimated fair values based on the value of the underlying net assets as provided by the Custodians of the investment. The real estate equity limited partnership uses a projected discounted cash flow model based on the underlying agreements. The discount rates utilized are those for similar investments and current market conditions. The value of the Plan's investment is calculated on the NAV based on ownership interest. The investment in venture capital and private investment companies is based on a review of the audited financial statements and valuations included therein of the underlying investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 **GUARANTEED INVESTMENT CONTRACT**

The Plan has an investment in the Principal Fixed Income Guaranteed Option Account, which is a fully benefit responsive investment contract and, therefore, reported at contract value. Contract value, as reported to the Plan by Principal, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

(See Independent Auditors' Report)

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 6 **PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

NOTE 7 **TAX STATUS**

The Plan adopted a non-standardized Volume Submitter Profit Sharing Plan with a cash or deferred arrangement sponsored by Principal Life Insurance Company. The Volume Submitter Plan received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020 that stated the Plan and related trust were designed in accordance with applicable requirements of the IRS. The Plan since was amended. The Plan Administrator believes the Plan is currently designed and operating in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

NOTE 8 **RELATED-PARTY TRANSACTIONS**

The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid \$113,400 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 9 **COMMITMENTS**

The Plan maintains investments in private equity limited partnerships. As of December 31, 2024 and 2023, the original commitments in the equity limited partnerships totaled \$2,000,000. As of December 31, 2024 and 2023, the unfunded capital commitments totaled \$84,499.
