We have performed audits of the financial statements of NREL 403(b) Employee Savings Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 and 2023

1. DESCRIPTION OF THE PLAN

The following description of the NREL 403(b) Employee Savings Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – Alliance for Sustainable Energy, LLC (the “Organization”) established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Organization, as defined in the universal availability standards, may enter the Plan once the requirements are satisfied. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”) for employees of the Organization.

State Street Bank and Trust Company, Empower Annuity Insurance Company of America (“Empower”) and Teacher’s Insurance and Annuity Association and College Retirement Equities Fund (“TIAA-CREF”) are trustees of the Plan. Transamerica Financial Life Insurance Company, Inc. (“Transamerica”) is a custodian of the Plan and also serves as the Plan’s recordkeeper. The Organization is the administrator of the Plan.

Contributions – Participants may contribute on a pre-tax or after-tax Roth basis amounts up to certain Internal Revenue Code (“IRC”) limitations. Participants age 50 or over are permitted to make catch-up contributions, as defined in the Plan. Employees hired or rehired are automatically enrolled in the Plan at a pre-tax deferral rate of 5%, unless the participant elects a different deferral rate or not to participate.

The Organization matches 50% of the first 5% of each participant’s pay contributed to the Plan for eligible participants.

Participant Accounts – Each participant’s account is credited with the participant’s voluntary contributions, the Organization’s contributions, and charged with the participant’s withdrawals and distributions, and an allocation of Plan earnings and expenses. Allocations of general expenses are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account balance.

Investment Options – Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers mutual funds, money market funds, pooled separate accounts, insurance company general accounts, guaranteed annuity contracts, and self-directed brokerage accounts as investment options. Employees previously had the ability to invest in investments offered by TIAA-CREF and certain investments offered by Empower. No current contributions may go into these investments.

Vesting – Participants’ contributions and the Organization’s contributions are fully vested at all times.

Payment of Benefits – Upon termination of service due to death, a lump sum amount equal to the value of the participants’ vested interest in his or her account will be paid to a designated beneficiary. Disabled, retired and terminated employees may remain in the Plan or receive a lump sum distribution or annuity.

In-Service Withdrawals – As described below, certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant's account balance that is 100% vested.

Participants who have obtained the age of 59 ½ may elect to receive an in-service distribution of all or any portion of their vested account balances in a single lump sum payment.

Participant Investment Rollovers – Participants are allowed to transfer or rollover funds into the Plan from other qualified plans.

Notes Receivable from Participants – Participants may borrow from their account balances, with interest charged at a rate set by the Plan Administrator, which remains in effect for the duration of the loan. Loan terms range from 1 to 5 years or up to 30 years for the purchase of a primary residence. The minimum loan is \$1,000 and the maximum loan is the lesser of \$50,000, or 50% of the participant's account balance. The loans are secured by the balance in the participant's account. Principal and interest are paid ratably through payroll deductions. Participants may only have one loan outstanding at any time.

Plan Loans – Plan loans between participants and TIAA-CREF are required to have 110% of the loan's principal balance deposited in the TIAA Traditional investment option. This serves as collateral for the loan. The loans are funded by TIAA-CREF and interest paid on the loans is earned by TIAA-CREF and not the Plan. Participants earn interest on their money in the TIAA Traditional investment. The loans outstanding with TIAA-CREF at December 31, 2024 and 2023 were \$47,122 and \$44,794 respectively. These loans are not included on the Statements of Net Assets Available for Benefits, however, the collateral required by TIAA-CREF is included on the Statements of Net Assets Available for Benefits.

Professional Fees – The Plan pays the majority of permitted expenses, such as investment, recordkeeping and auditing fees, for the Plan. Investment related expenses in the form of an expense ratio, ranging from .04% to 1.52%, charged to each investment option are included in the net appreciation on fair value of the investments. Expenses totaled \$546,607 for 2024. The Organization may pay other professional fees associated with the Plan, which are excluded from these financial statements.

Termination of the Plan – Although the Organization has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all remaining Plan assets would be allocated to the participants as described in the full text of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of certain assets, liabilities, and disclosures. Actual results could differ from those estimates.

Concentrations, Risks and Uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participant's account balances and the

amounts reported in the Statements of Net Assets Available for Benefits. As of December 31, 2024, there was one investment that individually represented 11% of investments held, the other investments did not individually represent more than 10% of investments held. As of December 31, 2023, there were no investments that individually represented more than 10% of investments held.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Organization by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Contract value is the relevant measure for the portion of the net assets available for fully benefit-responsive investments contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. See Note 4 for discussion of fair value measurements and Note 5 for additional information on investment contracts held by the Plan.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income/(loss) is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, money market funds and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment income for such investments.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans, except loans with TIAA-CREF, are reclassified as distributions based upon the terms of the Plan Document. No allowance is considered necessary.

Payment of Benefits – Benefit payments are reported in the year paid.

Administrative Expenses – Administrative expenses may be paid by the Organization or the Plan, at the Organization’s discretion.

Subsequent Events – Subsequent events have been evaluated through October 9, 2025, which is the date the financial statements were available to be issued. There were no events or transactions discovered during the evaluation that require recognition or disclosure in the financial statements.

3. INFORMATION CERTIFIED BY THE TRUSTEES/CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosures under ERISA. Accordingly, State Street Bank and Trust Company, Transamerica Financial Life Insurance Company Inc., Empower Annuity Insurance Company of America and Teacher’s Insurance and Annuity Association and College Retirement Equities Fund, qualified institutions and the trustees and custodian of the Plan, have certified the following information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate to the best of their knowledge and belief:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.

- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified information, except for comparing such certified information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

4. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The hierarchy consists of three broad levels, described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the lines presented in the Statements of Net Assets Available for Benefits.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

Mutual Funds and Money Market Funds – Valued at the published net asset value (“NAV”) of shares held by the plan at year end.

Guaranteed Annuity Contracts and Non-Fully Benefit-Responsive Insurance Company General Accounts – Reported at fair value which is based on contract value. The contract value is the aggregation of contributions, plus interest, less withdrawals, if any. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. Additionally, the discretionary rate applied to contributions received during a reporting period may vary from the discretionary rate applied to account balances at the end of the prior reporting period. Contract value approximates a discounted cash flow value calculated using an appropriate risk-adjusted market discount rate which correlates closely with historical crediting rates.

Empower Pooled Separate Accounts – The investment advisors calculate a unit value (NAV as a practical expedient) of the separate account. It is the sum of the market value of the underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

TIAA Pooled Separate Account – The value of the pooled separate account is determined at the close of each business day at the unit value which is based on the fair value of the underlying assets, which can consist of real estate properties, mutual funds, and securities. The value of the underlying real estate properties is determined by an external appraisal on a periodic basis, which are estimates based on professional opinions. The value of the underlying investments in the registered investment companies and securities are based on the daily value of the underlying registered investment companies and securities on an open market. There are restriction on the trading and withdrawals of funds from this investment, generally transfers out can be executed on any business day but may be limited to once per calendar quarter. Other limited exception may also apply.

Self-Directed Brokerage Accounts – Previously, certain participants could invest in these accounts which consisted of money market funds and mutual funds. The money market funds and mutual funds are valued as described above.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. INSURANCE COMPANY GENERAL ACCOUNT AND GUARANTEED ANNUITY CONTRACTS

The Plan has entered into various investment contracts with various service providers. This is comprised of two different types of contracts: those that meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value and those that do not meet the fully benefit-responsive investment criteria and therefore are reported at fair value which is based on contract value.

The type of contract which a participant enters into determines the applicability of certain account features, such as the guaranteed minimum interest rate, additional amounts paid, the degree of liquidity of the participant’s account and the options for receiving income upon retirement. On the non-fully benefit-responsive contracts there may be restrictions on lump sums, certain surrender charges, and requiring cash withdrawals spread over a period of up to 10 annual installments. Fully benefit-responsive contracts do not have such restrictions.

Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the

Plan. Each contract has a specified crediting interest rate which cannot be below 0% and for the various contracts held by the Plan in general range from 1% to 3%. These crediting interest rates may be set for the term of the contract or may be reset on a regular basis as determined by the contract. When establishing interest crediting rates, the issuer considers many factors including current yield of the underlying assets, the duration of the contract and the existing difference between fair value and contract value of such underlying assets.

The Plan's ability to receive amounts due in accordance with the contracts is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its' contractual obligations may be affected by future economic and regulatory developments. There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to be a qualified Plan under the IRC
2. Premature termination of the contract
3. Plan termination or merger
4. Changes to competing investment options
5. Other Plan Sponsor events

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. TAX STATUS

The Plan, together with the investment vehicles, is intended to be a tax-sheltered annuity plan under Section 403(b) of the Internal Revenue Code of 1986, as amended. The Plan has not requested or obtained a determination letter, as the IRS does not currently provide that service for 403(b) plans. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

7. EXEMPT RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments include investments managed by trustees or custodian of the Plan. Indirect payments to the custodian and trustees by the Plan were netted against investment income for the year ended December 31, 2024. The Plan issues loans to participants which are secured by the vested balance of the participants' accounts. An employee may also initiate a note with TIAA-CREF using their account balance as collateral for the note. Transactions in such investments qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules.

The Plan paid \$403,391 of administrative fees during the year ended December 31, 2024. The Organization provides certain administrative services at no cost to the Plan.

8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500

Participant loans are reported as notes receivable from participants in the accompanying financial statements as required by current authoritative guidance; however, for Form 5500 purposes and reporting on the supplemental Schedule of Assets (Held at End of Year) they are shown as investments, as required.

9. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
