Independent Auditor's Report

To the Plan Administrator

*Scope and Nature of the ERISA Section 103(a)(3)(C) Audit*

We have performed audits of the financial statements of Winchendon School 403(b) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C)"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements,

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. ## Notes to Financial Statements December 31, 2024

### Note 1 - Description of Plan

The following description of the Winchendon School 403(b) Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document, and any amendments thereto, for a more complete description of the Plan's provisions.

#### General

The Plan is an Internal Revenue Code ("IRC") Section 403(b) defined contribution retirement plan covering all eligible employees of Winchendon School, Inc. and Winchendon School - Brooklyn (collectively referred to as the "School"). Student employees, union employees, nonresident aliens, and reclassified employees are excluded from participating in the Plan. All other employees of the School are eligible to participate in the Plan immediately following their date of hire. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA") and the IRC. The Board of Trustees is responsible for oversight of the Plan. The Plan's Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees.

#### Contributions

Each year, participants may make salary deferral contributions to the Plan equal to a portion of their pre-tax annual compensation, as defined by the Plan, up to IRC limits. Effective June 1, 2024, the Plan was amended to allow participants to designate all or a portion of their salary deferral contributions as Roth deferral contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan.

#### Matching and nonelective contributions

The School contributes matching contributions to the Plan on behalf of each eligible participant. Any participant age 18 or older becomes immediately eligible for the School's matching contributions upon the completion of two years of service, as defined. The School will make a matching contribution to each eligible participant, in accordance with the table below:

<u>Period of service</u>	<u>Matching contribution</u>
From the date of eligibility through the participant's 10th anniversary of employment	100% of the first 5% contributed
Following the participant's 10th anniversary of employment	100% of the first 10% contributed

For those employees who have prior service at another educational organization, teaching institution, or institution of higher education, the Plan will credit those years of service for the purposes of determining the level of School matching contributions that apply with respect to a participant.

The School may also make discretionary nonelective contributions to the Plan; however, no such contributions were made to the Plan for the year ended December 31, 2024. Participants also direct the investment of the School's matching and any nonelective contributions. All contributions are subject to certain IRC limitations.

#### Participant accounts

Each participant's account is credited with the participant's contributions and the School's matching contributions as well as an allocation of any School nonelective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Notes receivable from participants

Participants may borrow from certain portions of their account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is set at the time of loan using the prime rate as published in *The Wall Street Journal* plus 1%. Principal and interest payments are made by participants directly to Teachers Insurance and Annuity Association of America ("TIAA") and College Retirement Equities Fund ("CREF").

#### Vesting

Participants are vested immediately in all contributions to their account plus actual earnings thereon.

#### Payment of benefits

On termination of service due to death, disability or normal retirement, a participant with account balances of \$5,000 or less will receive a lump-sum distribution. Participants with account balances greater than \$5,000 may elect to receive a single lump-sum amount, partial payments, installment payments for a specified term or purchase of an annuity contract equal to the value of the participant's vested interest in his or her account. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.

Withdrawals from the salary deferral portion of a participant's account may be made in the event of a financial hardship, in accordance with the provisions specified in the Plan. Withdrawals from a participant's rollover account may also be made at any time, in accordance with the provisions specified in the Plan. Additionally, in-service withdrawals are allowed in accordance with the provisions specified in the Plan for participants who have attained age 59½ or for the employer contribution portion of a participant's account balance provided they have been a participant for at least five years.

### Note 2 - Summary of accounting policies

#### Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in three types of fixed annuity contracts, of which two are considered fully benefit-responsive.

#### **Investment valuation and income recognition**

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value (see Note 4). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by TIAA and CREF. See Note 5 for discussion of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### **Notes receivable from participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

#### **Contributions**

Contributions from Plan participants and the matching contributions from the School are recorded in the year in which the employee contributions are withheld from compensation. Any nonelective contributions from the School are recorded in the year in which the contributions are earned.

#### **Payment of benefits**

Benefit are recorded when paid.

#### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the School. Expenses paid by the School are excluded from these financial statements. Indirect investment related expenses are included in the net appreciation in fair value of investments. Fees related to the administration of notes receivable from participants and a direct quarterly servicing fee payable to TIAA and CREF are presented as administrative expenses in the accompanying statement of changes in net assets available for benefits.

#### **Use of estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### **Subsequent events**

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

#### Note 3 - Certified investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Investments and notes receivable from participants held at December 31, 2024 and 2023, and investment income and interest income on notes receivable from participants for the year ended December 31, 2024, that are disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) (Schedule H, Line 4i), were obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by TIAA and CREF.

#### Note 4 - Investment contracts with insurance company

The Plan has entered into traditional fully benefit-responsive fixed annuity contracts with TIAA, an insurance company, referred to as the TIAA Traditional Annuity, totaling \$359,304 and \$347,739 as of December 31, 2024 and 2023, respectively. TIAA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The fixed annuity contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. Additional amounts above the guaranteed minimum interest rate may be declared at the discretion of the TIAA Board of Trustees on a year-by-year basis.

As described in Note 2, because the investment contracts are fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contracts. Contract value, as reported to the Plan by TIAA, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer and ranges between 1% and 3% and has the potential for additional interest if declared by TIAA.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the contract issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers, and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's

investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without the consent of the issuer.

The fixed annuity contracts do not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The Plan has also entered into a fixed annuity contracts with TIAA through an investment in the TIAA Stable Value Fund totaling \$19,193 and \$18,211 as of December 31, 2024 and 2023, respectively. This investment is also considered to be fully benefit-responsive.

#### Note 5 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets ("Level 1") and the lowest priority to unobservable inputs ("Level 3"). The three levels of the fair value hierarchy under Financial Accounting Standards Board issued Accounting Standards Codification 820, *Fair Value Measurement*, are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability; and
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds:* Valued at the daily closing price as reported by the funds. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Variable annuity contracts:* Contracts with CREF are valued at the unit value as reported by the accounts. The unit values are listed on the National Association of Securities Dealers Automated Quotations ("NASDAQ") website and updated overnight for each day that the NASDAQ is open. The accounts held by the Plan are deemed to be actively traded (Level 1).

The Plan also invests in variable annuity contracts with TIAA in the form of TIAA Access Accounts. The accounts are valued at the accumulation unit value ("AUV") of units held by the Plan at year-end. The AUV is based on the value of underlying investments, which are valued using market quotations or prices obtained from independent pricing sources who may employ various pricing methods to value the investments including matrix pricing less its liabilities and account charges, plus any applicable dividend income, then divided by the number of units outstanding. The accounts allow for daily redemptions and contributions (Level 2).

*Non-fully benefit-responsive fixed annuity contract:* Valued based on the accumulated cash contributions and interest credited to the Plan's contract, less withdrawals. Crediting rates are a combination of a guaranteed rate and an annually established discretionary rate. This annuity contracts are not available for sale or transfer on any securities exchange. Withdrawals under the retirement annuity contract may be made in the form of a life annuity or in 10 annual installments. The fully benefit-responsive fixed annuity contract is valued as described in Note 4.

*Pooled separate account:* Valued at the unit value reported by the account. The unit value is listed on the NASDAQ website and updated overnight for each day that NASDAQ is open. The pooled separate account held by the Plan is deemed to be actively traded.

#### Note 6 - Plan termination

Although it has not expressed any intent to do so, the School has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

#### Note 7 - Plan loans

Participants were allowed to borrow from TIAA using the assets in certain portions of the participant's account as collateral. Under this arrangement, TIAA has the right to collect the collateral in the event of a default. Principal and interest payments are made directly by participants to TIAA. Effective January 1, 2022, the Plan loan program offered by TIAA was discontinued; however, Plan participants may continue to borrow from certain portions of their account in the form of notes receivable (see Note 1). At December 31, 2024 and 2023, Plan loans totaling \$1,684 and \$3,277, respectively, were outstanding under this arrangement. There were no plan loans in default as of December 31, 2024 and 2023.

#### Note 8 - Tax status

The Plan has been designed using a volume submitter 403(b) plan document sponsored by PASI, LLC. The IRS has informed PASI, LLC by an advisory letter dated March 31, 2017, in which the IRS stated that the volume submitter 403(b) plan document, as then designed, satisfies the applicable requirements of the IRC. Although the Plan itself has not received a determination letter from the IRS, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and tax-exempt.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 9 - Related party and party-in-interest transactions**

Certain Plan investments are proprietary investments managed by TIAA and CREF. TIAA and CREF are the insurance entities holding certain investments of the Plan and also the recordkeeper as agent for TIAA Trust, N.A., the custodian holding other investments of the Plan. Therefore, these transactions qualify as party-in-interest transactions. Indirect fees were incurred by the Plan for TIAA and CREF investment management services and are included in the net appreciation in fair value of investments. For the year ended December 31, 2024, direct fees of \$8,291 paid to TIAA and CREF for certain administrative expenses were charged directly to participant accounts and are included in administrative expenses. The School pays directly any other fees related to the Plan's operations. The Plan allows participants to take loans against certain portions of their account balance, which are also considered party-in-interest transactions.

Effective May 1, 2024, all TIAA-CREF proprietary mutual funds and TIAA-CREF Lifecycle funds were renamed Nuveen funds. TIAA is the parent company of Nuveen, therefore, the Nuveen funds are considered proprietary assets and also qualify as party-in-interest transactions.

The Plan has entered into a revenue sharing agreement with TIAA and CREF. The Plan's revenue sharing account totaled \$881 and \$0 as of December 31, 2024 and 2023, respectively. The Plan received revenue sharing credits from TIAA and CREF in the amount of \$4,911 for the year ended December 31, 2024, which is included in other income in the accompanying financial statements. These amounts may be used to pay Plan administrative expenses or reallocated to Plan participants. The Plan utilized \$4,055 from the revenue sharing account during the year ended December 31, 2024 to pay certain investment advisory fees related to the Plan.

#### **Note 10 - Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
