Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Woodson Wholesale Inc. Profit Sharing/401k Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits - modified cash basis as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits - modified cash basis for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Woodson Wholesale Inc. Emphasis of Matter - Basis of Accounting

We draw attention to Note 2 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Woodson Wholesale Inc. Profit Sharing/401k Plan and Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. Plan Description

The following description of the Woodson Wholesale Inc. Profit Sharing/401k Plan and Trust (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Woodson Wholesale Inc. and affiliates (the "Company" or "Plan Sponsor"), age 21 or older that are not excluded employees per the plan document. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan Sponsor may make discretionary matching or nonelective contributions to the Plan. Contributions are subject to certain limitations.

Participant accounts

The Plan currently offers mutual funds and common collective trusts as investment options for participants. Each participant's account is credited with the participant's contribution and allocations of Plan earnings and the employer's contribution. Allocations are based on participant earnings or account balances, as defined. Each participant is entitled to the benefit that can be provided from his or her vested account.

Vesting

Participants vest immediately in their own contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus earnings thereon is based upon years of continuous service. Participants are 100% vested in profit sharing contributions and matching contributions after 3 years of service.

Forfeited accounts

Forfeited accounts may be used to reduce future administrative expenses or plan sponsor contributions. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$4,099 and \$2,415, respectively. During the year ended December 31, 2024, forfeitures of \$3,354 were used to reduce administrative expenses and \$7,213 were used to reduce plan sponsor contributions.

Notes receivables from participants

Participants may borrow from their fund accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Loan transactions are treated as transfers to (from) their investment funds from (to) the Participant Loans fund. Loan terms may range up to 5 years for most loans and up to 30 years for the purchase of a primary residence, are secured by the balance in the participant's account, and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the plan administrator. Principal and interest on loans is to be repaid through payroll deductions.

Payments of benefits

Plan benefits are available upon termination of employment, death, disability, or retirement. A participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Participants with a vested account balance greater than \$5,000 may also elect to defer payment of his or her account.

The Plan also allows for in service withdrawals in limited circumstances, as defined by the Plan.

2. Summary of Significant Accounting Policies

Basis of accounting

The financial statements of the Plan are prepared using the modified cash basis of accounting. This basis differs from accounting principles generally accepted in the United States of America in that contributions and interest income are recognized when received and expenses are recorded when paid or deducted from the Plan.

Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Notes receivable from participants

Notes receivable to participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the cash basis.

2. Summary of Significant Accounting Policies - continued

Investment valuation and income recognition

Plan investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income and capital gains are recorded on the cash basis.

Payment of benefits

Benefits are recorded when paid.

Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are not recorded as liabilities in the accompanying statement of net assets available for benefits prepared under the modified cash basis of accounting. There were no excess contributions payable as of December 31, 2024.

Administrative expenses

Certain expenses of the Plan have been paid by the plan sponsor and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

Date of management's review

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued. No additional modifications or disclosures were deemed necessary.

3. Certified investment information

Certain information related to investments and notes receivable from participants are disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 was obtained by management and agreed to or derived from information certified as complete and accurate by Alerus Financial, N.A., the trustee of the Plan.

4. Investments

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy in accounting literature consists of three broad levels: Level 1 inputs have the highest priority, and Level 3 inputs have the lowest priority. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. The three levels of the fair value hierarchy are described below.

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; or other inputs that are observable or can be corroborated by observable market data for substantially the full terms of the assets or liabilities.

Level 3 - Inputs to the valuation methodology are unobservable.

Mutual funds - The fair value of mutual funds is based on quoted market prices of the share held by the Plan at year-end.

Common collective trusts - The fair value of the funds are valued at net asset value of collective trusts, as provided by the fund manager, a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant directed redemptions are allowed daily with no restrictions. There are no unfunded commitments.

5. Plan termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested.

6. Party-in-interest transactions

Plan assets include notes receivable from participants. These transactions also qualify as party-in-interest transactions. Investment fees and expenses associated with Plan administration are paid to certain parties-in-interest. All of these transactions are exempt from the prohibited transaction rules under ERISA.

7. Tax status

The Plan sponsor has adopted a pre-approved plan and is relying on the pre-approved plan's IRS opinion letter for qualification. In the pre-approved plan's opinion letter dated June 30, 2020, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Plan management is required to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examination for years prior to 2021.

8. Plan administration

Certain administrative functions are performed by officers or employees of the plan sponsor. No such officer or employee receives compensation from the Plan.

9. Risks and uncertainties

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
