Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note C to the financial statements, is complete and accurate.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

A. DESCRIPTION OF PLAN

The following brief description of the Greencastle Associates, LLC 401(k) Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a defined contribution plan covering all employees of Greencastle Associates, LLC (the "Company"). Employees who are 21 years of age or older are eligible to enroll into the Plan on their hire date and are eligible for safe-harbor matching contributions after one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Lincoln National Life Insurance Company (the "Custodian") is the custodian of the Plan.

Contributions

Each year, participants are able to contribute up to 100% of eligible compensation, as defined in the Plan document, subject to certain limitations under the Internal Revenue Code ("IRC"). The Plan utilizes auto-enrollment with an automatic withholding of 1% of eligible compensation unless the participant elects otherwise. Contributions can be made as pre-tax contributions or as Roth contributions. Catch-up contributions and rollover contributions are also permitted. In-Plan Roth conversions are also permitted. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a variety of mutual funds, common collective trust funds, and a stable value fund as investment options for the participants.

The Company makes a safe-harbor matching contribution equal to 100% of a participant's contribution up to 3% of a participant's eligible compensation. For the year ended December 31, 2024, employer safe-harbor matching contributions totaled \$307,426.

The Company, at its discretion, may also make a discretionary profit sharing contribution each year. The profit sharing contribution for the year ended December 31, 2024, was \$261,003.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contributions, and (b) Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the safe-harbor contributions. Vesting in the Company's discretionary contributions is based on years of continuous service. A participant is 100% vested in the Company's discretionary contributions after six years of continuous service.

A. DESCRIPTION OF PLAN (CONTINUED)

Notes Receivable from Participants

From their fund accounts, participants may borrow a minimum of \$1,000, up to a maximum of \$50,000 or 50% of their account balance, whichever is less. The Plan's loan policy only permits one outstanding loan at a time. The notes receivable are secured by the account balance in the participant's account. Each note receivable will bear a rate of interest and must be repaid within five years by equal payments at least quarterly, except for a note receivable to buy the participant's principal residence, which can be repaid over more than five years, but within a reasonable timeframe. Notes receivable as of December 31, 2024 carried an interest rate of 10.00% to 10.50%, and notes receivable as of December 31, 2023, carried an interest rate of 7.50% to 10.50%.

Payment of Benefits

On termination of service due to death, disability or retirement, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account if the amount of vested interest is \$5,000 or less. If the amount of vested interest is greater than \$5,000, a participant may elect to receive his or her distribution in a lump sum or in monthly, quarterly, semi-annual or annual installments over a fixed period of time that does not exceed the life expectancy of the participant as determined by published life expectancy rate tables.

Forfeitures

Amounts forfeited by Plan participants are allocated to a forfeitures account. Forfeited amounts are used to pay Plan expenses or reduce employer contributions into the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$62,843 and \$23,114. During the year ended December 31, 2024, no forfeitures were used.

Plan Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Certain expenses, such as brokerage fees, are borne by the participants.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP") requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Investments Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are recorded as outstanding principal plus accrued interest. A participant will be considered to be in default with respect to a loan if any scheduled repayment with respect to such loan is not made by the end of the calendar quarter following the calendar quarter in which the missed payment was due. Such loans are treated as deemed distributions for financial statement purposes.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Excess Contributions Payable

Amounts payable for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Subsequent Events

Management has evaluated subsequent events for potential recognition and disclosure through October 3, 2025, the date the financial statements were available to be issued. No items were determined by management to require disclosure.

C. INFORMATION CERTIFIED AND PROVIDED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian, a qualified institution, has certified that the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024.
- Total investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

C. INFORMATION CERTIFIED AND PROVIDED BY THE CUSTODIAN

- Investment information and notes receivable from participants included in the schedule of assets (held at end of year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of the Plan administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

D. INVESTMENT IN LINCOLN STABLE VALUE FUND

The Plan invests in the Lincoln Guaranteed Stable Value Fund (the "Stable Value Fund"). The Stable Value Fund is a fully benefit-responsive fixed annuity contract that guarantees a fixed rate of interest. The credited interest rate may be based on an index rate specified in the contract or a declared rate, either of which may be changed quarterly and will never be below the guaranteed rate. The Stable Value Fund is backed by the general account assets of the issuing company.

Contract value represents the amount participants would receive if they were to initiate a benefit-responsive transaction under the terms of the ongoing plan. Group fixed annuity contracts are between the Plan and the issuer and may not be assigned or sold to another party without the consent of the issuer.

E. FAIR VALUE MEASUREMENTS

The Accounting Standards Board Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in less active markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

E. FAIR VALUE MEASUREMENTS (CONTINUED)

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in the methodologies used at December 31, 2024.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end.

Common collective trust funds: valued at NAV as reported to the Plan by the Custodian based on the market values of the underlying investments of the fund. The fund is not required to publish a daily NAV, therefore the NAV is a practical expedient in determining the fair value of the funds

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Changes in Fair Value Levels

To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another. In such instances, the transfer is reported at the end of the reporting period.

The Plan evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the years ended December 31, 2024 and 2023, there were no transfers into or out of Level 3.

F. TERMINATION OF THE PLAN

Although it has not expressed any intent to do so, the Company may terminate, amend, modify or suspend the Plan in whole or in part at any time. No such change is currently being contemplated; however, in any such event, the participants' right to their vested benefits is nonforfeitable.

G. TAX STATUS

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

H. CONCENTRATION OF RISK

The Plan invests in various investment instruments. Investment securities in general are exposed to various risks, such as those involving interest rates, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

I. RELATED PARTY-IN-INTEREST TRANSACTIONS

The Plan holds shares of a fund managed by the Custodian, therefore, transactions with the Custodian qualify as party-in-interest transactions. Definiti LLC (the "TPA") is the third-party administrator of the Plan. During the year ended December 31, 2024, the Plan paid the Custodian and the TPA \$46,206 and \$4,414, respectively, in fees.
