## **INDEPENDENT AUDITORS' REPORT**

To the Administrative Committee of  
NTC Marketing, Inc. 401(k) Profit Sharing Plan and Trust:

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of NTC Marketing, Inc. 401(k) Profit Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of NTC Marketing, Inc. 401(k) Profit Sharing Plan and Trust's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### **Opinion**

**1. DESCRIPTION OF PLAN**

The following description of the NTC Marketing, Inc. 401(k) Profit Sharing Plan and Trust provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

This Plan covers all employees included in the controlled group with NTC Marketing, Inc. The adopting employers that are participating with NTC Marketing, Inc. as members of the controlled group under this single plan include Summit Services Unlimited, Inc. and Specialized Merchandising Services, Inc. (collectively, the "Company").

**General**

The Plan is a defined contribution plan covering all employees of the Company who are age twenty-one or older and have completed one year of service consisting of at least 1,000 service hours. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan administrator oversees the governance of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance, and reports to the plan sponsors.

**Contributions**

Each year participants may contribute up to 92% of compensation as defined in the Plan, subject to the defined contribution limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. As of July 2023, the Company updated their matching contribution and offers a matching contribution of 50% of participant's elective deferrals up to 6% of a participant's compensation. Previously, the Company offered a matching contribution of 25% of the participant's elective deferrals, up to 4% of a participant's compensation. The matching Company contribution is invested as directed by the participant. The Company also has the option to make a profit sharing contribution for employees that are employed as of the last day of the year. The Company did not make a profit sharing contribution during the year ended December 31, 2024.

**Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's matching contributions, (b) any discretionary profit sharing contribution made by the Company, (c) plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant contributions, participant earnings, or account balances, as defined. The benefit to

which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in any Company matching or discretionary profit sharing portion of their account is based on years of continuous service. A participant is 100% vested after six years of credited service.

### **Notes Receivable from Participants**

Participants are able to borrow a minimum of \$1,000 up to the lesser of, (1) a maximum of 50% of their vested account balance reduced by any outstanding loan balance or, (2) \$50,000, reduced by the highest outstanding loan balance during the one-year period ending on the day before the loan was made. Participants are allowed to have two outstanding loans at a time. The loans are secured by the balance in the participant's account and bear interest at prime rates plus 1%. Principal and interest are amortized over the term of the loan, and payments are made through payroll deductions. The maximum term allowed is five years.

### **Payment of Benefits**

On termination of service due to death, disability or retirement, or due to other reasons, a participant, or the participants' legal representative, may elect to receive either a lump-sum amount equal to the value of the participant's interest in his or her account or partial withdrawals from the account, subject to account balance requirements. In addition, the plan allows for in-service distributions if a participant is still working and reaches the age of 59 ½, and the plan allows for hardship distributions.

### **Forfeited Accounts**

Forfeited non-vested accounts totaled \$524 and \$133 as of the years ended December 31, 2024 and 2023, respectively.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value.

### **Notes Receivable From Participants**

Notes receivable from participants are reported at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based on the terms of the plan document.

### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of mutual funds and the collective investment trust are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Payments of Benefits**

Benefits are recorded when paid.

### **Administrative Expenses**

Administrative expenses of maintaining the Plan may be paid out of the Plan or paid directly by the Company. Additionally, the Plan may impose certain charges against individual participant accounts. Such fees or expenses will generally be allocated to the accounts of participants either proportionally based on the value of account balances or as an equal dollar amount based on the number of participants in the plan. Participant distribution fees or loan origination/maintenance fees are allocated and charged directly to the specific participant/borrower's account. Fees of \$35,007 were allocated to participants for administrative during the year ended December 31, 2024.

### 3. FAIR VALUE MEASUREMENTS

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs were used only when Level 1 or Level 2 inputs were not available.

Collective Investment Trust: The Plan participates in the Reliance Trust Company Stable Value Fund Collective Investment Trust. The stable value fund invests in investment contracts issued by insurance companies and other institutions. The fund is valued at the net asset value of shares held by the Plan at year-end, based on market quotations published via investor online reporting available through John Hancock Retirement Plan Services.

Mutual Funds: Valued at the net asset value of shares held by the Plan at year-end, based on observable market quotations.

The Plan's investments are managed by John Hancock Trust Company, the Directed Trustee and Custodian for the Plan. The Plan invests in a collective investment trust with Reliance Trust Company. John Hancock Retirement Plan Services provides administrative services to the Plan. Robert F. Fahey Jr and Associates provide investment advisory services to the Plan. CCG Investments Inc. provide investment advisory services to the plan. ERISA Fiduciary Services provides trustee services to the Plan. These transactions qualify as party-in-interest transactions. Participant loans are also party-in-interest transactions.

The Company pays certain expenses to maintain the Plan for which they are not reimbursed by the Plan.

## **6. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan at any time, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

## **7. TAX STATUS**

The prototype plan utilized for the NTC Marketing, Inc. 401(k) Profit Sharing Plan and Trust is a prototype profit sharing plan provided by John Hancock Retirement Plan Services ("Hancock"). Hancock obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan as then designed was acceptable under the applicable provisions of the Internal Revenue Codes for use by employers for the benefit of their employees. The Plan administrators believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified.

Accounting principles generally accepted in the United States of America require the plan administrators to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

## **8. RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated for possible disclosure and recognition in the financial statements through October 9, 2025, which is the date the financial statements were available to be issued.

Subsequent to year-end, two of the Plan's participating employers, Summit Services Unlimited, Inc. and Specialized Merchandising Services, Inc., had employee layoffs that included plan participants.

No additional subsequent events were noted by the Company.
