### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed the audits of the accompanying financial statements of Anchor Healthcare, PLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. - Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgement, there are conditions or events, considered in the aggregate, that raise substantial doubt about Anchor Healthcare, PLC 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.





Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Such information is the responsibility of management and was derived from and related directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1 - Description of Plan**

The following description of the Anchor Healthcare, PLC 401(k) Plan, (the “Plan”), provides only general information. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan’s provisions.

**General**

The Plan, effective January 1, 1997, is a defined contribution plan covering all full time employees of Anchor Healthcare, PLC (the “Company”), who are 21 and have completed one year of service. The Plan was amended effective July 15, 2022 to conform the Plan to new tax laws. The plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended effective July 1, 2023 to require only six months of service for plan entry.

**Contributions**

The Plan is a defined contribution plan established under the provisions of Internal Revenue Code Section 401(k) covering substantially all eligible employees electing to participate. The Plan provides for pre-tax participant contributions, as defined in the Plan. The Plan also provides for automatic enrollment at 3% once a participant becomes eligible, with automatic increases of 1% annually, up to a maximum of 6%. Effective July 1, 2023, automatic enrollment is at 6% with automatic increases of 1% annually, up to a maximum of 10%. The Plan also allows for Roth contributions. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch up contributions. The Company makes a 3% safe harbor contribution to all participants and has the option to make a discretionary profit-sharing contribution, which is determined annually by the Company’s Board of Directors. The Company also had the option to make a discretionary match until the July 15, 2022 plan amendment. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Contributions are subject to certain limitations. During the year ending December 31, 2024 and 2023, the Company made a discretionary profit sharing contribution of \$361,937 and \$414,641, respectively.

**Participant accounts**

Each participant’s account is credited with the participant’s contributions and allocations of (a) the Company’s contribution and, (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Investment options**

Upon enrollment in the Plan, participants may direct the administrator of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

**Vesting**

Participants are immediately vested in their contributions plus actual earnings thereon. Participants who were employed as of December 31, 2014 are also immediately vested in the Company’s safe harbor matching and discretionary contributions plus actual earnings thereon. Effective January 1, 2015, safe harbor non-elective contributions are 100% vested and employer discretionary profit sharing contributions for new plan participants are vested on a 6 year grading schedule as follows:

**Payment of benefits**

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability, hardship withdrawal or retirement, as defined in the Plan. A participant is entitled to receive a lump sum payment or partial lump sum (minimum \$1,000) in an amount equal to the vested value of their account. In-service at age 59 ½ and hardship payments are allowed if certain conditions are met.

**Forfeitures**

Forfeited balances of terminated participants' non-vested accounts are used to pay plan expenses or reduce future Company contributions. Forfeitures of terminated non-vested account balances at December 31, 2024 and 2023 totaled \$19,943 and \$21,506. During the years ended December 31, 2024 and 2023, forfeitures of participant accounts of \$8,558 and \$10,923 were received by the Plan. For the years ended December 31, 2024 and 2023, forfeitures of \$12,695 and \$10,994 were used to reduce employer matching contributions.

**Note 2 - Summary of Accounting Policies**

**Basis of accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

**Investment valuation and income recognition**

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end. If quoted prices are unavailable, estimated fair values are based on comparable investment of other issues with similar credit ratings. The common/collective trusts and pooled separate accounts are based on the fair value of the underlying investments as based on information reported by the investment advisor using the audited financial statements of the assets held at year-end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Administrative expenses**

Audit fees are paid by the Company. Contract administration fees and third-party service fees are paid by the Plan from the participant accounts.

**Payment of benefits**

Benefits are recorded when paid.

**Use of estimates**

The preparation of financial statements in conformity with generally accepted accounting principles of the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

**Credit risk**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Note 3 – Fair Value Measurements**

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The valuation methodologies remained the same in 2024 and 2023.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Registered investment accounts* - Valued at actively traded market values of the shares held by the Plan at year-end.

*Pooled separate accounts* – Net asset value as reported by the investment manager based on the value of the underlying assets.

*Common collective trust* - Net asset value as reported by the investment manager based on the value of the underlying assets.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 4 – Party-In-Interest Transactions**

Certain Plan investments are assets managed by Principal Life Insurance Company, the custodian of the Plan. Therefore, these transactions qualify as part-in-interest transactions. Principal Life Insurance Company was paid \$59,483 and \$60,464 for administrative services during the years ended December 31, 2024 and 2023. Plan administrator fees are paid by the Company.

The Plan sponsors, trustees, and key management are also participants in the Plan. Their account balances totaled approximately 18% and 18% of the net assets available for benefits as of December 31, 2024 and 2023.

**Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 6 – Tax Status**

The Internal Revenue Service has determined by letter dated June 30, 2020, that the adopted prototype plan is qualified under the appropriate sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan’s tax counsel believe that the Plan is designed and is currently being operated in compliance with applicable requirements of the IRC and therefore believe that the plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

**Note 7 – Financial Information Certified by the Custodian of the Plan**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company and Principal Life Insurance Company, (the trustees of the Plan) as of December 31, 2024 and 2023 and for the years then ended.
