(1) Description of Plan

The following description of the MVHS, Inc. 401(k) Plan (formerly Faxton-St. Luke's Healthcare 401(k) Plan) (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

(a) General

The Plan is a defined contribution plan covering eligible employees of MVHS, Inc. (formerly Faxton-St. Luke's Healthcare) (Hospital), St. Luke's Home Residential Health Care Facility, Inc. d/b/a MVHS Rehabilitation and Nursing Center (Home), Mohawk Valley Home Care, LLC (MVHC) and Senior Network Health, LLC (SNH) who have elected to participate. The Hospital, Home, MVHC and SNH (collectively known as the Employer) are affiliated entities. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Mohawk Valley Health System (MVHS), a not-for-profit corporation was the sole member of St. Elizabeth Medical Center (SEMC) and MVHS, Inc. Effective October 29, 2023, all SEMC employees became employees of MVHS, Inc., and were immediately eligible to participate in the Plan as a result of MVHS finalizing the construction of its new hospital campus in downtown Utica and consolidating operations and services from SEMC and MVHS, Inc. On that date, Faxton-St. Luke's Healthcare was renamed MVHS, Inc. and the Faxton-St. Luke's Healthcare 401(k) Plan was renamed the MVHS, Inc. 401(k) Plan.

Effective January 1, 2024, contributions ceased for certain employees no longer eligible to participate in the MVHS, Inc. 403(b) Retirement Plan due to a change in their collective bargaining unit. These employees, under their new collective bargaining unit, are eligible to participate in the MVHS, Inc. 401(k) plan.

Effective January 19, 2024, the St. Elizabeth Medical Center 401(k) Plan was merged into the Plan and account balances totalling approximately \$100,000,000 were transferred to the Plan.

(1) Description of Plan, Continued

(b) Contributions

Each year, participants may contribute a percentage of their pre-tax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). For each participant who has completed at least one year of service and is age 21 or older, the Employer matches 50%-100% of participant contributions up to 1%-4% of eligible compensation based on years of service. To earn a year of service a participant must complete 1,000 hours of service during a Plan year. The Employer will contribute a fixed contribution amounting to 3% of eligible compensation (4% for employees hired prior to December 1, 2001), if the participant completed 500 hours of service during the Plan year. Effective January 1, 2024, the Employer will make a safe harbor contribution equal to 3% of eligible compensation (and an additional 1% for employees hired prior to December 1, 2001). Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

(c) Participant Accounts

Each participant's account is credited with the participant's contributions and related Employer contributions, as well as allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

(d) Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service and is as follows:

(e) Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which are commensurate with local prevailing rates as determined by the Plan administrator at the time the loan is originated. Principal and interest are paid ratably through payroll deductions or directly from participants.

(f) Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, a life annuity, a joint life and last survivor annuity or equal installments over a period of not more than the participant's or their beneficiary's assumed life expectancy.

(g) Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$67,000 and \$174,000, respectively. These accounts may be used to pay Plan administrative expenses or reduce Employer contributions that are allocated to each participant's account based upon the relation of the participant's compensation to total compensation for the Plan year. During 2024 and 2023, Employer contributions were reduced by approximately \$683,000 and \$389,000, respectively, from forfeited nonvested accounts.

(2) Summary of Significant Accounting Policies

(a) Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

(b) Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

(c) Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive group fixed annuity contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Pension Committee determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company. See note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

(d) Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

(e) Payment of Benefits

Benefits are recorded when paid.

(f) Administrative Expenses

The Plan's expenses are paid by the Plan as provided by the Plan agreement. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Fees incurred by the Plan for the investment management services are included in administrative expenses. In addition, certain investment related expenses are included in net appreciation in fair value of investments presented in the accompanying statements of changes in net assets available for benefits.

(g) Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025 the date the financial statements were available to be issued.

(3) Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

(4) Group Fixed Annuity Contracts with Insurance Company

The Plan maintains fully benefit-responsive group fixed annuity contracts with Lincoln Life and Annuity Company of New York (Lincoln). Lincoln maintains the contributions in general accounts. The accounts are credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Lincoln is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

These contracts meet the fully benefit-responsive investment contract criteria and, therefore, are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contracts, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligation. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The group fixed annuity contracts do not mature and permit the contract holder and insurance company to terminate the agreements with proper notice, as defined in the contracts.

(5) Certified Information

Certain investment information disclosed in the accompanying financial statements and ERISA - required supplementary schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants, and transfer of assets to the Plan for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Lincoln Financial Group Trust Company, Inc., the custodian of the Plan.

(6) Party-in-Interest Transactions

Certain Plan investments are group fixed annuity contracts issued by Lincoln Life and Annuity Company of New York. Lincoln Financial Group Trust Company, Inc. is the custodian as defined by the Plan and is a related party of Lincoln Life and Annuity Company of New York and, therefore, these transactions qualify as party-in-interest transactions. The Plan made direct payments to the third-party administrator of \$609,257 and \$415,733 for the years ended December 31, 2024 and 2023, respectively.

In addition, the Plan issues notes receivable to participants, which are secured by the balances in the participants' accounts.

(7) Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

(8) Tax Status

The IRS has determined and informed the prototype sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

(9) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
