Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of Gerken Rent-All 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Basis for Opinion

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of the Gerken Rent-All 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan’s provisions.

General – Gerken Rent-All, Inc. (the “Company”) established the Plan to provide employees with a systematic means of saving and investing for the future. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Transamerica Life Insurance Company Inc. (“Transamerica”) is the custodian and recordkeeper of the Plan. ERISA Services, Inc. serves as the Third-Party Administrator. The Plan was established on January 1, 2020. Officers of the Company serves as the trustees of the Plan.

Eligibility – The Plan is open to employees of the Company, as defined by the Plan Document. Employees are eligible to participate in the Plan immediately upon their date of hire and may enter the Plan on the first day the month coinciding with or next following the date the requirements were met.

Union employees, nonresident aliens, and leased employees are not eligible for the Plan.

Contributions – Participants may elect to contribute any amount of their annual compensation subject to certain Internal Revenue Code (“IRC” or “Code”) provisions.

The Company has elected to make safe-harbor matching contributions equal to 100% of the first 3% of gross compensation contributed, and 50% of the next 2% of gross compensation contributed. The Company may also make discretionary profit-sharing contributions. In order to receive the discretionary profit-sharing contribution, an employee must have worked 1,000 hours during the year, and be employed on the last day of the Plan year (unless the employee died, became disabled, or reached normal retirement age). Profit sharing contributions are allocated to eligible participants in accordance with applicable provisions of the Plan. The Company did not make a discretionary profit-sharing contribution for 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and Company contributions (if any), and Plan earnings or losses, based on the investments of each participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Investment Options – Participants of the Plan direct their contributions to various pooled separate accounts, and a guaranteed investment account.

Vesting – Participants’ contributions and the Company’s safe-harbor contributions are fully vested at all times. Discretionary employer profit sharing contributions vest in 20% increments, with 20% vested after year two, and increasing in 20% increments each year thereafter until 100% vested after six years of service. In the event of permanent disability, death, reaching normal retirement age, or termination of the Plan, the Company contributions will become fully vested.

Forfeitures – Forfeitures occur upon termination of employment by a participant who is not fully vested in the Plan. Forfeitures are used to reduce future employer contributions or to pay administrative expenses. At December 31, 2024 and 2023, forfeited, non-vested accounts totaled \$10,627 and \$4,793, respectively. During 2024, forfeitures in the amount of \$56 were used to pay administrative expenses.

Payment of Benefits – Upon termination of employment, the participant, or in the case of death, the participant's beneficiary, may elect to receive the participant's account balance in a single lump sum in accordance with the Plan document, or maintain the assets in the Plan until a later date, subject to certain IRC regulations. In the event that a participant terminates employment, and their account balance is less than \$7,000, the balance will automatically be distributed to the participant, in a single lump sum, or rolled over into an IRA.

In-Service Withdrawals – Certain participants may make withdrawals prior to termination of employment. Hardship withdrawals are available to Plan participants, as defined by the Plan Document and permitted by the IRC. Hardship withdrawals are limited to the participant's fully vested accounts.

Participants who have attained the age of 59 ½ are allowed to receive a distribution of all or any portion of the vested account balance in a single lump sum payment.

Notes Receivable from Participants – Participants may borrow from their fund accounts a minimum of \$1,000, up to the lesser of \$50,000 or 50% of their vested account balance. The maximum loan term is 5 years, except if the loan is to acquire the participant's principal residence, which may have a longer repayment term. Interest rates are established by adding one percentage point to the Prime rate. The balance in the participant's account secures the loan. A participant may have no more than two loans outstanding at any one time.

Administrative Expenses – The Plan's expenses may be paid by the Plan or the Company, at the option of the Company. During the year ended December 31, 2024, the Plan paid \$46,198 in expenses.

Other Income – A revenue sharing agreement is in place whereby investment fees earned are shared with the recordkeeper based upon a percentage of assets under management. These amounts are used for the benefit of the Plan to pay administrative expenses. During 2024, \$14,837 was received by the Plan under this revenue sharing agreement, and \$14,770 was used to pay a portion of the investment management fees. As of December 31, 2024 and 2023, \$3,808 and \$3,727 was unallocated, respectively.

Termination of the Plan – Although the Company has not expressed any intent to do so, it has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the Plan and under ERISA. In the event that the Plan should be terminated, all participants become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions – Employer and employee contributions are reported in the year services are rendered to the Company by the Plan participants.

Investment Valuation and Income Recognition – The Plan’s investments are stated at fair value, except for the Guaranteed Investment Account (“GIA”) which is at contract value (see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

Management fees and operating expenses charged to the Plan for investments are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Payment of Benefits – Benefit payments are reported in the year paid.

Notes Receivable from Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for doubtful accounts is considered necessary.

Date of Management’s Review – Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued, and there were no material events requiring recognition or disclosure.

3. FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs consist of unadjusted quoted prices for identical assets in active markets that the plan has the ability to access.

Level 2 – Inputs consist of 1) quoted prices for similar assets in active markets, 2) quoted prices for identical or similar assets in inactive markets, 3) inputs other than quoted prices that are observable, and 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset has a specified (contractual) term, the level 2 input must be observable for substantially the full term.

Level 3 – Inputs consist of unobservable inputs where there is little or no market activity, and the reporting entity makes estimates and assumptions related to the pricing of the asset including assumptions regarding risk.

The assets fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Pooled Separate Accounts – The investment advisors calculate a unit value (similar to a net asset value “NAV”) of a separate account. It is the sum of the market value of underlying investments as determined by quoted market prices, less operating expenses accrued but not deducted, if any.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. The Plan’s investments are reported at fair value as follows at December 31, 2024 and 2023:

(a) Certain investments are measured at fair value based on NAV per share practical expedient at December 31, 2024 and 2023. These investments have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statement of net assets available for benefits. These investments are valued daily, may be redeemed daily without restrictions, and with no notice requirements. Additionally, there are no unfunded commitments.

4. RISKS AND UNCERTAINTIES

The Plan invests in investment securities, which hold securities including U.S. Government securities, corporate debt instruments, and corporate stocks. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

5. INFORMATION CERTIFIED BY THE CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Transamerica Life Insurance Company Inc., the custodian of the Plan, have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023, and for the year ended December 31, 2024:

- Investments, at fair value
- Investments, at contract value
- Notes receivable from participants and related interest income
- Net appreciation in fair value of investments
- Other income
- Schedule of Assets (Held at End of Year)

The Plan's independent public accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

6. TAX STATUS

The Company adopted a Volume Submitter Profit-Sharing Plan with CODA which received a favorable opinion letter from the IRS on June 1, 2021, which stated that the Plan and related trust are designed in accordance with applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. However, the Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and that, therefore, the Plan qualifies under Section 401(a) and the related trust is tax-exempt as of December 31, 2024. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Generally accepted accounting principles requires Plan management to evaluate tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. GUARANTEED INVESTMENT ACCOUNT

Transamerica offers a stable value fund that the participant may elect to transfer all or part of his or her funds. The stable value fund is considered a fully benefit-responsive investment contract. Contract value is the relevant measurement attribute for that portion of the net assets available for benefits. Contract value, as reported by Transamerica, is the beginning balance plus any deposits and credited interest, less any withdrawals, charges, or expenses, a measurement that approximates fair value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of Transamerica or otherwise. The contract value of the investment contract at December 31, 2024 was \$48,464. The stable value fund invests in Guaranteed Investment Contracts ("GICs"). These investments seek to protect against any loss of principal while providing returns in excess of money market funds and one-year U.S. Treasury bills. The investment has a portfolio investment rate design in which all deposits are credited with the same interest rate, on a daily basis, and with no set maturity. The effective credited interest rate is set monthly and effective on the first day of the month. Contract charges may reduce this return. The Transamerica Stable Value fund is not a separate account investment choice – it is an investment in Transamerica's general account.

Certain events limit the ability of the Plan to transact at contract value with Transamerica. Such events include the following: (1) the Plan is changed so as to significantly affect Transamerica's obligations to the contract, (2) the contract can no longer be treated as a pension plan contract, (3) the Plan is terminated, (4) failure to comply with the contract's requirements, (5) failure to provide information, (6) the sum of the contract account values at any time equals \$20,000 or less, or (7) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator is not aware of any events which would limit the Plan's ability to transact at contract value with participants that are probable.

8. EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Plan investments include pooled separate accounts and a guaranteed investment account managed by Transamerica. Transamerica is the custodian of the Plan, and therefore, these transactions qualify as party-in-interest.

The Plan pays certain fees to the service providers of the Plan to administer the Plan. These transactions qualify as party-in-interest. Notes receivable from participants are party-in-interest transactions.

9. PROHIBITED TRANSACTIONS

During the year ended December 31, 2024, employee deferrals of \$32,138 and loan repayments of \$1,640 were withheld from five payrolls and not remitted to the trust on a timely basis (as defined by the Department of Labor "DOL") by the Plan Sponsor. The Plan Sponsor subsequently remitted all such deferrals to the trust, will file and pay the appropriate excise tax, and contribute lost earnings to the affected participants. These transactions were prohibited according to the provisions of the DOL.
