The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the U. S. Cotton LLC Retirement Savings Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section -

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of U. S. Cotton, LLC Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about U. S. Cotton, LLC Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

Note A – DESCRIPTION OF THE PLAN

The following description of the U. S. Cotton, LLC Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan with a cash or deferred feature under Internal Revenue Code Section 401(k). Employees of the Company and certain affiliates may elect to participate in the Plan. The Plan excludes employees covered by a collective bargaining agreement and non-resident aliens with no U. S. earned income sources. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make elective contributions of eligible compensation subject to Internal Revenue Code limitations on total contributions. The Plan has elected to be a safe harbor plan and the employer makes an enhanced matching contribution to the account of each eligible participant in an amount equal to the sum of 100% of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus, if applicable, 50% of the participant's elective deferrals that exceed 3% but do not exceed 6% of the participant's compensation. Participants direct the investment of their contribution as well as any employer contribution into investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and the employer's matching contribution and an allocation of Plan earnings and charged with an allocation of administrative expenses. Allocations of earnings and expenses are based on participant account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions, employer safe harbor matching contributions, and earnings thereon.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at prime (Wall Street Journal) plus 1% at time of issue. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service, participants electing to receive their vested benefits receive a lump-sum amount equal to the value of their account. In certain circumstances withdrawals may be made without termination of employment upon demonstration of financial hardship or after a participant reaches age 59 ½.

Note B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

Accounting Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ materially from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal and interest balances. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value except for the fully benefit-responsive investment contract which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Contract value represents the amount the participant would receive if they initiated permitted transactions under the terms of the Plan. The Plan's valuation policies utilize information provided by Empower Trust Company, LLC and Empower Annuity Insurance Company of America. See Note C for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses incurred by the Plan are paid directly by the plan sponsor and are excluded from these financial statements.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, which is the date the financial statements were available to be issued.

Note C – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities.
- Level 2 – Inputs other than quoted prices included in Level 1 that are either directly or indirectly observable. These include quoted prices for similar assets or liabilities other than quoted in Level 1, quoted prices for identical or similar assets in markets that are not active, or other inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs that are unobservable inputs for the asset or liability.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are Level 1 investments valued at fair value, which is determined by the quoted market price on the last business day of the plan year.

Fixed annuities held in a fully benefit-responsive insurance contract are valued at contract value.

Note D – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower). The issuer maintains Plan contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is established by the issuer and reviewed quarterly for resetting. The issuer may not terminate the agreement prior to the scheduled maturity date.

The contract meets the fully benefit-responsive investment contract criteria and is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract plus earnings, less withdrawals, and administrative expenses. The Plan's ability to receive amounts due under the contract is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. The plan sponsor believes that it is unlikely that any events will occur that would limit the Plan or participants' ability to transact at contract value with the issuer.

Note E – INFORMATION CERTIFIED BY EMPOWER TRUST COMPANY, LLC (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC and Empower Annuity Insurance Company (the custodians of the Plan).

Note F – TAX STATUS

The Plan uses a prototype plan document sponsored by Empower Trust Company, LLC. Empower Trust Company, LLC received a plan determination letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan itself has not received a determination letter from the IRS. Although the plan has been amended since adoption, the Plan administrator believes the Plan is currently designed and operating in compliance with applicable requirements of the Internal Revenue Code. No provision for income tax has been included in these financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by federal and state taxing authorities. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

Note G – RELATED PARTY TRANSACTIONS

Investment and administrative expenses represent exempt party-in-interest payments made by the plan for recordkeeping, investment advisory, regulatory compliance, and audit services. Additionally, notes receivable from participants are considered exempt party-in-interest transactions.

Certain administrative functions are performed by employees and officers of the plan sponsor. No such individuals receive compensation from the Plan. Certain administrative expenses are paid directly by the plan sponsor.

Note H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the plan to discontinue its contributions at any time and to terminate the plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

Note I – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Note J – PROHIBITED TRANSACTIONS

During the years ended December 31, 2024 and 2023, the Employer failed to make remittances of participant contributions and loan payments totaling \$263,129 and 169,657, respectively, in the time period prescribed by the Department of Labor's Rules and Regulations. The delay in remitting the contributions was due to administrative errors which were identified during 2024. Delinquent contributions of \$347,197 were corrected during 2024 with the remaining balance of \$85,589 to be corrected by the employer in 2025.
