Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of BH Management 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. Plan Description

The following description of the BH Management 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

Plan Amendment

Effective January 1, 2024, the Plan was amended and restated, which changed certain provisions of the Plan, including eligibility requirements, contribution options and certain other Plan provisions.

General and Eligibility

The Plan is a defined contribution plan covering all employees of BH Management Services, LLC, BH Equities, Inc., B Hom Student Living LLC and Trev CSG Danbury LP (collectively, the Companies) who meet the eligibility requirements. Employees of the Companies who are age 18 years or older and have completed 30 days of service are eligible to participate in the Plan. Effective January 1, 2024, temporary or seasonal employees who were age 18 years or older and have completed 1,000 hours of service during an entry service period or employment becomes full-time are eligible. Employees may begin participating in the Plan on the first day of the month following the date on which eligibility requirements have been met. Employer safe harbor match contributions have the same eligibility requirements as the employee deferral. The Board of Trustees is responsible for oversight of the Plan. The Investment Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Trustees. The Plan is subject to the current provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and the applicable current Internal Revenue Code (the Code) provisions.

Contributions and Investment Options

Each year, participants may contribute a stated percentage of their compensation, subject to an annual limit, as defined by the Plan and applicable statutory limitations. Effective January 1, 2023, the Plan was amended to change certain provisions of the Plan, including adding automatic enrollment and deferral increase provisions. Both newly eligible participants or current employees that had not completed an elective deferral agreement were automatically enrolled at 3% of eligible compensation, unless they elect a different deferral percentage, and will increase annually 1% up to 6% of eligible compensation. The Plan allows for additional catch-up contributions for participants that reach age 50 during the year. The Companies contribute a safe harbor match contribution of 100% of the participant's contributions up to 1% of eligible compensation, plus 50% of the participant's contributions which are over 1% but are not over 6% of eligible compensation, for a maximum match of 3.5% of eligible compensation, subject to Internal Revenue Service (IRS) limitations. The Companies also have the option of making an additional discretionary contribution to the Plan. No additional discretionary contributions were made during the year ended December 31, 2024. Rollover contributions to participants from another qualified plan are permitted as defined by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Companies' contributions to that participant, and allocations of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Participants are vested in the Companies' contributions plus actual earnings thereon based on continuous years of service. A participant is 100% vested in their employer safe harbor match contributions and additional discretionary contributions after two years of credited service. Participants also become fully vested upon reaching normal retirement age, as defined by the Plan.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 reduced by the borrower's highest loan balance during the 12-month period ending before the loan is made or the greater of 50% of their vested account balance as of the last valuation date. Only five participant loans within a 12-month period are allowed at a time. Principal and interest is paid ratably through payroll deductions over a period not exceeding five years or 25 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account. Notes receivable outstanding at December 31, 2024, had maturity dates ranging from 2025 to 2051 and bear interest between 4.25% and 9.50%. Notes receivable outstanding at December 31, 2023, bore interest at rates ranging from 4.25% to 9.50%.

Payment of Benefits

Benefits under the Plan begin when a participant reaches normal retirement age (or age 59.5 at the election of the participant), retires, dies or ceases to be an employee. Benefits are recorded when paid. Benefit payments are paid in a single lump sum payment or in installments, if the vested account balance is over \$5,000. The Plan allows for hardship withdrawals to participants who meet an immediate and severe financial need. Benefits paid to a participant who reaches age 59.5 or hardship withdrawals are limited to a participant's vested account balance.

Forfeitures

Forfeitures are used for Plan expenses or to reduce employer contributions. During the year ended December 31, 2024, forfeitures including earnings and fees thereon totaled approximately \$467,000 and were used to reduce Plan expenses and employer contributions. The balance of forfeited non-vested accounts totaled approximately \$7,000 and \$34,000 as of December 31, 2024 and 2023, respectively.

2. Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting in accordance with generally accepted accounting principles in the United States of America (U.S. GAAP).

Contributions

Contributions from Plan participants, safe harbor match contributions and additional discretionary contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

Accounting Estimates and Assumptions

The preparation of financial statements requires Plan management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein and disclosures of contingent assets and liabilities. Actual results may differ from those estimates.

Valuation of Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 7 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the plan document. No allowance for credit losses have been recorded as of December 31, 2024 and 2023.

Excess Contributions Payable

Participant contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction in contributions.

Benefit Payment

Benefit payments are recorded when paid.

3. Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Companies and are excluded from these financial statements. Administrative expenses include fees related to the administration of notes receivable that are charged directly to participant's account and certain recordkeeping fees paid by the Plan. Investment related expenses are included in net appreciation in fair value of investments.

4. Information Certified and Provided by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, the Trustee

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan's financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution:

The trustee also certified the completeness and accuracy of \$904,674 of interest and dividends and \$6,206,329 of net appreciation in fair value of investments and \$97,166 in interest income on notes receivable from participants. All amounts include activity on investments bought, sold and held during the year for the year ended December 31, 2024.

5. Related-Party Transactions

The Plan holds investments with Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company. Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company is the trustee as defined by the Plan and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan to the trustee totaled \$184,643 for the year ended December 31, 2024.

6. Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

7. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants. The Fair Value Measurement and Disclosures Topic of the Financial Accounting Standards Board Accounting Standards Codification (ASC) requires the use of valuation techniques that are consistent with the market approach, the income approach and/or the cost approach. Inputs to valuation techniques refer to the assumptions that market participants would use in pricing the asset or liability. Inputs may be observable, meaning those that reflect the assumptions market participants would use in pricing the asset or liability developed based on market data obtained from independent sources, or unobservable, meaning those that reflect the Plan's own assumptions about the assumptions market participants would use in pricing the asset or liability developed based on the best information available in the circumstances. In that regard, the Topic establishes a fair value hierarchy for valuation inputs that give the highest priority to quoted prices in active markets for identical assets or liabilities and the lowest priority to unobservable inputs. The fair value hierarchy is as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data.

Level 3: Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

A description of the valuation methodologies used for instruments measured at fair value, as well as the general classification of such instruments pursuant to the valuation hierarchy, is set forth below. The level to which an asset or liability is classified is based upon the lowest level of input that is significant to the fair value measurements. There have been no changes in valuation methodologies at December 31, 2024, compared to December 31, 2023.

Mutual Funds

Mutual funds are reported at fair value based on the quoted market price of the fund and are classified within Level 1 of the valuation hierarchy.

Common Collective Trust Fund

Common collective trust funds are composed of investment contracts that are valued at the net asset value of units of the common collective trust. The net asset value is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transaction (purchases and sales) may occur immediately. If the plan initiates full redemption of the collective trust, no notice to the issuer is required.

8. Plan Termination

Although it has not expressed any intent to do so, the Companies have the right under the Plan provisions to terminate the Plan subject to the provisions set forth in ERISA. In the event of a Plan termination, participants will become fully vested in their entire account balance.

9. Tax Status

The Plan has adopted a preapproved plan document that has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the preapproved plan document was in compliance with applicable requirements of the Code. The Plan has been amended since adopting the preapproved plan document; however, The Plan Administrator believes the Plan is designed, and is being operated, in compliance with the applicable requirements of the IRC.

The Plan follows the accounting guidance for uncertainty in income taxes and management has evaluated the Plan's tax positions and concluded that the Plan has maintained its tax exempt status and had taken no uncertain tax positions that require adjustments to the financial statements. Therefore, no provisions or liability for income taxes has been included in the financial statements.

10. Subsequent Events

The Plan Administrator has evaluated subsequent events for potential recognition and disclosure through October 7, 2025, which is the date the financial statements were available to be issued.
