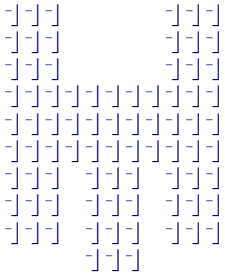

INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of
St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan
Boca Raton, Florida

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

1. **Description of Plan**

The following description of St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan (the "Plan"), formerly known as St. Andrews Country Club 401(k), is provided for general information purposes only. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

- a) *General* – The Plan is a defined contribution plan covering all employees of St. Andrews Country Club Property Owners Association, Inc. (the "Association"), except employees covered under a collective bargaining agreement and non-resident aliens, who have attained 21 years of age and provided at least 60 days or 1,000 hours of service to the Association. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was formed on January 1, 2017, and restated in its entirety on January 1, 2022, as required by Internal Revenue Service's (IRS) restatement cycle. The Plan was most recently amended effective January 1, 2024, with any changes to significant provisions incorporated in the descriptions below. Also, see Note 5 for further details of the Plan amendment.
- b) *Plan Administration* – The Plan is administered by Definiti, LLC and The Fiduciary Studio, LLC, third-party administrators (TPAs). The Plan's trustees are members and/or employees of the Association. As of December 31, 2024 and 2023, the custodian and party which directs the custody and management of the Plan's assets is Transamerica Financial Life Insurance Company (Transamerica).
- c) *Contributions* – Each year participants may contribute up to 100% of pretax annual compensation, as defined in the Plan and as subject to limitations defined by the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified plans. As a result of the above amendment, effective January 1, 2024, the Association contributes a Safe Harbor matching contribution of 100% of the first 4% of base compensation that a participant contributes to the Plan.
- d) *Participant Accounts* – Each participant's account is credited with participant's contribution, the employer's matching contribution and Plan earnings.
- e) *Vesting* – Participants are immediately vested in their salary deferral contributions, rollovers, and Safe Harbor matching contributions, plus actual earnings thereon. Vesting in the Association's contributions that are not considered Safe Harbor matching contributions is based on years of credited service. A participant becomes 100% vested in such contributions after 6 years of credited service or immediately upon death or disability.
- f) *Administrative Expenses* – The Plan Sponsor has elected to pay the administrative costs associated with Plan operations and compliance. Individual participants pay for loan fees, investment fees, assets charges, and associated expenses.
- g) *Investment Options* – Upon enrollment in the Plan, a participant may direct employee contributions in any of the investment options offered in the Transamerica program and determined by the Plan Administrator. Participants may change their investment options via phone or internet access to Transamerica at any time.

1. **Description of Plan, continued**

- h) *Participant Notes Receivable* – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. No loan may be taken from Roth deferral contributions. Loan transactions are treated as a transfer to (from) the investment fund from (to) the Participant Loans fund. Loan terms range from 1-5 years. Loans made for the purchase of a primary residence may extend beyond 5 years. The loans are secured by the balance in the participant’s account and bear interest at a rate commensurate with local prevailing rates as determined by the loan administrator at the time the loan is taken (currently Prime Rate plus 2%). The interest rate on participant loans receivable as of December 31, 2024 and 2023 range from 5.25% to 10.50%. Principal and interest is paid ratably through bi-weekly payroll deductions. Participant loans are reported at their unpaid principal balances plus any accrued interest. The loan balances are secured by the participants’ investment accounts, therefore, no allowance for uncollectible loans was deemed necessary. For purposes of presentation on the schedule of assets held for investment purposes, the participant notes receivable are presented as part of the investments in the Form 5500, and are referred to as participant loans.
- i) *Payments of Benefits* – Upon retirement, disability, death, termination of employment, or attainment of age 65, a participant may elect to receive a lump-sum amount equal to the value of the participant’s vested interest in his or her account. In-service distributions are permitted for employees attaining age 59 ½. Hardship distributions are also permitted from all accounts that are fully vested.
- j) *Forfeited Accounts* – Forfeitures on non-vested accounts may be used to pay plan expenses or to reduce future employer contributions. During the year ended December 31, 2024, \$36,154 was forfeited by employees and \$28,167 was applied to administrative fees. There was \$39,555 and \$28,520 of forfeited non-vested accounts as of December 31, 2024 and 2023, respectively.

2. **Summary of Significant Accounting Policies**

The following are the significant accounting policies followed by the Plan:

- a) *Basis of Accounting* – The accompanying financial statements are prepared on the accrual basis of accounting.
- b) *Use of Estimates* – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- c) *Payment of Benefits* – Benefits are recorded when paid.

2. **Summary of Significant Accounting Policies, continued**

- d) *Valuation of Investments and Income Recognition* – Investments in registered investment companies (i.e., mutual funds) are valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end. Investment options that do not have readily available market quotations are valued according to quotations from the custodian. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date.
- e) *Plan Risk and Uncertainties* – The Plan and the Plan assets are sensitive to economic pressures prevalent in the investment market. The pressures primarily stem from interest rates, market and credit risk and their effect on bond rates, mortgage rates, the value of real estate, stock prices, and the overall stability of the market. Additionally, the financial position of the Plan Sponsor, St. Andrews Country Club Property Owners Association, Inc., may have a significant impact on the Plan. Specifically, these include the ability of the Plan Sponsor to continue to make contributions to the Plan and/or the stability of the Plan Sponsor's operations. Other external factors which may affect the Plan, and the Plan assets include legislation or regulations established by the Internal Revenue Service, ERISA, and/or Department of Labor (DOL).

3. **Fair Value Measurements**

Financial Accounting Standard Board Accounting Standards Codification (FASB ASC) 820-10, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy under FASB ASC 820-10 are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

3. Fair Value Measurements, continued

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following descriptions provide the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024:

- a) *Mutual funds* – Valued at quoted market price of a national security exchange on the last business day of the year, of units held by the Plan at year end.

5. Plan Amendment

Effective January 1, 2024, pursuant to an amendment to the Plan document, sponsorship of the Plan transferred from St. Andrews Country Club, Inc. (the "Former Plan Sponsor") to St. Andrews Country Club Property Owners Association, Inc. (the "Plan Sponsor"). In connection with this amendment, the Plan changed its name from St. Andrews Country Club, Inc. 401(k) Plan to St. Andrews Country Club Property Owners Association, Inc. 401(k) Plan. The Employer Identification Number (EIN) associated with the Plan changed from 59-2000688 to 59-2309237. The Plan continues to be identified as Plan No. 001.

In April 2024, the Plan received assets totaling \$360,810 related to employees of St. Andrews Country Club Property Owners Association, Inc. pursuant to a plan merger agreement. Prior to the merger, St. Andrews Country Club Property Owners Association, Inc.'s employees participated in a defined contribution plan administered by ADP Total Source Retirement Savings Plan. As part of the merger transaction, those participants became participants of the Plan, and their account balances were transferred to the Plan without disruption.

These changes did not impact participants' rights with respect to their account balances, investment elections, or contributions.

6. Plan Termination

Although the Association intends the Plan to be permanent and continuing, the Association has the right to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts and accrued benefits, to the extent funded or required to be funded, must be distributed to the participants.

7. Tax Status

The Plan is utilizing a Non-Standardized Pre-Approved Profit-Sharing Plan document (Profit-Sharing Plan) provided by its TPA, Definiti, LLC. The Profit-Sharing Plan reflects the implementation of the recent legislative changes in the regulations governing qualified tax-deferred arrangements via the IRS's Cycle 3 restatement. The restated Profit-Sharing Plan received an opinion letter from the Internal Revenue Service dated June 30, 2020. Although the Plan has been amended since receiving the opinion letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believes that the Plan is qualified and is tax-exempt. Accordingly, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Subsequent Events

The Plan's management has evaluated subsequent events through October 9, 2025, the date on which the financial statements were available to be issued, and determined no additional disclosures were required to be presented in these financial statements.
